Background.

The City typically creates sunset positions when authorizing positions based on anticipated grant funding or on the expectation of a time-limited body of work. The ordinance authorizing the creation of sunset positions typically establishes a sunset date, after which the position is inactivated by the Personnel Department. Each year, Council Central staff reviews the Citywide Position List to determine which sunset positions should be abrogated (e.g., deleted), designated, or extended, as necessary.
