**Budget Action description:**

This green sheet makes a citywide cut to the employer contribution rate for the Seattle City Employees' Retirement System (SCERS), lowering it from 11.27% of regular (non-overtime) payroll in the 2012 Proposed Budget to the updated rate of 11.01%. Both rates were increases from the 10.03% rate in the 2012 Endorsed Budget. The newest rate is based on an updated actuarial calculation following an October policy vote by the SCERS Board of Administration that changed the interest rate paid on new contributions after January 1, 2012. The green sheet reduces department appropriations directly citywide, reduces GSF support to the departments (where appropriate) to reflect the lower costs, and adjusts revenues accordingly.
