## **Budget Action description:**

This action cuts \$2 million in Cumulative Reserve Subfund (CRS) funding from the Zoo Parking Garage Development project in the Department of Parks and Recreation's (DPR's) proposed 2013 budget, pending further Council review of the proposed appropriation. The spending had been proposed to fund construction of a new 180-stall surface lot at the Woodland Park Zoo.
