### **Budget Action description:**

This Green Sheet would add \$168,000 GSF to the Department of Neighborhoods, Office for Education (OFE) BCL to expand enrollment in the Early Learning Academy (ELA). The ELA provides evidence-based professional development training to child care providers. Child care can be provided by licensed child care centers, licensed family home child care providers or by family, friends and neighbors. This \$168,000 increase would provide training to 60 family home child care providers. Family home child care providers are licensed to provide child care for twelve or fewer children in the living quarters where the licensee resides.

## Background.

Research by the University of Washington's Institute for Learning and Brain Sciences (I-LABS) establishes that a child's life-long foundation for learning begins well before kindergarten. This is confirmed by a recent <u>Stanford University study</u>, which shows that significant learning and language gaps can appear in children age 3 and younger.

The intent of the ELA is to increase child care providers' knowledge of childhood development, and strengthen their skills at developing and implementing intentional learning activities. OFE's ELA trains child care providers in the use of the extensively evaluated High Scope program. High Scope encourages purposeful play-based learning as a foundation for the literacy, math and social/emotional skills children need to be ready for kindergarten.

In related efforts, the City provides child care subsidies to assist qualifying families with the cost of child care. HSD maintains a list of child care providers where families may use their child care subsidy. In 2014 HSD intends to increase the number of qualifying providers from the current 131 to 260, with a specific target of increasing the number of qualifying family home child care providers in underserved emerging communities, such as the Somali community.

While the \$168,000 will not provide sufficient funding for all existing or new child care providers on HSD's qualifying provider list to participate in the ELA in 2014, this expansion will allow a greater portion of family home child care providers the opportunity to participate. This proposed expansion of the Early Learning Academy is consistent with Budget Resolution 31425 because the training is based on the extensively evaluated High Scope early learning models which are proven to produce positive education outcomes.
