<b>Background:</b>  Kevin Eggers has demonstrated a profound commitment to advocating for people with disabilities. Living with epilepsy, he knows that both the physical burden and social stigma contribute to the difficulties and nuances of living with such ailments.  An Eggers' Transportation co-founder, Kevin oversees a disability transportation company which donates much of its net proceeds to the Epilepsy Foundation. As an advocate for himself and others, he delivered speeches about eliminating the stigma associated with epilepsy through the Epilepsy Advocate Program. In addition to giving speeches, Kevin lobbied Congress and gave interviews about coping with epilepsy, all as the youngest member of the group.  While working toward his Philosophy and Political Science degrees at Seattle University, Kevin was elected as the school's Student Body President, and was appointed as a student representative to the University's Board of Trustees and Regents. Both the Commission for People with disAbilities and the Get Engaged program are pleased to welcome Kevin and his eye for opportunity, active engagement, and sincere dedication.
