After moving to Seattle from New York, Bridge served for two years on the board of Camp Ten Trees, an LGBTQ and ally youth camp. He also volunteers for the pro bono attorney program at The Northwest Immigrant Rights Project, focusing on immigrant visa petitions under the Violence Against Women Act and asylum cases. | | |
