
I am writing to express my keen interest in serving as a Seattle Human Rights Commissioner. You have a most impressive team of Commissioners, and the Commission's embrace of the U.S.'s international human rights obligations is remarkable. The work the Commission does is cutting edge among U.S. cities, promising great benefit to the people and City of Seattle, including a higher standard of living for all who live here. It also distinguishes Seattle as a standard-bearer among U.S. cities for what human rights implementation at the local level can look like. That is, it demonstrates that cities are in the position to ensure a more just environment where the most vulnerable of its citizens are protected, and where the color of one's skin or the birth origin of one's parents plays no role in the treatment of that individual, in the protection of that individual's personal liberties, or in his or her baseline living or working conditions.

I have extensive experience with human rights issues that qualifies me for a seat on the Commission. As you will see from my attached resume, most of my experience in human rights work has involved indigenous human rights, but I am more broadly interested in advancing human rights in the context of homelessness, employer discrimination, and justice for those accused of crimes. As a Commissioner, I would be able to draw on insights and expertise gained from my practice at the Indian Law Resource Center, one of the pre-eminent indigenous human rights organizations in the Western Hemisphere, as well as my training with the Columbia Human Rights Institute (focused on the International Covenant on Civil and Political Rights). My principal work at the Indian Law Resource Center centered on implementation of the U.N. Declaration on the Rights of Indigenous Peoples in the U.S., Mexico, Central America, and South America. I crafted broad-scale strategy towards that end and executed that strategy primarily through oral and written advocacy, and education of the Inter-American Commission on Human Rights, tribal leaders, federal officials, national legislators, scientists, and the general public. In my current position, I have continued my human rights work through pro bono engagement by the Navajo Nation Human Rights Commission (NNHRC). I assisted the NNHRC in advocating for the Obama administration's implementation of the recommendations

of the U.N. General Assembly's Working Group on the Universal Periodic Review, particularly as those recommendations related to indigenous human rights. In addition to my human rights-specific work, I have served as an advocate for tribes for the bulk of my career as an attorney, which experience I believe further reinforces my human rights-oriented outlook.

I appreciate your review of my letter of interest and resume, and I welcome the opportunity to speak with you regarding the Commission. Please let me know if there is anything else I can provide you with to assist in your consideration of me as a candidate for the Commission.
