Huong T. Vu

Huong has worked in the arts for 20 years a nonprofit manager, curator, and grantmaker. She has directly managed more than \$90M in philanthropic investments for foundation, corporate giving and regranting programs. These investments supported programming, innovation, capacity building, arts participation, arts education, capital campaigns, technology, research, artist support systems, economic development/community revitalization, professional development/training, and cultural space/placemaking.

Huong joined Boeing in 2009 and currently oversees its Pacific Northwest Region arts, culture, and civic grants portfolio. Prior to Boeing, Huong was the senior arts program officer at The Paul G. Allen Family Foundation, guest curator at contemporary performance center On the Boards, director of grants programs at the Association of Performing Arts Presenters, fellow at the National Endowment for the Arts, and an organizer of visual arts exhibitions. Huong is a graduate of the University of Washington where she studied Business Administration and Visual Arts. In 2007, she earned a program certificate from the Stanford University/Graduate School of Business/Program for Philanthropy Executives. She has served as a funding panelist for more than a dozen grantmakers in the United States.

Huong currently serves on a number of local and national boards including: Grantmakers in the Arts (2008-present), Seattle Arts Commission (2012-present), Seattle Parks Foundation (2012-present; co-chair of the Rainier Beach Urban Farm & Wetlands capital campaign); and the Association of Performing Arts Presenters (2014-present). In 2012, Huong served on the Arts & Culture advisory team at the White House Asian American Pacific Islander Initiative Forum. In 2013, WESTAF named her as one of the Top 50 Most Influential People in the Arts Nonprofit Sector (USA).
