

Recently, she worked for the Legal Department at the Consulate of Mexico in Seattle, Washington providing legal advice on Mexican law and consular assistance to Mexican nationals in Washington State. Susana also served as President of the Board of the Seattle Latino Film Festival and is vigorously involved in the Latino Community as an activist, coordinator, volunteer and interpreter with various local organizations such as One America, Legal Voice, Social Justice Fund, and El Centro de la Raza, among others.</p>

To Whom It May Concern:

The City of Seattle has been my home for the past five years. Since moving to Seattle, I have been working closely with the local community. Throughout my career, I have had the chance to interact, advocate and work directly with various nonprofits and community organizers, as well as local, state, and national governmental agencies and officials, both from Mexico and the United States.

During my time here I have closely observed the work and services provided by the City of Seattle. I have also been able to engage as a volunteer and supporter of various local grassroots organizations that work together with the City on events and programs that address social justice issues within Seattle. This has allowed me to become aware of immigrant's needs in this region. Being an immigrant myself, a professional woman, and an activist from Mexico City gives me a unique perspective on various approaches to serving immigrants in our community.

I am a lawyer from Mexico, where I worked in the Mexico City Human Rights Commission for four years. At the Commission, I worked directly with vulnerable groups of people, including women who had been victims of human rights violations. I provided direct legal assistance and advocacy during the investigations in my case load. There, I discovered my natural passion for social justice issues.

I came to Seattle in 2008 when the Mexican Consulate offered me a position in the agency's Legal Department. In that position, I provided consular assistance to Mexican nationals living in Washington State. This included providing legal advice and giving legal information on local resources to Mexican immigrants who had all sorts of legal issues, including family law cases, criminal law, labor claims and immigration matters. I also helped to organize a symposium on Women's Labor Rights, bringing together local professionals, government officials, and advocates to discuss legal issues that affect immigrant women in the workplace.

I recently left the Mexican Consulate and began working for a private immigration law firm located in downtown Seattle. Many of our clients are immigrants who seek legal advice. I assist as a Law Clerk, providing culturally sensitive legal support in their immigration cases and advice on Mexican Law issues. I enjoy my job greatly as I am able to understand their situations and provide aid using the skills I had learned in the past.

In addition to my professional experience, I have volunteered with numerous local community organizations, including OneAmerica, Washington New Americans, Legal Voice, the Latin@ Bar Association, and the Social Justice Fund. Recently, I also served as the president of the Board of Directors for the Seattle Latino Film Festival.

My experience and my background would offer a different insight to the work of the Seattle's Immigrant and Refugee Commission. I would greatly enjoy the opportunity to give back to the City that has welcomed me and is now my home. I would especially like this position to be a bridge between immigrants in our community and the elected officials and government agencies, to give voice to their needs that should be addressed. This is a chance to work on behalf of a group that I am a part of and whose needs I understand and share. I would take this position fully aware of the responsibilities that are entailed in providing public service and in representing the voice of immigrants.
