COUNCIL BILL 118290

AN ORDINANCE relating to the Seattle Office of Housing; repealing Section 3.14.750 of the Seattle Municipal Code.

WHEREAS, the Seattle Municipal Code, Chapter 3.14, establishes the Office of Housing, including its mission and purpose and the duties of its Director; and

WHEREAS, the Seattle Municipal Code, Section 3.14.750, requires the Office of Housing to submit an annual work program to the City Council for approval, which is generally not required for City departments and offices; and

WHEREAS, City Council establishes priorities for department activities through the City budget process and receives regular briefings of department work program activities at Committee meetings; and

WHEREAS, City Council directs implementation of Office of Housing programs through the Council-approved Consolidated Housing and Community Development Plan and Housing Levy Administrative and Financial Plan, and through provisions in the Seattle Municipal Code;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Section 3.14.750 of the Seattle Municipal Code, last amended by Ordinance 119273 and that currently reads as follows, is repealed:

~~3.14.750 Work program to be adopted by City Council.~~

~~The annual work program for the Office of Housing, showing anticipated tasks, likely work products, and approximate assignments of FTEs shall be set by the City Council. The Council's review of the work program shall be in two (2) steps:~~

1 ~~A. The Director of Housing shall submit a preliminary proposed work program for the~~

Legislation Title:

AN ORDINANCE relating to the Seattle Office of Housing; repealing Section 3.14.750 of the Seattle Municipal Code.

Summary of the Legislation: This legislation repeals the SMC provision requiring the Office of Housing to submit a proposed work plan to Council each year, which must be adopted by Council resolution.

Background:

The requirement for City Council adoption of OH's annual work plan dates from the formation of the Office in 1998. OH must submit a preliminary work plan each October, followed by a revised proposed work plan in January. Council adoption of annual work plans is not generally required of City departments or Executive offices and is no longer necessary for OH. OH's work is guided by the Council-adopted City Budget, Consolidated Housing and Community Development Plan, Housing Levy Administrative and Financial Plan, and provisions of the Seattle Municipal Code.
