Gentlemen:-

By the enclosures you will observe that the City of San
Francisco has called a convention to memorialize Congress in favor
of the re-enactment of the Geary Exclusion Law which expires by
limitation in May, 1902. As the Pacific States are exposed to
Chinese immigration, the gravity of the danger can be understood by
the fact that powerful influences are at work to interrupt the established national policy of Chinese Exclusion. If Chinese coolies
can freely come, it means the displacement of our white population.

I would respectfully suggest that your City-the leading one in your State-should take the initiative in memorializing Congress in some appropriate manner.

The plan we have adopted may appeal to you. Ten years ago such a convention was held in Sacramento City with excellent results. The business before us is to influence the members of Congress, through the pressure of public opinion, to save us from an inundation of coolies, which would inevitably follow the relaxation of the law.

A CALL TO ACTION

To the People of the State of California:

The Chinese exclusion act, after having been in existence for about ten years, will expire in May, 1902, and at the next session of Congress the question of its re-enactment shall have to be decided.

The Chinese Government, through its Ministers and Consuls, have already attempted to influence public opinion by appeals and petitions and other means known to diplomacy.

It is sufficient now to remind the American people that should the bars be let down an enormous immigration of Chinese coolies would inundate this country and overwhelm its free orking population.

The standard of American civilization, our schools, churches, employment and family life, our greatness in peace and power in war are at issue.

We invite you to meet in convention in San Francisco, Thursday, November 21st, to discuss this question and to take appropriate action as voicing the sentiment of California, the State most exposed to the impending danger, by memorializing Congress.

The proceedings shall be reported and circulated for the enlightenment of the people of the United States.

CALL FOR A STATE CONVENTION

The Board of Supervisors of the City and County of San Francisco did, on the 13th day of September, 1901, adopt the following resolutions, to-wit:

WHEREAS, The Chinese Exclusion Act, enacted in 1891, expires during the session of the next Congress; and

WHEREAS, It is absolutely necessary that the same should be re-enacted.

Resolved, That this Board inaugurate a movement toward the calling of a State Convention, to be held in the City and County of San Francisco not later than December 2nd of this year, for the purpose of memorializing the President of the United States and Congress for the re-enactment of the law known as the "Geary Exclusion Act;" and

Resolved, further, That said Convention shall consist of representatives of all County Boards of Super-visors, Boards of City Councils, Town Trustees, Boards of Trade, trades unions and other civic organizations.

Resolved, further, That a committee, consisting of his honor, the Mayor, and five Supervisors, to be appointed by the Mayor, be selected for the purpose of formulating a call and making such arrangements as are deemed necessary to hold said Convention.

The Mayor and the subscribed members of said Board of Supervisors were appointed as members of said committee, in pursuance with the terms of said resolution, and being authorized so to do, hereby issue

A Call for a Convention

to consider ways and means of securing an extension of the provisions of said Chinese exclusion act, and to memorialize Congress to act in the matter without unnecessary delay. Said convention will be held at

Metropolitan Hall, San Francisco, beginning on Thursday, November 21st, at 2 o'clock P. M.

Such Convention will consist of representatives chosen by all public bodies, civic societies and labor organizations in the State of California and public officials.
