WHEREAS, by Ordinance No. 59719, it is proposed that the City of Seattle condemn a portion of Woodland Park for the purpose of laying out and establishing a public highway through said park, and also to condemn certain other property and lay out and establish certain streets and highways; and,

WHEREAS, the establishing of such public highway through Woodland Park is unnecessary and will greatly hamper and destroy the utility of said part as a public playground and will also destroy the beauty thereof,

NOW, THEREFORE, believing that said Ordinance No. 59719 entitled:
