It has been suggested by Mr. Kirby Terrence of the Civilian Protection Division that I contact you in regard to the Auxiliary Fire Fighters assisting the City of Seattle in destroying old shacks which have been erected by transients in various parts of the town.

For your information, the City has had quite a problem on its hands, particularly in regard to persons building unauthorized shacks on vacant property in certain sections of the city. This created a serious health menace and fire hazard and for sometime now the city has been gradually getting rid of these places.

However, due to the outbreak of the war which placed an additional burden on our Fire Department, and the fact that we have had a long dry spell in this city, there are several shacks about town which have not been destroyed.

Members of the Public Safety Committee suggested that possibly the Auxiliary Fire Fighters would be interested in burning these places down for practice, and at the same time they would be doing a good job for the City of Seattle.

If it will be possible for the Auxiliary Firemen to burn these places for the city I would suggest that you get in touch with Mr. Allen Butler in the Health Department, who is charged with destruction of these illegal shacks, and Chief Fitzgerald of the Fire Department. Both of these parties have been contacted and are in apparent agreement with this method of disposing of these places.

Dear Sir:

Replying to your communication of October 27, will say that there are shacks in various parts of the city, which have not all been demolished. This work of demolition was discontinued last April, when the Chief of the Fire Department advised this department and your committee that he could no longer spare equipment for burning such shacks. At that time he also agreed that he would make an effort to have the auxiliary fire fighting crew engage in this work.

This department has burned or caused to be razed a total of six hundred thirty-three shacks. The Port Commission razed approximately four hundred twenty on the site, which was known as "Hooverville". The U.S. Navy disposed of approximately ninety shacks in the Interbay area and the Coast Guard--we are informed--destroyed or caused to be moved approximately four hundred along the Duwamish water way.

Each week we find a number of small shelters being erected around our garbage fills. As soon as we find them they are destroyed. There are a number of shacks which we have vacated, especially those in "Louisville", which should be burned. Now that the dangerous summer fire season is over, perhaps the fire department can again help us in this work.



On or about April 25, 1941, the City Council had under consideration File No. 169237, concerning shack elimination. At that time a committee was appointed consisting of a representative from the Health, Fire, Building, and Police Departments, to take what action might be necessary in removing these shacks.


Since that time we have burned or caused to be removed about six hundred of these sub-standard dwelling places. At the present time we have about seventy-five vacant shacks which should be destroyed by burning.

Chief Fitzgerald of the Fire Department has informed Mr. Butler, who has acted as chairman of the committee appointed that the Fire Department cannot assist in any more burning operations, because there is no fire fighting equipment that can be spared for such purposes.

The shacks that are now vacant will soon be reoccupied, if they are not destroyed, and these seventy-five with others which will soon be vacant, are a potential health and fire hazard and a disgrace to the city.

We request that your honorable body consider this question and instruct the shack committee as to what action they should now take.
