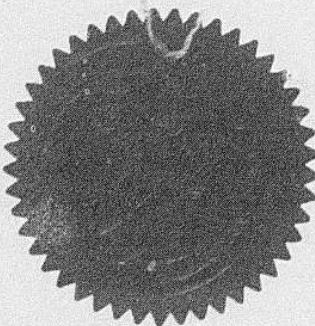

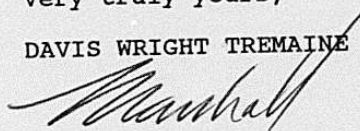
I am enclosing the original Certificate of Registration No. 1,560,198 for the service mark BUMBERSHOOT, showing the City of Seattle as registrant.

Dear Louise:

I am pleased to report that the Trademark Office has finally issued a registration for "Bumbershoot." A copy of the certificate is enclosed. As you know, the ® symbol that indicates registration should now be used with the name.

As you will probably also remember from the "One Reel" registration, two filings are needed to keep this registration in effect for the maximum period of time. The first, an affidavit of continued use, must be filed between the fifth and sixth anniversaries of the registration in order to continue the registration in effect for the rest of the first 20-year term. The second, a renewal for a second 20-year term, must be filed within six months before the 20th anniversary. I have placed these dates on our tickler system, but the City will probably want to note them in its records as well.
