I have reviewed your proposed petition related to ending the war in Iraq - proposed Initiative No. 95. The petition, as presented, does not conform to general standards set forth for initiative petitions. Initiatives are to be presented in ordinance format, and your proposed initiative, as presented, does not meet that requirement. In addition, there is an error in the warning box, as the ordinance cited should be 94289; and the margins at the top of each side of the petition page must be at least one inch.

The initiative process is defined in Article IV Section 1 of the City Charter, Seattle Municipal Code Section 2.08, and Washington State Code (RCW) 29.27.050. If you would like copies of these reference materials, please let me know.

This office has established the following ballot title for Initiative 95. The measure was filed with the Clerk's office on Wednesday, November 14, 2007:

Initiative Measure No. 95 concerns the Iraq War.

If enacted, this measure would state that: the Iraq War is undemocratic, and violates international law and our nation's deepest values; U.S. troops must be brought home immediately; Congress shall not authorize new funding for the war; and the people of Seattle declare the Iraq War over. It would also require that a copy of the measure be sent to the 2008 U.S. president-elect, all U.S. senators and representatives, the King County Council, and mayors of major U.S. cities.

Ordinance 942891 provides as follows:

Section 1. It is unlawful for any person:

1. To sign or decline to sign any petition for a City initiative, referendum, or Charter amendment, in exchange for any consideration or gratuity or promise thereof; or
2. To give or offer any consideration or gratuity to anyone to induce him or her to sign or not to sign a petition for a City initiative, referendum, or Charter amendment; or
3. To interfere with or attempt to interfere with the right of any voter to sign or not to sign a petition for a City initiative, referendum, or Charter amendment by threat, intimidation or any other corrupt means or practice; or
4. To sign a petition for a City initiative, referendum, or Charter amendment with any other than his or her true name, or to knowingly sign more than one (1) petition for the same initiative, referendum or Charter amendment measure, or to sign any such petition knowing that he or she is not a registered voter of The City of Seattle." The provisions of this ordinance shall be printed as a warning on every petition for a City initiative, referendum, or Charter amendment.

Section 2. Any person violating any of the provisions of this ordinance shall upon conviction thereof be punishable by a fine of not more than Five Hundred Dollars (\$500) or by imprisonment in the City Jail for a period not to exceed six (6) months, or by both such fine and imprisonment.
