The following is the 2022 Annual Property Report of all fee-owned real property under City ownership, as required by Resolution 31837 (Oct 2018). The Annual Property Report supports strategic management of the City's real estate holdings.

Each January, FAS' Real Estate Services Division initiates the annual review process for all City departments with jurisdiction over real property to ensure that all acquisitions, transfers, and dispositions are accurately represented and logged in a central database. Departments validate and provide information about each property. Each property is classified based on level of utilization – from fully utilized municipal use to excess property available for re-use as affordable housing or transfer to another department for another use.

Highlights of the March 2022 Annual Real Property Report

The 2022 report lists a total of 1,089 property management areas (PMAs) where the City has property ownership interests. That represents an increase of 12 PMAs since March 2021. A PMA can vary in size from 56 square feet (SF) to over 3 million SF and may include one or multiple tax parcels.

Twenty-three real estate transactions were reported by all City departments this past year, and nearly half of those were property acquisitions by Office of Housing from Sound Transit.

Seattle Center

- Owns 59 acres in 20 PMAs
- No fee interest transactions
- Skatepark opened in Fall 2021; property transferred to SC from SDOT in 2019
- Oak View Group finished redevelopment based on 40-year ground lease
- Climate Pledge Arena opened in October 2021

DON

- Owns 1.5 acres in eight PMAs (all are P-Patches/Community Gardens)
- Eight leases for P-Patches renewed with GROW (previously P-Patch Trust); a new legal entity

FAS

- Owns 188 acres in 200 PMAs

- Acquired properties for North Rainier Landbank and for Duwamish Waterway Park
- 1125 Harvard Ave E life estate extinguished; Parks now owns outright

- Owns 20,857 acres in 172 PMAs
- Acquired a previously leased property in Boundary Dam Area

SDOT

- Owns 108 acres in 66 PMAs
- Acquired 7 properties for Right of Way (ROW) and capital projects

SPL

- Owns 15 acres in 25 PMAs (including Central Library, 23 Branch Libraries and a storage facility)
- Sold former storage facility on Fourth Ave South
- Acquired Library Maintenance and Operations Center on Corson Ave S.

SPU

- Owns 103,871 acres in 143 PMAs

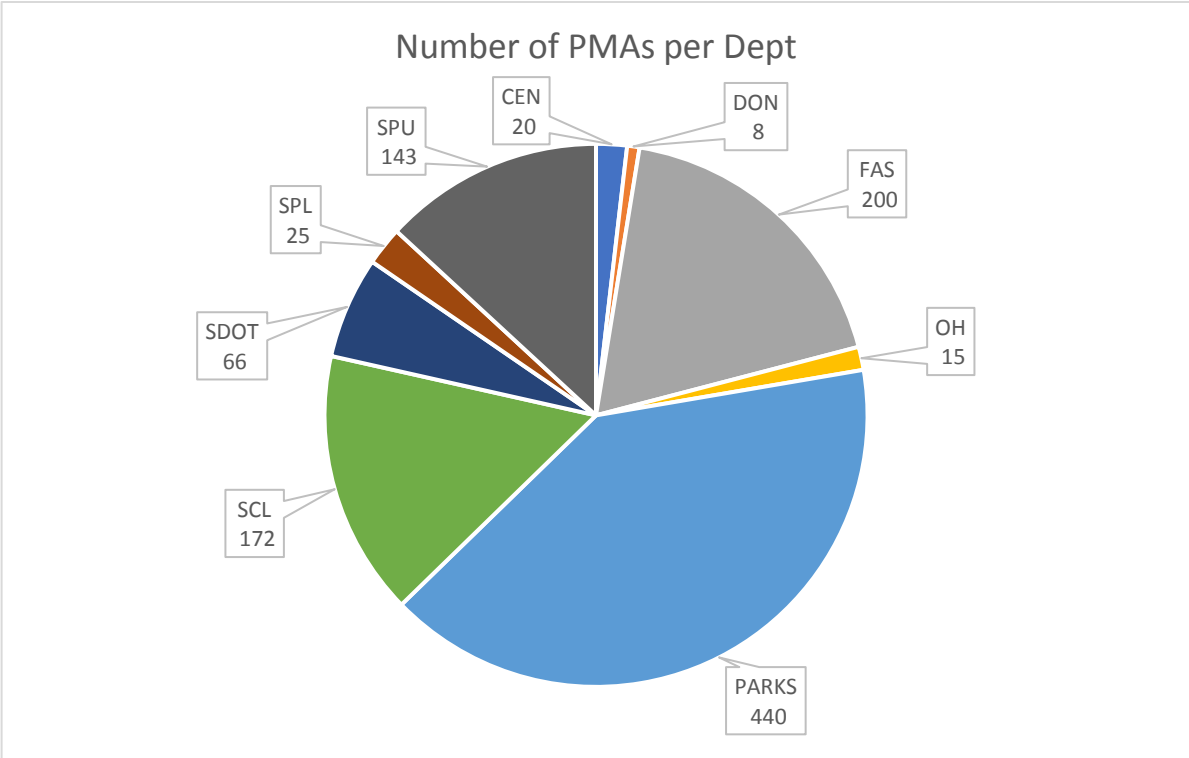
Per Council Resolution 31837, properties newly designated as Excess are reviewed by FAS for prioritization by Office of Housing for affordable housing development. Not all properties designated as Excess are suitable for redevelopment. Some have steep slopes or other site characteristics that make them difficult building sites,

yet they might have value to the City for other purposes, such as drainage sites or vegetative buffers. Excess properties for one department might have a use by another department, and if both departments agree, a property may be transferred through a Transfer of Jurisdiction Ordinance (TJO). When no other municipal use exists, Excess properties may be sold to the public, following a surplus process that requires City Council approval.

Currently, the number of Excess PMAs citywide is 115, and 74 of those are under 5,000 SF.

Fully Utilized Municipal Use Property	Municipal Use Property that is actively being used for municipal purposes to the fullest capacity possible under any required restrictions on its Municipal Use.
Underutilized Property	Municipal Use property that could support additional and/or more intensive uses without interfering with the primary use of the property.
Interim Use	The use of property for a non-municipal use(s) on a short-term basis during the period of time prior to its being used for its proposed future Municipal Use.
Unused Property	Property owned by the City that is not currently in Municipal Use and that is not being rented, leased, or otherwise used under an agreement with the City.
Excess Property	Real Property that the Jurisdictional Department has formally determined it no longer needs for the Department's current or future use.
Surplus Property	Excess Property formally designated by the City Council as not needed to carry out any recognized goal or policy of the City.
