of The City of Seattle:

Gentlemen: ---- In behalf of the Alaska=Yukon=Pacific Exposition. its committee on Buildings & Grounds respectfully represents: That in the construction of the buildings and grounds of said exposition, it will be necessary to lay down about 21,000 linear feet of cast iron pipe and to establish some sixty-two hydrants, and to erect some seven or eight stand pipes, for the purpose of supplying water to the grounds of said exposition for fire and sprinkling purposes. So far as possible, these pipes will be so located that they may be retained as a permanent fixture in the State University grounds, but, at the present time, it is an absolute impossibility for any one to foresee just what portion of said pipe lines it will be necessary to remove at the close of the exposition, and just what portion of the same, it may be desirable to leave. For this reason, your committee asks the reasonable co-operation of your Honorable Body in this matter. Our request is: That you obtain and loan to the exposition, the bill of material hereinafter set forth; the managers of the exposition to take said material and to place the same in the ground; at the close of the exposition, that which is to remain as a permanent thing in the University Grounds, to be paid for at its cost value; that which is to be removed, to be removed by the exposition management and delivered in good order to the City of Seattle. Gentlemen:-

I beg leave to report on petition File No. 34436, to

wit:

After taking up with the Committee of the A. Y. P. Exposition the supplying of pipe, hydrants, valves, crosses, T's, etc., by the City, for use on the exposition grounds, would report that the exposition people do not want to buy this pipe outright, but wish to arrange for having it loaned to them by the City.

To use cast iron pipe it would cost to furnish the same \$23,801.70 less the value of the hydrants and some 3000 feet of 8" pipe we have on hand, amounting to \$4000.00. In addition to the above \$23,801.70 there should be added not less than 10 % for loss of material due to breakage and other causes in handling and transportation.

If wooden pipe were used instead of cast iron it would cost \$15,668.00. This, however, I would not recommend, for the reason that it would be of no service to the City after being used on the exposition grounds unless it could be used immediately in some other locality.

In case it is decided that the City shall furnish this material I would recommend that the exposition authorities be re-
