My dear Sir:

Regarding ordinances Nos. 20285 and 20882, recommended for passage by your Honorable Committee, allowing the Chief of Police \$2000.00 per month for the purpose of engaging outside detectives for duty in the city during the progress of the Alaska-Yukon-Pacific Exposition, from June 1st, 1909 to October 15th, 1909. I desired to have the detectives kept on duty fifteen days longer than originally provided for, and upon speaking to various members of the Finance Committee was informed there would be no objection to my so doing provided I did not exceed the original allowance. I did so and I have still an unexpended balance of \$1332.00, which I hold awaiting instructions from your committee as to what disposition I shall make of it.

In my humble opinion the action of your committee in granting such allowance has been productive of great good in keeping the city proper free from crooks during the duration of the Fair;
