

BE IT REMEMBERED that the city council met in the council chamber in the city hall in the City of Seattle on Friday, July 3, 1914, at the hour of ~~eight~~ ^{seven} o'clock p. m., as required by law, to canvass the returns of the special municipal election held in the City of Seattle on Tuesday, the 30th day of June, 1914, and on said canvass finds as follows:

That the proposition of the ratification and adoption of the charter prepared and submitted by the freeholders elected on the 3rd day of March, 1914, did not receive the necessary majority of votes cast on said proposition, and is declared NOT ADOPTED.

That the proposition of the ratification and adoption of an alternate article submitted by the freeholders elected on the 3rd day of March, 1914, relating to the granting of street railway franchises, did not receive the necessary majority of the votes cast on said proposition, and is declared NOT ADOPTED.

That the proposition of the issuance and sale of bonds in the sum of \$479,500 for the purpose of providing money for the construction of a bridge to cross Salmon Bay Waterway at Fifteenth Avenue Northwest, received the necessary ^{3/5} majority of the votes cast on said proposition, and is declared CARRIED.

That the proposition of the issuance and sale of bonds in the sum of \$350,000 for the purpose of providing money for the construction of a bridge across the Lake Washington Canal at Fremont Avenue, received the necessary ^{Three fifths} majority of the votes cast on said proposition, and is declared CARRIED.


That the proposition of the issuance and sale of bonds in the sum of \$318,500 for the purpose of providing money for the construction of a bridge across the Lake Washington Canal at Sixth Avenue Northeast, did not receive the necessary ^{Three fifths} majority of the votes cast on said proposition, and is declared NOT CARRIED.

That the proposition of the issuance and sale of bonds in the sum of \$180,000 for the purpose of providing money for the construction of a bridge across the Lake Washington Canal at Montlake Boulevard, did not

receive the necessary ^{Three fifths} majority of the votes cast on said proposition, and is declared NOT CARRIED.

That the proposition of the issuance and sale of bonds in the sum of \$435,000 for the purpose of providing money for the construction of a bridge across the West Waterway at West Spokane Street, did not receive the necessary ^{Three fifths} majority of the votes cast on said proposition, and is declared NOT CARRIED.


