Increased funding and program potential by strategically seeking new funding streams to diversify base and expand programming opportunities. KING COUNTY Out Of School Youth Employment And Training Programs

Program Manager 4 April 1998 to Nov 2006. Manage a \$3+ million annual program and a staff exceeding 30 FTEs. These programs blend funding from the US Department of Labor (WIA & Youth Opportunity), King County human services and justice systems, HUD, with state and local educational resources. Involved programs include YouthBuild USA, Habitat for Humanity, Ryther, YWCA, YMOA, CAMP, AmeriCorps, South Seattle Community College, the Highline, Seattle, and Renton school districts, and the Work Force Development Council. These combine to form a one-stop occupational training and basic education facility for young people with auxiliary services in mental health, substance abuse, and general life skills (e.g. drivers education).

WASHINGTON STATE Department of Social and Health Services

Learning Disabilities Director, November 1994 to September 1998. Developed a statewide pilot program (13 sites) to examine the prevalence and consequences of learning disabilities within the AFDC/TANF population. Once the situation was delineated, a screening and service delivery system was deployed to 12 sites. Prepared contracts with community providers to serve the special needs of this population. Designed and executed a project evaluation. Findings from this body of work have been utilized nationally and in the design of services for several states.

KING COUNTY Department of Public Health

Planner: May 1994 to January 1995. Designed a fast-track public health project to improve adolescent access to public health care capacity and eliminate identified barriers to care working with the community's health care, mental health, and substance abuse treatment systems.
