This supplement to the Seattle Municipal Code contains all of the general ordinances of the City passed by the City Council and approved by the Mayor during the period from November 20, 1979 through December 31, 1980. (Numbers 108636 through 109600). "General ordinances" means those laws having some continuing effect upon the citizens of the City. For example, license laws, traffic laws and zoning laws are contained in these pages.

Certain city ordinances passed during the period covered by this Code Supplement are not reprinted here. They include special ordinances having no continuing effect; laws adopted by reference; and laws passed after this book was compiled. All ordinances, whether or not codified here, are available for your examination at the City Clerk's office.

Special Ordinances Special ordinances are not printed here since they are effective for only a limited time, and have no ongoing effect. Examples of special ordinances include ordinances appropriating money to improve streets, or authorizing payment of claims against the City. Such ordinances are of little or no use to most citizens. They are not codified here in order to minimize the bulk cost of printing this book.

Ordinances Adopted by Reference Some times the City needs to enact whole books as a part of City law. Rather than reprint the whole book in ordinance form, the City adopts the work by reference. The City passes an ordinance stating, for example, "The 1981 Uniform Building Code is hereby adopted." Upon adopting a book by reference, the City places three copies of the adopted matter on file in the City Clerk's office for the citizens' examination and reference. Works that the City has adopted by reference during the period covered by this code supplement are named in this code, even though not set forth fully in these pages.

Recent Ordinances New ordinances are passed by the City Council every week. Some have been passed too recently to be included in this Code. An index of such new ordinances, listed by subject matter, is located in the City Clerk's office. Some of these newest ordinances may amend ordinances contained in this book. To determine whether an ordinance printed in this book has been amended, it is necessary to check the index of ordinance amendments in the City Clerk's office.
