11.10.020 Citation.

The ordinance codified in this subtitle constitutes the "Traffic Code" of the City and may be cited as such. Wherever a reference is made herein to "this Code" it shall be construed to mean "this subtitle." (Ord. 108200 § 2(11.10.020), 1979.)

11.10.040 Purpose and policy.

This subtitle is enacted as an exercise of the police power of the City to protect and preserve the public peace, health, safety and welfare, and its provisions shall be liberally construed for the accomplishment of these purposes. It is expressly the purpose of this subtitle to provide for and promote the health, safety and welfare of the general public, and not to create or otherwise establish or designate any particular class or group of persons who will or should be especially protected or benefited by the terms of this subtitle. It is the specific intent of this subtitle to place the obligation of complying with its requirements upon the owner or operator of the vehicles or upon the pedestrian within its scope, and no provision of nor term used in this subtitle is intended to impose any duty whatsoever upon the City or any of its officers or employees, for whom the implementation or enforcement of this subtitle shall be discretionary and not mandatory. Nothing contained in this subtitle is intended to be nor shall be construed to create or form the basis for any liability on the part of the City, or its officers, employees or agents, for any injury or damage resulting from the failure of the owner or operator of a vehicle or a pedestrian to comply with the provisions of this subtitle, or by reason or in consequence of any act or omission in connection with the implementation or enforcement of this subtitle on the part of the City by its officers, employees or agents.

11.10.080 Number, gender and tense.

Whenever consistent with the context of this subtitle, words in the present, past or future tenses shall be construed to be interchangeable with each other, words in the singular number shall be construed to include the plural, words in the plural shall be construed to include the singular, and words in any gender shall apply to the feminine, masculine and neuter genders.

11.10.100 Effect of headings and references.

11.10.120 Existing permits to remain in force.

Except as otherwise provided in this subtitle, all permits lawfully issued under the provisions of any ordinance repealed by the ordinance codified in this subtitle shall remain in force and effect until expiration according to the terms thereof, unless sooner surrendered or revoked; subject, however, to all other provisions of this subtitle.

11.10.130 Prosecution under expired or repealed ordinance.

No offense committed and no penalty or forfeiture incurred previous to the time when any ordinance expires or is repealed, whether such repeal be express or implied, shall be affected by such expiration or repeal, unless a contrary intention is expressly declared in the expiring or repealing ordinance, and no prosecution for any offense or for the recovery of any penalty or forfeiture pending at the time any ordinance expires or is repealed, whether such repeal be express or implied, shall be affected by such expiration or repeal, but the same shall proceed in all respects as if such ordinance had not expired or been repealed, unless a contrary intention is expressly declared in the expiring or repealing ordinance. Whenever any ordinance defining an offense or making conduct unlawful is amended or repealed, whether such amendment or repeal be express or implied, any offense committed, conduct engaged in or penalty or forfeiture incurred while the ordinance was in force shall be punished or enforced as if the ordinance were in force, notwithstanding such amendment or repeal, unless a contrary intention is expressly declared in the amendatory or repealing ordinance, and every such amendatory or repealing ordinance shall be so construed as to save all proceedings under the amended or repealed ordinance pending at the time of the amendatory or repealing ordinance, unless a contrary intention is expressly declared therein.

11.10.140 Vehicle owner to act in person--Agents.

Every act or statement required to be made by the owner or operator of any vehicle shall be made or done by the owner or operator in person, unless such owner is a company or corporation or incapable of acting in person, and if the same is made or done by the agent, the necessity thereof shall be stated and shown. (Ord. 108200 § 2(11.10.140), 1979.)

11.10.160 False representation prohibited.

No person shall knowingly make a false statement or representation in any application, statement or report required by this subtitle to be made. (Ord. 108200 § 2(11.10.160), 1979.)

11.10.180 Existing regulations to remain in force.

11.12.060 Application to government vehicle.

The provisions of this subtitle shall apply to the operator of any vehicle owned by or used in the service of any government, including the United States government or any agency created by the United States, or of any foreign nation, or of this or any state, or of any political subdivision of this or any other state. 11.12.080 Exemption of authorized emergency vehicles.

- The driver of an authorized emergency vehicle, when responding to an emergency call or when in the pursuit of an actual or suspected violator of the law or when responding to but not upon returning from a fire alarm, may exercise the privileges set forth in this section, but subject to the conditions stated in this chapter.
 - B. The driver of an authorized emergency vehicle may:
 - 1. Park or stand, irrespective of the provisions of this subtitle;
 - 2. Proceed past a red or stop signal or stop sign, but only after slowing down as may be necessary for safe operation;
 - 3. Exceed the maximum speed limits so long as he does not endanger life or property; the Office of the City Cler

Provided, that ambulances shall not exceed the posted speed limit by more than five (5) miles per hour and shall not proceed through stop signs or red traffic signal lights without first making a full stop and permitting traffic to clear the intersection; and provided further, that Fire Department vehicles, including aid cars and other vehicles, shall not be subject to the above restrictions on the operation of ambulances.

- The exemptions granted in this section to an authorized emergency vehicle shall apply only when such vehicle is making use of visual signals meeting the requirements of RCW 46.37.190, except that:
- An authorized emergency vehicle operated as a police vehicle need not be equipped with or display a red light visible from in front of the vehicle;
- Authorized emergency vehicles shall use audible signals when necessary to warn others of the emergency nature of the situation but in no case shall they be required to use audible signals while parked or standing.
- D. The foregoing provisions shall not relieve the driver of an authorized emergency vehicle from the duty to drive with due regard for the safety of all persons, nor shall such provisions protect the driver from the consequences of his reckless disregard for the safety of others. (RCW 46.61.035) (Ord. 108200 § 2(11.12.080), 1979.)

11.12.100 Authorized work upon street.

The provisions of this subtitle relating to the operation of vehicles upon the streets or alleys of this City shall not apply to any persons, vehicles or other equipment while actually engaged in authorized work upon the surface of a street or alley insofar as suspension of the provisions of this subtitle are reasonably necessary for the carrying on of such work. Reasonable precautions must be taken to apprise and protect the users of such street or alley, in conformance with the guidelines set forth in the City's Traffic Control Manual for In-street Work which is adopted by reference, and three (3) copies of which are filed with the City Clerk. Such provisions of this subtitle shall apply to such persons, vehicles and other equipment when traveling to and from such works. The contract or permit for such authorized work shall set forth the extent of such suspension, and over what portions of the street or alley the suspensions shall apply. (RCW 46.61.030) (Ord. 108200 § 2(11.12.100), 1979.)

11.12.120 Traffic Control Manual for In-street Work.

No person shall work on a street or alley area without providing flaggers, signs, barricades, and/or other traffic-control devices as established by the guidelines set forth in the City's Traffic Control Manual for In-street Work, which is adopted by reference, and three (3) copies of which are filed with the City Clerk, if such person is required to meet the guidelines of the Traffic Control Manual for In-street Work by a permit, contract, regulation or ordinance. (See Street Use Ordinance 90047.)¹

ng and amending Words and phrases, wherever used in this subtitle shall have the meaning ascribed to them in this chapter except where otherwise defined, and unless where used the context thereof shall clearly indicate to the contrary. (RCW 46.04.010)

11.14.015 Abandoned vehicle. and to confirm accuracy Abandoned vehicle" means any vehicle left upon the private property of another without the consent of the owner of such property for a period of twenty-four (24) hours or longer, except that a vehicle shall not be considered abandoned if its owner or operator is unable to remove it from the place where it is located and so notifies law enforcement officials and requests assistance. 11.14.020 Adult school crossing supervisor.

"Adult school crossing supervisor" means an adult who is either hired by the Chief of Police or appointed or hired by the executive head of a university, college, public or private school within the City, for the purpose of guiding and assisting school children crossing streets or alleys. An adult school crossing supervisor shall wear a uniform or other appropriate insignia, as approved by the Chief of Police. The adult school crossing guard shall have the authority to stop and control pedestrian and vehicular traffic while engaged in the performance of duty or while wearing or displaying appropriate insignia. (Ord. 108200 § 2(11.14.035), 1979.)

11.14.023 Alcohol concentration.

"Alcohol concentration" means (i) grams of alcohol per two hundred ten (210) liters of a person's breath or (ii) grams of alcohol per one hundred (100) milliliters of a person's blood. (RCW 46.04.015). (Ord. 117734 § 1, 1995: Ord. 117155 § 1, 1994.)

11.14.025 Alley.

"Alley" means a highway not designed for general travel and primarily used as a means of access to the rear of residences and business establishments. (RCW 46.04.020) (Ord. 108200 § 2(11.14.040), 1979.)

11.14.030 Alley entrance.

"Alley entrance" means that portion of the street which provides access to an alley through a curb cut or a depression in the constructed curb or, when there is no constructed curb, that area in front of such alley as is well defined or as is designated by authorized signs or markings. "Automobile hulk" is synonymous with "wrecked, dismantled, or inoperative vehicle or automobile hulk" and means the remnant or remains of a motor vehicle which is inoperative and cannot be made mechanically operative without the addition of vital parts or mechanisms and the application of a substantial amount of labor to effect repairs. (RCW 46.52.102) (Ord. 108200 § 2(11.14.070), 1979.)

11.14.050 Axle.

"Axle" means a structure or structures in the same or approximately the same transverse plane with a vehicle supported by wheels and on which or with which such wheels revolve. (RCW 46.04.060) (Ord. 108200 § 2(11.14.080), 1979.)

11.14.055 Bicycle.

"Bicycle" means every device with two (2) or more wheels, of which not more than one (1) wheel shall be less than sixteen (16) inches in diameter, having a steering device and saddle or seat or seats, and propelled solely by human power.

(Ord. 108200 § 2(11.14.090), 1979.)

11.14.060 Bicycle lane.

"Bicycle lane" means a portion of the roadway which has been designated by traffic-control devices for preferential or exclusive use by bicycles. (Ord. 108200 § 2(11.14.100), 1979.)

11.14.065 Boundary line.

"Boundary line" means the line between the private property edge and the highway. ed for historic (Ord. 108200 § 2(11.14.120), 1979.)

11.14.070 Bus zone.

"Bus zone" means a portion of the roadway along the curb which is reserved for loading and unloading of either transit coaches of the Metro Transit System, or school buses when authorized and designated by:

- A sign with the words "bus," "bus zone" or "bus stop" and a parking control message; or



11.14.115 Commercial vehicle.

For purposes of this Code, the term "commercial vehicle" means (1) a "motor truck" or "truck" except a passenger car or (2) a station wagon or van that has been permanently modified to carry no more than three (3) seated passengers. Such vehicles shall be properly licensed as a truck and shall have the name of the business to which the vehicle is registered permanently displayed on both the left and right sides in letters no less than two inches (2") in height.



11.14.155 Curb ramp return.

"EPAMD" means an electric personal assistive mobility device, which is a self-balancing device with two wheels not in tandem, designed to transport only one person by an electric propulsion system with an average power of seven hundred fifty watts (one horsepower) having a maximum speed on a paved level surface, when powered solely by such a propulsion system while ridden by an operator weighing one hundred seventy pounds, of less than twenty miles per hour. 11.14.185 Excess weight.

11.14.320 Median barrier.

"Median barrier" means a physical barrier, a guard rail, or a solid yellow or cross-hatched pavement marking at least eighteen (18) inches in width, which divides any street into two (2) or more roadways. (RCW 46.61.150)

11.14.325 Metal tire.



11.14.375 Multiple lane street.

11.16.040 Police authorization.

Officers of the Police Department and such officers as are assigned by the Chief of Police are authorized to direct all traffic by voice, hand or signal in conformance with the provisions of this subtitle: Provided, that in the event of a fire or other emergency or to expedite traffic or to safeguard pedestrians, officers of the Police Department may direct traffic as conditions may require, notwithstanding the provisions of this subtitle. 

Upon ordering the closure, the Director shall cause the area to be posted with signs or barricades stating the hours of closure;
 - C. To designate any streets for one (1) way traffic and the required direction of such traffic;
- To close or authorize the closure during hours of darkness of any shoreline street end, as defined at SMC 15.02.046, for entry, travel, or use by the general public, based on a determination that such a closure is



The Director of Transportation may establish a restricted parking zone whenever seventy-five (75) percent or more of the capacity of the streets available for parking in such designated area is generally occupied during regular business hours or any consecutive eight (8) hour period during evenings or during any consecutive eight (8) hour period on both Saturdays and Sundays; at least twenty-five (25) percent of the vehicles parked on the street in the area during such hours are not owned by residents of the designated area; a petition signed by, or a survey indicating that, a majority of the residents in the designated area approves the restricted parking zone; and the public interest would be served. In cases where the criteria listed above are not all met, the Director of Transportation is authorized to establish a restricted parking zone when, in his or her judgment, the parking problem will be ameliorated by a restricted parking zone and the public interest would be served.
- В. The Director of Transportation's decision to establish or not to establish a restricted parking zone may be subject to review or reconsideration within fifteen (15) days of publication in the Seattle Daily Journal of Commerce and/or local newspaper. Requests for review or reconsideration may be initiated by residents, business owners, or employees in the proposed RPZ. On review or reconsideration, the Director, or his or her designee, shall conduct a public hearing before the Director makes a final decision. Grounds for review or reconsideration may include the validity of the study; the stringency of the parking restrictions; the boundaries of the restricted parking zone; and violations of Policies and Procedures Concerning the Implementation of Residential Parking Zones.
- C. The Director may modify boundaries or hours of an existing RPZ consistent with Policies and Procedures Concerning the Implementation of Residential Parking Zones.
- D. A restriction of parking shall first take effect on a street segment when it is signed or posted, and shall cease when the signs or posting are removed pursuant to lawful order; provided, that vandalism or destruction of parking control signs shall not affect the validity of a restriction upon parking on any street segment designated by the Director of Transportation if other signs or traffic control devices give notice that parking in the street segment is restricted.



- Develop and publish a Traffic Control Manual for In-street Work which sets forth the guidelines for the methods and devices to be used for safeguarding and controlling traffic at and near work in streets or alleys;
 - F. Designate alleys and short sections of streets for one (1) way traffic;

vehicle within the City unless such person has a valid driver's license issued under the provisions of RCW Chapter 46.20.

B. A violation of this section is a misdemeanor and is a lesser included offense within the offense described in Section 11.56.320 or Section 11.56.340. However, if a person in violation of this section provides the citing officer with an expired driver's license or other valid identifying documentation under RCW 46.20.035 at the time of the stop and is not in violation of Section 11.56.320 or Section 11.56.340, the violation of this section is an infraction and is subject to a penalty of Two Hundred Fifty Dollars (\$250). If the person appears in person before the court or submits by mail written proof that he or she obtained a valid license after being cited, the court shall reduce the penalty to Fifty Dollars (\$50). 11.20.060 Intermediate license restrictions.

- A. 

Any peace officer who has received notice of the suspension or revocation of a driver's license from the Department of Licensing may, during the reported period of such suspension or revocation, stop any motor vehicle identified by its vehicle license number as being registered to the person whose driver's license has been suspended or revoked. The driver of such vehicle shall display his driver's license upon request of the peace officer. (RCW 46.20.430)

11.20.340 Financial responsibility required.

No person may operate a motor vehicle subject to registration under Chapter 46.16 RCW in this City unless the person is insured under a motor vehicle liability policy with liability limits of at least the



amounts provided in RCW 46.29.090, is self-insured as provided in RCW 46.29.630, is covered by a certificate of deposit in conformance with RCW 46.29.550, or is covered by a liability bond of at least the amounts provided in RCW 46.29.090. Written proof of financial responsibility for motor vehicle operation must be

provided on the request of a law enforcement officer in the format specified under RCW 46.30.030.

- B. A person who drives a motor vehicle that is required to be registered in another state that requires drivers and owners of vehicles in that state to maintain insurance or financial responsibility shall, when requested by a law enforcement officer, provide evidence of financial responsibility or insurance as is required by the laws of the state in which the vehicle is registered.
- C. When asked to do so by a law enforcement officer, failure to display an insurance identification card as specified under RCW 46.30.030 creates a presumption that the person does not have motor vehicle insurance.
- D. Failure to provide proof of motor vehicle insurance is a traffic infraction and is subject to penalties as set by the supreme court under RCW 46.63.110 or community service. (RCW 46.30.020(1)) (Ord. 115895 § 1, 1991: Ord. 115040 § 1(part), 1990.)

11.20.345 Post citation proof of financial responsibility.



 - 5. On any motor vehicle owned by the dealer which is used only to move vehicles legally bearing mobile home and travel-trailer license plates of the dealer so owning any such motor vehicle;
 - On vehicles being moved to or from vehicle exhibitions within the State of Washington, 6. the Office of the City Clerk

- Miscellaneous vehicle dealer license plates may be used:
- To demonstrate any miscellaneous vehicle, provided that:

 - A dated demonstration permit, valid for no more than seventy-two (72) hours, is carried with the vehicle at all times it is operated by any such individual;
 - On vehicles owned, held for sale and which are, in fact, available for sale, by the firm when operated by an officer of the corporation, partnership or proprietorship or by a bona fide full-time employee of the firm, provided that a card so identifying such individual is carried in the vehicle at all times it is operated by him;
 - 3. On vehicles being tested for repair;
 - 4. On vehicles being transported to or from the place of business of the manufacturer and the place of business of the dealer or to and from places of business of the dealer;
 - 5. On vehicles on which any other item sold or to be sold by the dealer is transported from the place of business of the manufacturer to the place of business of the dealer or to and from places of business of the dealer; provided, that such vehicle and such item are purchased or sold as one (1) package.
 - D. Manufacturers properly licensed pursuant to this chapter may apply for and obtain manufacturer license plates and may be used:
 - 1. To transport vehicles to or from the place of business of a manufacturer to a vehicle dealer within this state who is properly licensed pursuant to this chapter;
 - 2. To test vehicles for repair.
 - E. Vehicle dealer license plates and manufacturer license plates shall not be used for any purpose other than set forth in this section and specifically shall not be:
 - 1. Used on any vehicle not within the class for which the vehicle dealer license plates are issued unless specifically provided for in this section;
 - 2. Loaned to any person for any reason not specifically provided for in this section;
 - 3. Used on any vehicles for the transportation of any person, produce, freight, or commodities unless specifically provided for in this section, except there shall be permitted the use of such

Commercial loading permits shall only be issued to persons or entities that possess a current business license issued by any governmental jurisdiction. The applicant may obtain one (1) nontransferable permit for each truck licensed vehicle operated by the company named in the

business license except as provided in subsection B of this section. The permit shall be permanently affixed to the lower left-hand corner of the vehicle's windshield except as provided in subsection B of this section. The applicant shall provide the license plate number, as well as other vehicle identification information as

- B. Companies that operate a fleet of ten (10) or more commercial vehicles will be eligible to purchase one (1) transferable permit for every five (5) commercial vehicles in their fleet with nontransferable permits. The transferable permits shall only be used on other commercial vehicles in the company fleet while a commercial vehicle with a nontransferable permit is temporarily out of service. Transferable permits shall be displayed in the lower left-hand corner of the windshield. Under no circumstances shall a transferable permit be used on any vehicle other than a commercial vehicle.
- C. Permits shall be valid for one (1) calendar year. Permits issued after July 1st of any calendar year shall have their fee reduced by fifty (50%) percent. (Ord. 114736 § 1, 1989: Ord. 114518 § 2, 1989: Ord. 114251 § 7(part), 1988.)

The applicant may obtain one (1) nontransferable permit for each shuttle bus licensed vehicle operated by the company named in the business license. The applicant shall provide the license plate number, as well as other vehicle identification information as determined by the Traffic Engineer. The permit shall be permanently affixed to the lower left-hand corner of the vehicle's windshield.
- B. Permits shall be valid for one (1) calendar year. The Traffic Engineer shall collect an annual fee of Three Hundred Dollars (\$300) for each permit issued to an applicant. Permits issued after July 1st of any calendar year shall have their fee reduced by fifty (50%) percent. (Ord. 121917 § 3, 2005.)

11.23.040 Overlegal trucking operation.

If the appropriate fund is solvent at the time payment is ordered, the Director of Executive Administration may elect to make payment by


A three (3) axle truck tractor and a two (2) axle pole trailer combination engaged in the operation of hauling logs may exceed by not more than six thousand eight hundred (6,800) pounds the legal gross weight of the combination of vehicles when licensed, as permitted by law, for sixty-eight thousand (68,000) pounds: Provided, That the distance between the first and last axle of the vehicles in combination shall have a total wheelbase of not less than thirty-seven feet (37') apart and shall not exceed thirty-three thousand six hundred (33,600) pounds. Such additional allowances shall be permitted by special permit issued in accordance with the provisions of RCW 46.44.047. (RCW 46.44.047) (Ord. 112092 § 17, 1984.)

11.23.220 Special permits for oversize or overweight movements.

- A. A special permit in writing may be obtained from the Traffic Engineer upon application in writing and good cause being shown therefor, authorizing the applicant to operate or move a vehicle or combination of vehicles of a size, weight of vehicle or load exceeding the maximum specified in Chapter 11.60, or otherwise not in conformity with the provisions of Chapter 11.60, upon any street or alley.
- B. No overweight permit shall be issued to any vehicle or combination of vehicles unless such vehicle or combination of vehicles is licensed for the maximum gross weight allowed by law. (RCW 46.44.090) (Ord. 108200 § 2(11.23.220), 1979.)

11.23.250 Special permits for oversize or overweight movements--Gross weight limit.

- A. Except as otherwise provided in subsections C and D of this section, no special permit shall be issued for movement on any street or alley where the gross weight, including load, exceeds the following limits:
 - 1. Twenty-two thousand (22,000) pounds on a single axle or on dual axles with a wheelbase between the first and second axles of less than three feet six inches (3' 6");
 - 2. Forty-three thousand (43,000) pounds on dual axles having a wheelbase between the first and second axles of not less than three feet six inches (3' 6") but less than seven feet (7');
 - 3. On any group of axles or in the case of a vehicle employing two (2) single axles with a wheelbase between the first and last axle of not less than seven feet (7') but less than ten feet (10'), a weight in pounds determined by multiplying six thousand five hundred (6,500) times the distance in feet between the center of the first axle and the center of the last axle of the group;
 - 4. On any group of axles with a wheelbase between the first and last axle of not less than ten feet (10') but less than thirty feet (30'), a weight in pounds determined by multiplying two thousand two hundred (2,200) times the sum of twenty (20) and the distance in feet between the center of

the first axle and the center of the last axle of the group;

- On any group of axles with a wheelbase between the first and last axle of thirty feet (30') or greater, a weight in pounds determined by multiplying one thousand six hundred (1,600) times the sum of forty (40) and the distance in feet between the center of the first axle and the center of the last axle of the group.
- B. The total weight of a vehicle or combination of vehicles allowable by special permit under subsection A of this section shall be governed by the lesser of the weights obtained by using the total number of axles as a group or any combination of axles as a group.
- The weight limitations pertaining to single axles may be exceeded to permit the movement of equipment operating upon single pneumatic tires having a rim width of twenty inches (20") or more and a rim diameter of twenty-four inches (24") or more or dual pneumatic tires having a rim width of sixteen inches (16") or more and specially designed vehicles manufactured and certified for special permits prior to July 1, 1975.
- D. Permits may be issued for weights in excess of the limitations contained in subsection A of this section for any shipment duly certified as necessary by military officials, or by officials of public or private power facilities, or when in the opinion of the Traffic Engineer the movement or action is a necessary movement or action: Provided, That in the opinion of the Traffic Engineer, streets or alleys on the routes involved are capable of sustaining weights in excess of such limitations and it is not reasonable, for economic or operational considerations, to transport such excess weights by rail or water for any substantial distance of the total mileage applied for.
- E. Application shall be made in writing on special forms provided by the Traffic Engineer and shall be submitted at least thirty-six (36) hours in advance of the proposed movement. An application for a special permit for a gross weight of any combination of vehicles exceeding two hundred thousand (200,000) pounds shall be submitted in writing to the Traffic Engineer at least thirty (30) days in advance of the proposed movement. 11.23.290 Annual additional tonnage permits--Fees.

- When a combination of vehicles has been lawfully licensed to a total weight of eighty thousand A. (80,000) pounds and when a three (3) or more axle single-unit vehicle has been lawfully licensed to a total gross weight of forty thousand (40,000) pounds pursuant to Section 11.60.370, a permit for additional gross weight may be issued by the Traffic Engineer upon the payment of Thirty-seven Dollars and Fifty Cents (\$37.50) per year for each one thousand (1,000) pounds or fraction thereof of such additional gross weight: Provided, That the tire limits specified in Section 11.60.420 shall apply, and the gross weight on any single axle shall not exceed twenty thousand (20,000) pounds, and the gross load on any group of axles shall not exceed the limits set forth in Section 11.60.370: Provided further, That within the tire limits of Section 11.60.420 and notwithstanding Sections 11.60.370 and 11.23.250, a permit for an additional six thousand (6,000) pounds may be purchased for the rear axles of a two (2) axle garbage truck or eight thousand (8,000) pounds for the tandem axle of a three (3) axle garbage truck at a rate not to exceed Thirty Dollars (\$30.00) per thousand (1,000).
 - B. The annual additional tonnage permits provided for in this section shall be issued upon such

- The annual additional tonnage permits provided for in this section shall commence on the first of January or the first of April of each year. The permit may be purchased at any time, and if they are purchased for less than a full year, the fee shall be one-twelfth (1/12) of the full fee multiplied by the number of months, including any fraction thereof, covered by the permit. When the Traffic Engineer issues a duplicate permit to replace a lost or destroyed permit and where the Traffic Engineer transfers a permit from one (1) vehicle to another a fee of Five Dollars (\$5.00) shall be charged for each duplicate issued or each transfer. The Traffic Engineer shall issue permits on a temporary basis for periods not less than five (5) days at One Dollar (\$1.00) per day for each two thousand (2,000) pounds or fraction thereof.


- e text, graphics, A person with a current and valid identification card and disabled parking placard from the Washington State Department of Licensing under RCW 46.16.381 shall be allowed to park a vehicle displaying the placard that is being used to transport such person free of charge for a maximum of a four-hour time period in parking areas, including those with a parking payment device, that are otherwise restricted as to the length of time parking is permitted. Areas with four-hour time limits shall be appropriately signed and/or marked.
- B. A person with a current and valid identification card and disabled parking license plate or disabled parking year tab from the Washington State Department of Licensing under RCW 46.16.381 shall be allowed to park the vehicle displaying the license plate or year tab that is being used to transport the person free of charge for unlimited periods of time in parking areas, including those with parking payment devices, that are otherwise restricted as to the length of time parking is permitted.
- C. This section shall have no application to those zones or areas in which the stopping, parking, or standing of all vehicles is prohibited or which are reserved for special types of vehicles. Such person shall not be permitted the foregoing privilege unless he or she obtains and displays a placard, disabled parking year tab, or license plate issued pursuant to RCW 46.16.381. 11.23.390 Carpool parking--Application for certificate and permit.

11.23.400 Disabled parking--Enforcement.

- Knowingly providing false information in conjunction with an application for a disabled parking permit is a gross misdemeanor. For purposes of this subsection, "knowingly" has the same meaning as in Section 12A.04.030 B.
- Except as provided by subsection A of this section, it is a traffic infraction, with a monetary penalty of Two Hundred Fifty Dollars (\$250), for any person wilfully to obtain a disabled parking placard, license plate, or photo identification card in a manner other than that established by RCW 46.16.381.
 - C. The unauthorized use of a disabled parking placard, license plate, or photo identification card

- The court may not suspend more than one-half (1/2) of any fine imposed under subsection B or C of this section. For a second or subsequent violation of subsection B or C of this section, in addition to a monetary penalty, a violator must complete a minimum of forty (40) hours of either community service for a nonprofit organization that serves the disabled community or persons having disabling diseases or any other community service that may sensitize the violator to the needs and obstacles faced by persons who have disabilities.
- Any peace officer or parking checker finding any unauthorized use of such placard, or license plate shall issue and affix a notice indicating the unauthorized uses thereof in the form and in the manner required by Section 11.31.030.

The carpool parking permit shall be displayed upon each parked vehicle at the time, place and manner prescribed in such permit. (Ord. 108200 § 2(11.23.410), 1979.)

11.23.415 Carpool parking--Unlawful use of permit.

It is unlawful to display upon any vehicle a carpool parking permit at a time or place or in a manner not consistent with the terms of such permit, and in addition to any other penalty prescribed by this subtitle, such unlawful display shall be sufficient cause for revocation of such permit. 11.23.420 Curb space parking permits.

The Director of Engineering may authorize curb space parking permits for charitable, educational or community purposes, including, for example, medically related programs, armed forces recruiting efforts and street fairs; provided, that no permits shall be authorized for commercial purposes except in conjunction with community events. 11.23.440 Parking privileges.

No person shall be granted a franchise or special privilege to the exclusion of any other like person for parking vehicles on any roadway. 
11.24.030 Signage that may be required by Traffic Engineer.

Whenever the Traffic Engineer determines that, to protect life, limb, or property, facilitate the movement of traffic, prevent traffic congestion, or maintain the most efficient transportation use of the streets or alleys, any of the following vehicular movements should be prohibited or required, it shall be incumbent upon and the duty of the owner or agent of property designated by the Traffic Engineer, when so ordered by such official, to install and maintain on such property one or more signs subject to approval by the Traffic Engineer as to sign design and location, indicating that the following vehicular movement(s) are prohibited or required, as specified by the Traffic Engineer:

- Making a left turn or right turn from an off-street garage, parking lot, or other vehicular facility served by a driveway or other route commonly used for travel;
- Obtaining ingress to or egress from private property by way of a specified driveway or other route commonly used for travel;
 - C. Backing into a street area from a driveway; or
- Stopping or yielding for oncoming traffic. D. (Ord. 115995 § 14, 1991.)

No person shall conduct or participate in a parade upon any street or alley in the City without first submitting a written notification to the Chief of Police and obtaining a permit from the Chief of Police to do so. Upon written notification to the Chief of Police, the Chief of Police shall grant a permit. So that preparations for traffic regulation can be made, the written notification for permit shall state the place and hour of formation, the proposed line of movement or march, the scheduled starting time, and the names of the persons having charge or control of the parade, and the name of the sponsoring agency, if any. Such written notification shall be delivered to the Chief of Police at least forty-eight (48) hours before the parade is scheduled to begin: Provided, that the forty-eight (48) hour time limit for written notification may be waived by the Chief of Police if, at the time the written notice is submitted, the Chief of Police anticipates being able to make reasonable preparations for the parade within less time than forty-eight (48) hours. The Chief of Police may modify the place and hour of formation, the proposed line of movement or march, and the scheduled starting time in the interest of vehicular or pedestrian traffic safety.

The Traffic Engineer is authorized to issue upon application permits for service parking upon payment of the prescribed fee as established herein. As many permits may be issued to any one (1) applicant as the Traffic Engineer deems necessary or convenient. Service parking permits are of two (2) types: Those needed for building service and those needed for on-street service functions. "Building service" is defined as rendering maintenance service to building and building equipment, including utilities. "On-street service" is defined as a commercial vehicle being used as a mobile shop or a commercial vehicle engaged in loading or unloading operations or when the parking space is to be cleared to allow work to occur in the roadway area. (Ord. 112550 § 1, 1985; Ord. 110363 § 1, 1981; Ord. 108200 § 2(11.26.020), 1979.)

11.26.040 Application for service parking.

Applicant for a service parking permit shall set forth the nature of his business and the necessity for such permit in his application to the Traffic Engineer. Upon receipt of the application, the Traffic Engineer shall investigate the facts and upon approval, issue a permit. (Ord. 108200 § 2(11.26.040), 1979.)

11.26.060 Service parking hoods.

- The holder of a valid building service parking permit shall be issued a service hood, padlock and Α. keys to use in covering any parking meter, other than fifteen (15) minute meters or commercial vehicle load zones, or for display in the vehicle where parking is controlled by time limit posting or parking pay station rather than by parking meters. As many service hoods may be issued as the Traffic Engineer deems necessary or convenient for the application upon payment of the prescribed fee.

Unless a report is to be made by a law enforcement officer under subsection B of this section, the operator of any vehicle involved in a collision resulting in injury to or death of any person or damage to the property of any one (1) person to an apparent extent equal to or greater than the minimum amount established by rule adopted by the Chief of the Washington State Patrol in accordance with RCW 46.52.030 shall, within four (4) days after such collision make a written report of such collision to the Chief of Police on forms furnished by him; the original of such report to be immediately forwarded by the Chief of Police to the Chief of the Washington State Patrol at Olympia, Washington, and the second copy of such report to be forwarded to the Department of Licensing at Olympia, Washington. The Chief of Police may require any operator of any vehicle involved in a collision, of which report must be made as provided in this Section 11.27.020, to file supplemental reports whenever the original report in his opinion is insufficient and may likewise require witnesses of any such collision to render reports.
- B. Any law enforcement officer present at the scene of a collision or in possession of any facts concerning a collision shall submit an investigator's report as required by RCW 46.52.070. (RCW 46.52.030) (Ord. 119011 § 8, 1998: Ord. 108200 § 2(11.27.020), 1979.)

11.27.040 Report when operator disabled.

The operator of the vehicle shall pay all costs for such removal. If the operator fails or is unable to remove such glass, debris or other injurious substance, the City may remove such substance and the operator of the vehicle shall reimburse the City for all costs of such removal. Any person to whom a permit or other authorization is granted to park in a restricted parking zone shall be strictly liable for compliance with its terms and conditions and complying with this subtitle. Any such permit or other authorization issued shall be revoked if any person to whom such permit is issued or authorization granted shall:



When a vehicle without a special license plate, card, or decal indicating that the vehicle is being used to transport a disabled person as defined under Chapter 46.16 RCW, as now or hereafter amended, is parked in a stall or space clearly and conspicuously marked as provided in Section 11.72.065 A, as now or hereafter amended, whether the space is provided on private property without charge or on public property; or

 - When a police officer has probable cause to believe that the vehicle is stolen; or
 - When a police officer has probable cause to believe that the vehicle constitutes evidence of a crime or contains evidence of a crime, if impoundment is reasonably necessary in such instance to obtain or preserve such evidence; or
 - 7. When a vehicle is parked in a public right-of-way or on other publicly owned or controlled property in violation of any law, ordinance, or regulation and there are four (4) or more parking infractions issued against the vehicle for each of which a person has failed to respond, failed to appear at a requested hearing, or failed to pay an adjudicated parking infraction for at least forty-five (45) days from the date of the filing of the notice of infraction;
 - 8. When the vehicle is a "junk motor vehicle" as defined in SMC 11.14.268, and is parked on a street, alley, or way open to the public, or on municipal or other public property.
 - 9. When the vehicle is impounded pursuant to Section 11.30.105A, but if the vehicle is a commercial vehicle and the driver is not the registered owner of the vehicle, then the police officer shall attempt in a reasonable and timely manner to contact the registered owner before impounding the vehicle and may release the vehicle to the registered owner if the registered owner is reasonably available, was not in the vehicle at the time it was stopped and the driver arrested, and has not received a prior release under this Subsection 11.30.040 A9 or Subsection 11.30.120 C2.

The notice shall contain the full particulars of the impoundment, redemption, and opportunity for hearing to contest the propriety of the impoundment as hereinafter provided.
- B. Similar notice shall be given to each person who seeks to redeem an impounded vehicle, except that if a vehicle is redeemed prior to the mailing of notice, then notice need not be mailed.
- C. The Seattle Police Department shall give written notification to the last registered and legal owner that the investigatory hold has been removed, except that if a vehicle is redeemed following notice by telephone and prior to the mailing of notice, then notice need not be mailed. In addition, the Police Department shall notify the towing contractor, by telephone or in writing, of the authorization to release such vehicle. 11.30.105 Impoundment of vehicle where driver is arrested for a violation of Section 11.56.320 B or C or Section 11.56.020--Period of impoundment.

A. Whenever the driver of a vehicle who is also the registered owner of the vehicle is arrested for a violation of Section 11.56.020, 11.56.320 B or C, the vehicle is subject to impoundment at the direction of a police officer. For purposes of this subsection, "arrested" includes, but is not limited to, being temporarily detained under Section 12A.02.140 B and served with a citation and notice to appear pursuant to Section 12A.02.140 C and RCW 46.64.015.

- D. If a vehicle is impounded because the driver is arrested for a violation of Section 11.56.320 B or C and the Washington Department of Licensing's records show that the driver has not been convicted of a violation of RCW 46.20.342(1)(a) or (b) or similar local ordinance within the past five (5) years, the vehicle shall be impounded for thirty (30) days.
- E. If a vehicle is impounded because the driver is arrested for a violation of Section 11.56.320 B or C and the Washington Department of Licensing's records show that the driver has been convicted one (1) time of a violation of RCW 46.20.342(1)(a) or (b) or similar local ordinance once within the past five (5) years, the vehicle shall be impounded for sixty (60) days.
- F. If a vehicle is impounded because the driver is arrested for a violation of Section 11.56.320 B or C and the Washington Department of Licensing's records show that the driver has been convicted of a violation of RCW 46.20.342(1)(a) or (b) or similar local ordinance two (2) or more times within the past five (5) years, the vehicle shall be impounded for ninety (90) days. (Ord. 121483 § 1, 2004; Ord. 120006 § 1, 2000; Ord. 12005 § 1, 2000; Ord. 119180 § 4, 1998.)

11.30.120 Redemption of impounded vehicles.

Vehicles impounded by the City shall be redeemed only under the following circumstances:

- A. Only the registered owner, a person authorized by the registered owner, or one who has purchased the vehicle from the registered owner, who produces proof of ownership or authorization and signs a receipt therefor, may redeem an impounded vehicle. A person redeeming a vehicle impounded pursuant to Section 11.30.105 must prior to redemption establish that he or she has a valid driver's license and is in compliance with Section 11.20.340. A vehicle impounded pursuant to Section 11.30.040 A7 or Section 11.30.105 can be released only pursuant to a written order from the Police Department or a court.
- B. Any person so redeeming a vehicle impounded by the City shall pay the towing contractor for costs of impoundment (removal, towing, and storage) and administrative fee prior to redeeming such vehicle. Such towing contractor shall accept payment as provided in RCW 46.55.120(1)(b), as now or hereafter amended. If the vehicle was impounded pursuant to Section 11.30.105 and was being operated by the registered owner when it was impounded, it may not be released to any person until all penalties, fines, or forfeitures owed by the registered owner to the City of Seattle have been satisfied by payment in full, by establishment of a time payment agreement with the Municipal Court, or by other means acceptable to the Municipal Court.
- C. The Chief of Police or Municipal Court is authorized to release a vehicle impounded pursuant to Section 11.30.105 prior to the expiration of any period of impoundment:
 - 1. Upon petition of the spouse of the driver, or the person registered pursuant to Ordinance 117244 as the domestic partner of the driver, based on economic or personal hardship to such spouse or domestic partner resulting from the unavailability of the vehicle and after consideration of the





threat to public safety that may result from release of the vehicle, including, but not limited to, the driver's criminal history, driving record, license status, and access to the vehicle; or

If the registered owner of the vehicle was not the driver, did not know that the driver's driver's license was suspended or revoked and has not received a prior release under this Subsection 11.30.120 C2 or Subsection 11.30.040 A9.

In order to avoid discriminatory application, the Chief of Police and Municipal Court shall deny release without discretion in all circumstances other than for the reasons set forth in this Subsection 11.30.120 C. If such release is authorized, the person redeeming the vehicle still must satisfy the requirements of Section 11.30.120 A and B.

- D. Any person seeking to redeem a vehicle impounded as a result of a parking or traffic citation has a right to a hearing before a Municipal Court judicial officer to contest the validity of an impoundment or the amount of removal, towing, and storage charges or administrative fee if such request for hearing is in writing, in a form approved by the Municipal Court and signed by such person, and is received by the Municipal Court within ten (10) days (including Saturdays, Sundays, and holidays) of the latter of the date the notice was mailed to such person pursuant to Section 11.30.100 A or B, or the date the notice was given to such person by the registered tow truck operator pursuant to RCW 46.55.120(2)(a). Such hearing shall be provided as follows:
 - If all of the requirements to redeem the vehicle, including expiration of any period of 1. impoundment under Section 11.30.105, have been satisfied, then the impounded vehicle shall be released immediately, and a hearing as provided for in Section 11.30.160 shall be held within ninety (90) days of the written request for hearing.
 - 2. If not all of the requirements to redeem the vehicle, including expiration of any period of impoundment under Section 11.30.105, have been satisfied, then the impounded vehicle shall not be released until after the hearing provided pursuant to Section 11.30.160, which shall be held within two (2) business days (excluding Saturdays, Sundays and holidays) of the written request for hearing.
 - 3. Any person seeking a hearing who has failed to request such hearing within the time specified in Section 11.30.120 D may petition the Municipal Court for an extension to file a request for hearing. Such extension shall only be granted upon the demonstration of good cause as to the reason(s) the request for hearing was not timely filed. For the purposes of this section, "good cause" shall be defined as circumstances beyond the control of the person seeking the hearing that prevented such person from filing a timely request for hearing. In the event such extension is granted, the person receiving such extension shall be granted a hearing in accordance with this chapter.
 - 4. If a person fails to file a timely request for hearing and no extension to file such a request has been granted, the right to a hearing is waived, the impoundment and the associated costs of impoundment and administrative fee are deemed to be proper, and the City shall not be liable for removal, towing, and storage charges arising from the impoundment.
 - 5. In accordance with RCW 46.55.240 (1)(d), a decision made by a Municipal Court judicial officer

may be appealed to Municipal Court for final judgment. The hearing on the appeal under this subsection shall be de novo. A person appealing such a decision must file a request for an appeal in Municipal Court within fifteen (15) days after the decision of the Municipal Court judicial officer and must pay a filing fee in the same amount required for the filing of a suit in district court. If a person fails to file a request for an appeal within the time specified by this section or does not pay the filing fee, the right to an appeal is waived and the Municipal Court judicial officer's decision is final.

Hearings requested pursuant to Section 11.30.120 shall be held by a Municipal Court judicial officer, who shall determine whether the impoundment was proper and whether the associated removal, towing, storage, and administrative fees were proper. The Municipal Court judicial officer shall not have the authority to determine the commission or mitigation of any parking infraction unless a timely response under Section 11.31.050 A was filed to that notice of infraction requesting a hearing and the hearing date for that infraction has not passed, in which case the Municipal Court judicial officer has discretion to consolidate the impoundment hearing and the notice of infraction hearing.

- A. At the hearing, an abstract of the driver's driving record is admissible without further evidentiary foundation and is prima facie evidence of the status of the driver's license, permit, or privilege to drive and that the driver was convicted of each offense shown on the abstract. In addition, a certified vehicle registration of the impounded vehicle is admissible without further evidentiary foundation and is prima facie evidence of the identity of the registered owner of the vehicle.
- В. If the impoundment is found to be proper, the Municipal Court judicial officer shall enter an order so stating. In the event that the costs of impoundment (removal, towing, and storage) and administrative fee have not been paid or any other applicable requirements of Section 11.30.120 B have not been satisfied or any period of impoundment under Section 11.30.105 has not expired, the Municipal Court judicial officer's order shall also provide that the impounded vehicle shall be released only after payment to the City of any fines imposed on any underlying traffic or parking infraction and satisfaction of any other applicable requirements of Section 11.30.120 B and payment of the costs of impoundment and administrative fee to the towing company and after expiration of any period of impoundment under Section 11.30.105. In the event that the Municipal Court judicial officer grants time payments for the costs of impoundment and administrative fee, the City shall be responsible for paying the costs of impoundment to the towing company. The Municipal Court judicial officer shall grant such time payments only in cases of extreme financial need, and where there is an effective guarantee of payment.
- If the impoundment is found to be improper, the Municipal Court judicial officer shall enter an order so stating and order the immediate release of the vehicle. If the costs of impoundment and administrative fee have already been paid, the Municipal Court judicial officer shall enter judgment against the City and in favor of the person who has paid the costs of impoundment and administrative fee in the amount of the costs of the impoundment and administrative fee.

- Seattle Municipal Code le update file In the event that the Municipal Court judicial officer finds that the impound was proper, but that the removal, towing, storage, or administrative fees charged for the impoundment were improper, the Municipal Court judicial officer shall determine the correct fees to be charged. If the costs of impoundment and administrative fee have been paid, the Municipal Court judicial officer shall enter a judgment against the City and in favor of the person who has paid the costs of impoundment and administrative fee for the amount of the overpayment.
 - E. No determination of facts made at a hearing under this section shall have any collateral estoppel effect on a subsequent criminal prosecution and such determination shall not preclude litigation of those same facts in a subsequent criminal prosecution.
 - An appeal of the Municipal Court judicial officer's decision in Municipal Court shall be conducted according to, and is subject to, the procedures of this section. If the court finds that the impoundment or the removal, towing, storage, or administrative fees are improper, any judgment entered against the City shall include the amount of the filing fee.

11.30.180 Responsibility for fees as to standby time or vehicles held for investigatory purposes.

- No fee shall be assessed against the owner of a vehicle for time elapsed after the towing equipment has arrived at the location of the vehicle to be towed and prior to the operation of the towing equipment or performance of the impound service.
- B. No impoundment fee and/or towing or storage charges shall be assessed against the owner of a vehicle which is being held for investigatory purposes pursuant to Section 11.30.040 A6 and which is redeemed within forty-eight (48) hours after the Police Department shall have notified the owner of the release of such vehicle in writing in the manner provided in Section 11.30.100 C; provided that such owner or person authorized to obtain possession of such impounded vehicle shall pay any charges assessed for storage after such forty-eight (48) hour period; provided further, that if the registered owner or the driver authorized by the registered owner is arrested or charged with a crime in connection with the incident leading to impoundment, the City shall not pay the towing or storage charges.

 A. The Director of Executive Administration is authorized and directed to prepare specifications for
 - A. The Director of Executive Administration is authorized and directed to prepare specifications for towing and storage of vehicles, including instructions to bidders, containing such provisions as the Director of Executive Administration shall deem advisable and not in conflict with this chapter. The specifications shall be subject to the review and approval of the Budget Director and the approval of the City Council by resolution passed for such purpose.
 - B. A call for bids responsive to such specifications shall then be made, and the contract shall be awarded to the lowest and best bidder whose proposal is deemed by the Director of Executive Administration to be the most advantageous for the public and the City; provided that, in the event all bids are deemed by the Director of Executive Administration to be too high or irregular, he or she may reject all such bids and make another call for bids or proceed alternatively pursuant to ordinance passed for such purpose.

The Director of Executive Administration shall consider, among other relevant factors, the following:

- 1. Integrity, skill, and business judgment of the bidder;
- 2. General experience in providing towing and storage services;
 - 3. Conduct and performance under a previous City towing impound contract demonstrating honesty, promptness, skill, efficiency, and a satisfactory relationship with vehicle owners;
 - 4. Existing availability of equipment, facilities, and personnel; and
 - 5. The bidder's financial ability and willingness to expand or improve available equipment, facilities, and services.

The contract award shall be in accordance with the specifications so approved for towing and storage service necessary for carrying out the provisions of this chapter.

C. Subsequent to the award of the contract, the Director of Executive Administration shall file a written statement with the City Clerk giving the name and address of the contractor for towing and storage of vehicles and, if more than one (1) place of storage has been provided, the name and address or location of each storage place. The Director of Executive Administration shall administer and enforce contracts made pursuant to this section.

11.30.240 Contract for towing and storage--Financial responsibility.

Any contract for towing and storage under the provisions of this chapter shall require the contractor to demonstrate proof of financial responsibility for any liability which the City may have as a result of any negligence, wilful conduct or breach of contract by the contractor and for any damages which the owner of an impounded vehicle may sustain as a result of damage to or loss of the vehicle, or the contents of a vehicle in the custody of the contractor. Proof of financial responsibility shall be furnished either by proof of insurance, by filing a surety bond and/or by depositing cash in such amounts as the Finance Director shall determine necessary.

11.30.280 Contractor to file monthly claim for services.

The contractor shall, on or before the tenth day of each month, file his or her claim with the Department of Executive Administration for towing and storage charges accruing to him or her upon vehicles redeemed as provided in this chapter during the preceding month, in accordance with this chapter and with the specifications for the contract authorized in Section 11.30.220, and such claim shall be sworn to by him or her under oath. The Director of Executive Administration shall audit such claim and any payment thereof at least once annually. A warrant or warrants for payment of such claim shall be drawn and paid by the Director of Executive Administration from such expenditure allowances as may be provided therefor in the annual budget or from such moneys as may otherwise be appropriated for such purpose. - В. If a vehicle is impounded pursuant to Section 11.30.040 A7, an administrative fee shall be levied when the vehicle is redeemed under the specifications of the contract provided for by Section 11.30.220.
- If a vehicle is impounded other than pursuant to Section 11.30.040 A7 or Section 11.30.-105, an administrative fee shall be levied when the vehicle is redeemed under the specifications of the contract provided for by Section 11.30.-220.
- The administrative fee shall be collected by the contractor performing the impound, and shall be remitted to the Department of Executive Administration in the manner directed by the Director of Executive Administration and as specified in the contract provided by Section 11.30.220 A. The administrative fee shall be for the purpose of offsetting, to the extent practicable, the cost to the City of implementing, enforcing, and administering the provisions of this chapter and shall be deposited in an appropriate account. The administrative fee shall be set by rule by the Director of Executive Administration in an amount not to exceed One Hundred Dollars (\$100).

11.30.360 Violations constituting abandoning--Evidence--Penalty.

- A. No person shall wilfully leave an abandoned vehicle on private property for more than twenty-four (24) hours without the permission of the person having the right to possession of the property, or a wrecked, dismantled, or inoperative vehicle or automobile hulk on a street, alley or way open to the public for twenty-four (24) hours or longer without notification to the Chief of Police of the reasons for leaving the motor vehicle in such a place. Any such vehicle or hulk shall be abated and removed in accordance with the provisions of Ordinance 98223, as amended, and enforcement shall be by the Director of Transportation in accordance with said ordinance as amended. For the purposes of this section, the fact that a motor vehicle has been so left without permission or notification is prima facie evidence of abandonment.
- B. Any person found to have abandoned a vehicle or hulk shall, in addition to any penalty imposed, also be assessed any costs incurred by the City in the removal of such abandoned vehicle or hulk less any

Except as otherwise provided in Section 12A.06.010, Section 11.34.020 or elsewhere in this title, failure to perform any act required or the performance of any act prohibited by this title is designated as a traffic infraction and may not be classified as a criminal offense.

- 2. if an officer investigating at the scene of a motor vehicle accident has reasonable cause to believe that the driver of a motor vehicle involved in the accident has committed a traffic infraction; or
- 3. when the infraction is detected through the use of an automated traffic safety camera under Washington Laws of 2005, chapter 167, section 1.

Whenever any motor vehicle without an operator is found parked, standing or stopped in violation of this subtitle, the officer finding it may take its registration number and any other information displayed on the vehicle which may identify its user, and shall fix conspicuously to such vehicle a notice of traffic infraction. 11.31.040 Notice of traffic infraction--Determination--Response.

A notice of traffic infraction represents a determination that an infraction has been committed. The determination will be final unless contested as provided in this chapter. (RCW 46.63.060) (Ord. 109476 § 1(part), 1980: Ord. 108200 § 2(11.31.020), 1979.)

11.31.050 Response to notice of traffic infraction--Contesting determination--Hearing--Failure to appear.

- A. Any person who receives a notice of traffic infraction shall respond to such notice as provided in this section within fifteen (15) days of the date of the notice.
- B. If the person determined to have committed the infraction does not contest the determination the person shall respond by completing the appropriate portion of the notice of infraction and submitting it, either by mail or in person, to the Municipal Court of Seattle. A check or money order in the amount of the penalty prescribed for the infraction must be submitted with the response. When a response which does not contest the determination is received, an appropriate order shall be entered in the court's records, and a record of the response and order shall be furnished to the Department of Licensing in accordance with RCW 46.20.270.
- C. If the person determined to have committed the infraction wishes to contest the determination the person shall respond by completing the portion of the notice of infraction requesting a hearing and submitting it, either by mail or in person, to the Municipal Court of Seattle. The court shall notify the person in writing of the time, place, and date of the hearing, and that date shall not be sooner than fifteen (15) days from the date of the notice, except by agreement.
- D. If the person determined to have committed the infraction does not contest the determination but wishes to explain mitigating circumstances surrounding the infraction, the person shall respond by completing the portion of the notice of infraction requesting a hearing for that purpose and submitting it, either by mail or in person, to the Municipal Court of Seattle. The court shall notify the person in writing of the time, place, and date of the hearing.
- E. In any hearing conducted pursuant to subsections C or D of this section, the court may defer findings, or in a hearing to explain mitigating circumstances may defer entry of its order, for up to one (1) year and impose conditions upon the defendant the court deems appropriate. Upon deferring findings, the court may assess costs as the court deems appropriate for administrative processing. If at the end of the deferral period the defendant has met all conditions and has not been determined to have committed another traffic infraction, the court may dismiss the infraction. A person may not receive more than one (1) deferral within a seven (7) year period for traffic infractions for moving violations and more than one (1) deferral within a seven (7) year period for traffic infractions for nonmoving violations.

- The court may consider the notice of traffic infraction and any other written report made under oath submitted by the officer who issued the notice or whose written statement was the basis for the issuance of the notice in lieu of the officer's personal appearance at the hearing. The person named in the notice may subpoena witnesses, including the officer, and has the right to present evidence and examine witnesses present in court.
- The burden of proof is upon the City to establish the commission of the infraction by a preponderance of the evidence.
- After consideration of the evidence and argument, the court shall determine whether the infraction was committed. Where it has not been established that the infraction was committed, an order dismissing the notice shall be entered in the court's records. Where it has been established that the infraction was committed an appropriate order shall be entered in the court's records. A record of the court's determination and order shall be furnished to the Department of Licensing in accordance with RCW 46.20.270 as now or hereafter amended.
- An appeal from the court's determination or order shall be to the Superior Court. The decision of E. the Superior Court is subject only to discretionary review pursuant to Rule 2.3 of the Rules of Appellate Procedure. (RCW 46.63.090)



- A. In any traffic infraction case involving a violation of this title relating to the stopping, standing or parking of a vehicle, or the sounding of an audible alarm, proof that the particular vehicle described in the notice of traffic infraction was stopping, standing or parking or emitting an audible alarm in violation of any such provision in this title together with proof of registered ownership of the vehicle at the time of the violation, shall constitute in evidence a prima facie presumption that the registered owner of the vehicle was the person who parked or placed the vehicle at the point where, and for the time during which, the violation occurred or was responsible for the failure to turn off the audible alarm as required.
- B. The foregoing stated presumption shall apply only when the procedure prescribed in Section 11.31.030 has been followed. (RCW 46.63)
- C. If a car rental agency declares that the vehicle was under lease at the time of the violation, and supplies the name and address of the lessee, there shall be a prima facie presumption that the lessee so identified parked or placed the vehicle at the point where the violation occurred, or was responsible for the failure to turn off the audible alarm as required.

11.31.090 Traffic infractions detected through the use of an automated traffic safety camera.

- A. A notice of infraction based on evidence detected through the use of an automated traffic safety camera must be mailed to the registered owner of the vehicle within fourteen (14) days of the violation, or to the renter of a vehicle within fourteen (14) days of establishing the renter's name and address under subsection C1 of this section. The peace officer issuing the notice of infraction shall include with it a certificate or facsimile thereof, based upon inspection of photographs, microphotographs, or electronic images produced by an automated traffic safety camera, stating the facts supporting the notice of infraction. This certificate or facsimile is prima facie evidence of the facts contained in it and is admissible in a proceeding charging a violation of Section 11.50.140. The photographs, microphotographs, or electronic images evidencing the violation must be available for inspection and admission into evidence in a proceeding to adjudicate the liability for the infraction.
- B. A person receiving such a notice of infraction may respond to the notice by mail. The registered owner of a vehicle is responsible for such an infraction unless the registered owner overcomes the presumption in subsection E of this section, or, in the case of a rental car business, satisfies the conditions under subsection C of this section. If appropriate under the circumstances, a renter identified under subsection C1 of this section is responsible for such an infraction.
- C. If the registered owner of the vehicle is a rental car business, the peace officer shall, before such a notice of infraction is issued, provide a written notice to the rental car business that a notice of infraction may

be issued to the rental car business if the rental car business does not within eighteen (18)

be issued to the rental car business if the rental car business does not, within eighteen (18) days of receiving the written notice, provide to the peace officer by return mail:

- 1. A statement under oath stating the name and known mailing address of the individual driving or renting the vehicle when the infraction occurred; or
 - 2. A statement under oath that the business is unable to determine who was driving or renting the vehicle at the time the infraction occurred; or
- In lieu of identifying the vehicle operator, the rental car business may pay the applicable penalty.

Timely mailing of this statement to the peace officer relieves a rental car business of any liability under this chapter for the notice of infraction.

- D. For the purposes of this section, "automated traffic safety camera" means a device that uses a vehicle sensor installed to work in conjunction with an intersection traffic control system and a camera synchronized to automatically record one (1) or more sequenced photographs, microphotographs, or electronic images of the rear of a motor vehicle at the time the vehicle fails to stop when facing a steady red traffic control signal.
- E. In a traffic infraction case involving an infraction detected through the use of an automated traffic safety camera, proof that the particular vehicle described in the notice of traffic infraction was in violation of Section 11.50.140, together with proof that the person named in the notice of traffic infraction was at the time of the violation the registered owner of the vehicle, constitutes in evidence a prima facie presumption that the registered owner of the vehicle was the person in control of the vehicle at the point where, and for the time during which, the violation occurred. This presumption may be overcome only if the registered owner states, under oath, in a written statement to the court or in testimony before the court that the vehicle involved was, at the time, stolen or in the care, custody, or control of some person other than the registered owner. (Laws of 2005, chapter 167, section 1 and RCW 46.63.075) (Ord. 121944 § 3, 2005.)

11.31.115 Monetary penalty doubled for certain traffic infractions.

A person found to have committed a traffic infraction relating to speed restrictions in a school or playground crosswalk zone under Section 11.52.100 or a roadway construction zone under Section 11.52.110 or overtaking and passing a school bus under Section 11.53.440 A shall be assessed a monetary penalty equal to twice the penalty assessed under Section 11.31.120. This penalty may not be waived, reduced or suspended. (RCW 46.61.440(2); RCW 46.61.527(3); RCW 46.61.370(6)) (Ord. 119011 § 9, 1998.)

11.31.120 Monetary penalties.

A. A person found to have committed a traffic infraction shall be assessed a monetary penalty. No penalty may exceed Two Hundred Fifty Dollars (\$250.00) for each offense unless a higher penalty is specifically provided for in this title or by statute.

- B. There shall be a penalty of Twenty-five Dollars (\$25.00) for failure to respond to a notice of traffic infraction, to appear at a requested hearing or to pay a monetary penalty imposed pursuant to this chapter; provided, the penalty for failure to respond to a notice of the traffic infraction of overtime parking shall be Twenty Dollars (\$20.00).
 - C. A traffic infraction for violation of Section 11.50.140 detected through the use of an automated traffic safety camera shall be processed in the same manner as a parking infraction, with a base monetary penalty of One Hundred One Dollars (\$101.00).

- There shall be a maximum penalty and default amount of Twenty-five Dollars (\$25) for failure to respond to a notice of violation under Section 11.84.345 within fifteen (15) days from the date of notice as contemplated by RCW 7.80.030(1) and 7.80.076(2)(K), a failure to appear at a hearing requested by the recipient of the notice as contemplated by RCW 7.80.160(2) and RCW 7.80.070(2)(K), and a failure to pay a penalty imposed under subsection A of this section, as contemplated by RCW 7.80.160(3).

This section shall not apply to pedestrians crossing a roadway at a point where an accessible pedestrian tunnel or overhead pedestrian crossing has been provided.

11.40.130 Prohibited crossing of median barrier.

No pedestrian shall cross an arterial street other than in a crosswalk, except upon the following portions of streets within the Pike Place Market Historical District:

11.40.200 White cane abuse.

Only persons who have no vision or whose vision, with corrective glasses or contact lenses, is so defective as to prevent the performance of ordinary activities for which eyesight is essential, shall use a white cane or walking stick for the purpose of securing the rights accorded to pedestrians in Section 11.40.180. (Ord. 108200 § 2(11.40.200), 1979.)

11.40.220 Walking on sidewalk.

Where there are sidewalks provided, no pedestrian shall move along and upon an adjacent roadway. Where sidewalks are provided but wheelchair access is not available, disabled persons may move along and upon an adjacent roadway until they reach an access point in the sidewalk. (Ord. 115323 § 4, 1990: Ord. 108200 § 2(11.40.220), 1979.)

11.40.240 Walking in roadway.

Where sidewalks are not provided any pedestrian moving along and upon a street shall, when practicable, move only on the left side of the roadway or its shoulder facing traffic which may approach from the opposite direction and upon meeting an oncoming vehicle shall move clear of the roadway. (Ord. 115323 § 5, 1990: Ord. 108200 § 2(11.40.240), 1979.)

11.40.250 Playing in streets.

No person upon roller skates, or riding in or by means of any coaster, skateboard, toy vehicle or similar device, shall go upon the roadway of any arterial street or transit coach route, except while crossing such street at a crosswalk; or engage in any sport, amusement or exercise or play in the roadway of any street. Every person using a skateboard or rollerskates upon a sidewalk or public path shall yield the right-of-way to any pedestrian thereon.

11.40.340 Pedestrians on bridges.

No pedestrian shall enter or remain upon any bridge or approach thereto beyond a bridge signal gate after a bridge operation signal indication has been given, or enter or remain upon any bridge beyond a barrier indicating a bridge is closed to through traffic. (UVC 11-513-1971) (Ord. 108200 § 2(11.40.340), 1979.)

11.40.360 Pedestrians at railroad grade crossings.

11.40.370 Standing or walking on stationary rails prohibited.

No person operating a bicycle shall suddenly enter a crosswalk into the path of a vehicle which is so close that the driver cannot yield safely. (Ord. 108200 § 2(11.44.100), 1979.)

11.44.120 Riding on sidewalk or public path.

Every person operating a bicycle upon any sidewalk or public path shall operate the same in a careful and prudent manner and at a rate of speed no greater than is reasonable and proper under the conditions existing at the point of operation, taking into account the amount and character of pedestrian traffic, grade and width of sidewalk or public path, and condition of surface, and shall obey all traffic-control devices. Every person operating a bicycle upon a sidewalk or public path shall yield the right-of-way to any pedestrian thereon, and shall give an audible signal before overtaking and passing any pedestrian.

11.44.140 Hand signals.

- A. All required hand signals shall be given in the following manner:

A lamp emitting a red light visible from a distance of five hundred feet (500') to the rear may be used in addition to the red reflector. (RCW 46.61.780(1)) (Ord. 108200 § 2(11.44.160), 1979.)

11.44.200 Brakes.


11.46.010 Areas of operation.

- Except as otherwise provided in this chapter, gas motorized foot scooters may be operated on roadways, shoulders, and alleys, but not on sidewalks, bicycle lanes, or public paths.
- B. Except as otherwise provided in this chapter, EPAMDs and electric motorized foot scooters may be operated on roadways, shoulders, sidewalks, and alleys, but not on bicycle lanes, or public paths. Where an arterial street contains a sidewalk, EPAMDs shall be operated only upon the sidewalk and not upon the roadway or shoulder. An EPAMD shall not be operated upon the roadway or shoulder of any highway where the speed limit is greater than 35 miles per hour.

 the Office of the City Clerk C. EPAMDs and motorized foot scooters are subject to limitations imposed by SMC Title 18 on the use of motorized vehicles in parks.

Subject to the limitations on areas of operation contained in Section 11.46.010, the following rules of operation apply to EPAMDs and/or motorized foot scooters, as indicated:

- B. Every motorized foot scooter when in use at anytime from a half hour after sunset to a half hour before sunrise must be equipped with a lamp on the front that emits a white light visible at a distance of at least five hundred (500) feet to the front and with a red reflector on the rear of a type approved by the State Patrol that shall be visible from all distances up to six hundred (600) feet to the rear when directly in front of lawful lower beams of head lamps on a motor vehicle.
- C. No person under sixteen years of age may operate a gas motorized foot scooter on a roadway, shoulder or alley.
- Except as otherwise provided in this chapter, operators of gas motorized foot scooters shall have the same rights and duties as operators of bicycles.
 - E. Speed-limited zones for EPAMDs and electric motorized foot scooters.
 - (1) The Director of the Seattle Department of Transportation (Director) is authorized to designate speed-limited zones for EPAMDs and electric motorized foot scooters.
 - (2) Speed-limited zones shall be those areas where, in the professional judgment of the Director:
 - congested pedestrian or nonmotorized traffic is present; (a)
 - without a speed limit, a significant speed differential would exist between pedestrians or (b) nonmotorized traffic and EPAMD or electric motorized foot scooter traffic, and
 - (c) without a speed limit, the presence of EPAMD or electric motorized foot scooter traffic could endanger public safety.
 - The Director is also authorized, in the professional judgement of the Director, to establish times (3)

- When within a designated speed-limited zone, EPAMDs and electric motorized foot scooters shall not be operated at a speed in excess of five miles per hour upon any sidewalk, crosswalk, or pedestrian zone.
 - F. Except as otherwise provided in this chapter, operators of EPAMDs and electric motorized foot scooters shall have the same rights and duties as:
 - operators of bicycles when upon any portion of a highway except a sidewalk, crosswalk, or (1) pedestrian zone; and

 - At all times, operators of motorized foot scooters and operators of EPAMDs shall yield the right-of-way to pedestrians and human-powered devices and shall give an audible signal before overtaking and passing a pedestrian or human-powered device.
 - H. Any person operating a motorized foot scooter shall wear a protective helmet designed for bicycle safety.
 - I. No motorized foot scooter or EPAMD shall be operated with any passenger or other person in addition to the operator. (Ord. 121518 § 3, 2004.)

11.46.030 Noise.

- Every gas motorized foot scooter shall at all times be equipped with a muffler in good working order and in constant operation to prevent excessive or unusual noise.
- The use of a cutout, bypass, or similar muffler elimination device, is prohibited on any gas В. motorized foot scooter.



 - 4. Visible from a street or alley, and flooding, or intended to flood, or directed across, the roadway of the street or alley with a directed beam, or with diffused light, whether or not the floodlight is shielded against directing its flood beam toward approaching traffic on the street or alley.

A "speed trap" within the meaning of this section, is a particular section of or distance on any street or alley, the length of which has been or is measured off or otherwise designated or determined, and the limits of which are within the vision of any officer or officers who calculate the speed of a vehicle passing through such speed trap by using the lapsed time during which such vehicle travels between the entrance and exit of such speed trap; provided, however, that evidence shall be admissible against any person arrested for violation of any of the provisions of this subtitle, or of any orders, rules or regulations made pursuant thereto regarding speed, if the same is determined by a particular section of or distance on a street, or alley the length of which has been accurately measured off or otherwise designated or determined and the limits of which are controlled by a mechanical, electronic, or other device capable of measuring or recording the speed of a vehicle passing within such limits within an error of not to exceed five (5) percent using the lapsed time during which such vehicle travels between such limits; provided further, that such limits shall not be closer than one-fourth (1/4) mile. (RCW 46.61.470) (Ord. 108200 § 2(11.52.200), 1979.)

11.52.220 Exceeding speed limit evidence of reckless driving.



 - Upon a roadway divided into three (3) marked lanes for traffic under the rules applicable 3. thereon; or
 - 4. Upon a roadway restricted to one (1) way traffic.

 - D. Mandatory Appearance After Charging.
 - 1. A defendant who is charged with a violation of this section shall be required to appear in person before a judicial officer within one (1) judicial day after the arrest if the defendant is served with a citation or complaint at the time of the arrest. The Municipal Court may by local court rule waive the requirement for an appearance within one (1) judicial day if it provides for the appearance at the earliest practicable day following arrest and establishes the method for identifying that day in the rule.
 - 2. A defendant who is charged with a violation of this section and who is not served with a citation or complaint at the time of the incident shall appear in court for arraignment in person as soon as practicable, but in no event later than fourteen (14) days after the next day on which court is in session following the issuance of the citation or the filing of the complaint or information.
 - 3. At the time of an appearance required by this subsection, the court shall determine the necessity of imposing conditions of pretrial release according to the procedures established by court rule for a preliminary appearance or an arraignment.
 - 4. Appearances required by this subsection are mandatory and may not be waived.
 - 5. Failure of the court to comply with the requirements of this subsection shall not be grounds for dismissal of any charge under this section nor the establishment of a constructive date of arraignment for purposes of Criminal Rule for Courts of Limited Jurisdiction 3.3.

Being in physical control of a motor vehicle while intoxicated is a lesser included offense of driving while intoxicated. McGuire v. City of Seattle, 31 Wn.App. 438, 642 P.2d 765 (1982)

Ordinance defining crime of driving while intoxicated as driving with a blood alcohol level of 0.10 or above did not create an unconstitutional presumption that a person with that blood alcohol level is intoxicated. City of Seattle v. Urban, 32 Wn.App. 634, 648

Where defendant, after being advised of his right to have an assigned attorney if he could not afford a retained attorney, was given access to a telephone and a telephone book containing the phone numbers of private attorneys and the public defender, both having 24-hour answering services, and did not request a list of available retained or assigned attorneys nor other means of contacting an attorney, he was not denied access to counsel. 

Editor's Note: The provisions of this ordinance are declared to be separate and severable. The invalidity of any clause, sentence, paragraph, subdivision, section or portion of this ordinance, or the invalidity of the application thereof to any person or circumstance shall not affect the validity of the remainder of this ordinance, or the validity of its application to other persons or circumstances. In the event that a court should declare void any provision of the Municipal Code affected by this ordinance because the alcohol concentration is 0.08 rather than 0.10, then an alcohol concentration of 0.10 rather than 0.08 shall be in full force and effect as though "0.10" appeared everywhere "0.08" appears in the Municipal Code, except in Section 11.56.020 N8, and prosecutions shall be made and shall continue thereunder as if the alcohol concentration was 0.10.

- A person who is convicted of a violation of Subsection 11.56.020 A or B who has no A. prior offense within seven (7) years and whose alcohol concentration was less than 0.15, or for any reason other than the person's refusal to take a test offered pursuant to RCW 46.20.308 there is no test result indicating the person's alcohol concentration, shall be punished by imprisonment for not less than twenty-four (24) consecutive hours nor more than one (1) year and by a fine of not less than Three Hundred Fifty Dollars (\$350) and not more than Five Thousand Dollars (\$5,000). In lieu of the mandatory minimum term of imprisonment required under this subsection, the court may order not less than fifteen (15) days of electronic home monitoring.
- 2. A person who is convicted of a violation of Subsection 11.56.020 A or B who has no prior offense within seven (7) years and whose alcohol concentration was 0.15 or more, or who refused to take a test offered pursuant to RCW 46.20.308, shall be punished by imprisonment for not less than two (2) consecutive days nor more than one (1) year and a fine of not less than Five Hundred Dollars (\$500) nor more than Five Thousand Dollars (\$5,000). In lieu of the mandatory minimum term of imprisonment required under this subsection, the court may order not less than thirty (30) days of electronic home monitoring.
- B. A person who is convicted of a violation of Subsection 11.56.020 A or B who has one (1) prior offense within seven (7) years and whose alcohol concentration was less than 0.15, or for any reason other than the person's refusal to take a test offered pursuant to RCW 46.20.308 there is no test result indicating the person's alcohol concentration, shall be punished by imprisonment for not less than thirty (30) consecutive days nor more than one (1) year, sixty (60) days of electronic home monitoring, and a fine of not less than Five Hundred Dollars (\$500) nor more than Five Thousand Dollars (\$5,000).
- A person who is convicted of a violation of Subsection 11.56.020 A or B who has one (1) prior 2.



offense within seven (7) years and whose alcohol concentration was 0.15 or more, or who refused to take a test offered pursuant to RCW 46.20.308, shall be punished by imprisonment for not less than forty-five (45) consecutive days nor more than one (1) year, ninety (90) days of electronic home monitoring, and a fine of not less than Seven Hundred Fifty Dollars (\$750) nor more than Five Thousand Dollars (\$5,000).

- C. 1. A person who is convicted of a violation of Subsection 11.56.020 A or B who has two (2) or more prior offenses within seven (7) years and whose alcohol concentration was less than 0.15, or for any reason other than the person's refusal to take a test offered pursuant to RCW 46.20.308 there is no test result indicating the person's alcohol concentration, shall be punished by imprisonment for not less than ninety (90) consecutive days nor more than one (1) year, one hundred twenty (120) days of electronic home monitoring, and a fine of not less than One Thousand Dollars (\$1,000) nor more than Five Thousand Dollars (\$5,000).
- A person who is convicted of a violation of Subsection 11.56.020 A or B who has two (2) or more prior offenses within seven (7) years and whose alcohol concentration was 0.15 or more, or who refused to take a test offered pursuant to RCW 46.20.308, shall be punished by imprisonment for not less than one hundred twenty (120) consecutive days nor more than one (1) year, one hundred fifty (150) days of electronic home monitoring, and a fine of not less than One Thousand Five Hundred Dollars (\$1,500) nor more than Five Thousand Dollars (\$5,000).
 - D. "Prior offense" and "within seven (7) years" have the same meaning as in RCW 46.61.5055.
- E. If a person convicted of a violation of Subsection 11.56.020 A or B committed the offense while a passenger under the age of sixteen (16) years was in the vehicle, the court shall order the use of an ignition interlock device under RCW 46.20.720 for not less than sixty (60) days following restoration of the person's license, permit or nonresident driving privilege or, in the case of a person for whom use of such a device is already required under RCW 46.20.720, order the use of such a device for an additional sixty (60) days.
- F. For purposes of sentencing under this section, the judge shall determine, based on a preponderance of the evidence, the number of prior offenses within seven (7) years the person has, whether the person's alcohol concentration was less than 0.15 or 0.15 or more, whether the person refused to take a test offered pursuant to RCW 46.20.308 or whether for any reason other than the person's refusal to take a test offered pursuant to RCW 46.20.308 there is no test result indicating the person's alcohol concentration and whether the person committed the offense while a passenger under the age of sixteen (16) years was in the vehicle. The prosecutor or the court may obtain an abstract of the person's driving record, which shall be prima facie evidence of the person's prior offenses.
- G. Unless the judge finds the person to be indigent, the mandatory minimum fine shall not be suspended or deferred. Neither the mandatory minimum jail sentence nor the mandatory minimum period of electronic home monitoring shall be suspended or deferred unless the judge finds that the imposition of this sentence will pose a substantial risk to the defendant's physical or mental well-being. Whenever the mandatory minimum sentence is suspended or deferred, the judge must state, in writing, the reason for granting the suspension or deferral and the facts upon which the suspension or deferral is based. Whenever the court sentences an offender to a period of electronic home monitoring, the court may also require the offender's home electronic monitoring device to include an alcohol detection breathalyzer and may restrict the amount of alcohol

- H. A person convicted of a violation of Subsection 11.56.020 A or B of this section is subject to the alcohol assessment and treatment provisions of RCW 46.61.5056.

In addition to any nonsuspendable and nondeferrable jail sentence required by this subsection, whenever the court imposes less than one (1) year in jail, the court shall also suspend but shall not defer a period of confinement for a period not exceeding five (5) years. The court shall impose conditions of probation that include: (1) not driving a motor vehicle within this state without a valid license to drive and proof of financial responsibility for the future; (2) not driving a motor vehicle within this state while having an alcohol concentration of 0.08 or more within two (2) hours after driving; and (3) not refusing to submit to a test of his or her breath or blood to determine alcohol concentration upon request of a law enforcement officer who has probable cause to believe the person was driving or was in actual physical control of a motor vehicle within this state while under the influence of intoxicating liquor. For each violation of mandatory conditions of probation (1), (2), or (3) of this subsection, the court shall order the convicted person to be confined for thirty (30) days, which shall not be suspended or deferred. For each incident involving a violation of a mandatory condition of probation imposed under this subsection, the court shall suspend the person's license, permit or privilege to drive for thirty (30) days or, if the person's license, permit or privilege to drive already is suspended, revoked or denied at the time the finding of probation violation is made, then the suspension, revocation or denial then in effect shall be extended by thirty (30) days. The court shall notify the Washington State Department of Licensing of a person's violation of any mandatory condition of probation imposed under this subsection and the suspension of or extension of the suspension, revocation or denial of a person's license, permit or privilege to drive. The court may impose conditions of probation that include nonrepetition, installation of an ignition interlock device on the probationer's motor vehicle, alcohol or drug treatment, supervised probation, or other conditions that may be appropriate. The sentence may be imposed in whole or in part upon violation of a condition of probation during the suspension period.
- J. In addition to the penalties set forth in this section, a fee of One Hundred Twenty-five Dollars (\$125) shall be assessed to a person who is either convicted, sentenced to a lesser charge or given a deferred prosecution as a result of an arrest for violating Subsection 11.56.020 A or B, RCW 46.61.520 or RCW 46.61.522. - Any person or persons who wilfully compare or contest relative speeds by operation of one (1) or more motor vehicles is guilty of reckless driving, whether or not such speed is in excess of the maximum speed prescribed by law; provided however, that any comparison or contest of the accuracy with which motor vehicles may be operated in terms of relative speeds not in excess of the posted maximum speed does not constitute reckless driving.



11.56.130 Reckless endangerment of roadway workers.

- A. A person is guilty of reckless endangerment of roadway workers if he or she:
- 1. Drives a vehicle in a roadway construction zone in such a manner as to endanger or be likely to endanger any persons or property; or
- 2. Removes, evades, or intentionally strikes a traffic safety device or a traffic control device.
- В. Reckless endangerment of roadway workers is a gross misdemeanor. (RCW 46.61.527(4)) (Ord. 119011 § 17, 1998.)

11.56.320 Driving while license is suspended or revoked.

- It is unlawful for any person to drive a motor vehicle within the City while that person is in a suspended or revoked status or when his or her privilege to drive is suspended or revoked in this or any other state.
- B. A person found to be an habitual offender under Chapter 46.65 RCW, who violates this section while an order of revocation issued under Chapter 46.65 RCW prohibiting such operation is in effect, is guilty of driving while license suspended or revoked in the first degree, a gross misdemeanor. Upon the first such

conviction, the person shall be punished by imprisonment for not less than ten (10) days. U

conviction, the person shall be punished by imprisonment for not less than ten (10) days. Upon the second conviction, the person shall be punished by imprisonment for not less than ninety (90) days. Upon the third or subsequent conviction, the person shall be punished by imprisonment for not less than one hundred eighty (180) days. If the person is also convicted of the offense defined in Section 11.56.020 A or Section 11.56.020 B, when both convictions arise from the same event, the minimum sentence of confinement shall be not less than ninety (90) days. The minimum sentence of confinement required shall not be suspended or deferred.

- C. A person who violates this section while an order of suspension or revocation prohibiting such operation is in effect and while the person is not eligible to reinstate his or her driver's license or driving privilege, other than for a suspension for the reasons described in subsection D of this section, is guilty of driving while license suspended or revoked in the second degree, a gross misdemeanor. This subsection applies when a person's driver's license or driving privilege has been suspended or revoked by reason of:
 - 1. A conviction of a felony in the commission of which a motor vehicle was used;
 - 2. A previous conviction under this section;
 - 3. A notice received by the Washington Department of Licensing from a court or diversion unit as provided by RCW 46.20.265, relating to a minor who has committed, or who has entered a diversion agreement concerning an offense relating to alcohol, legend drugs, controlled substances, or imitation controlled substances;
 - 4. A conviction relating to the violation of restrictions of an occupational or temporary restricted driver's license;
 - 5. A conviction relating to the operation of a motor vehicle with a suspended or revoked license;
 - 6. A conviction relating to duty in case of injury to or death of a person or damage to an attended vehicle;
 - 7. A conviction relating to attempting to elude pursuing police vehicles;
 - 8. A conviction relating to reckless driving;
 - 9. A conviction relating to a person under the influence of intoxicating liquor or drugs;
 - 10. A conviction relating to vehicular homicide;
 - 11. A conviction relating to vehicular assault;
 - 12. A conviction relating to reckless endangerment of roadway workers;
 - 13. A conviction relating to racing of vehicles on highways;
 - 14. A conviction relating to leaving children in an unattended vehicle with motor running;

- A conviction relating to theft of motor vehicle fuel; 15.
- A conviction relating to attempting, aiding, abetting, coercing, and committing crimes; or
- An administrative action taken by the Washington Department of Licensing under Chapter 46.20 RCW.
 - D. A person who violates this section when his or her driver's license or driving privilege is, at the time of the violation, suspended or revoked solely because (1) the person must furnish proof of satisfactory progress in a required alcoholism or drug treatment program, (2) the person must furnish proof of financial responsibility for the future as provided by Chapter 46.29 RCW, (3) the person has failed to comply with the provisions of Chapter 46.29 RCW relating to uninsured accidents, (4) the person has committed an offense in another state that, if committed in this state, would not be grounds for the suspension or revocation of the person's driver's license, (5) the person has been suspended or revoked by reason of one (1) or more of the items listed in subsection C of this section, but was eligible to reinstate his or her driver's license or driving privilege at the time of the violation, (6) the person has failed to respond to a notice of traffic infraction, failed to appear at a requested hearing, violated a written promise to appear in court or has failed to comply with the terms of a notice of traffic infraction or citation, as provided in RCW 46.20.289, Section 1, (7) the person has received traffic citations or notices of traffic infraction that have resulted in a suspension under RCW 46.20.267 relating to intermediate drivers' licenses, or any combination of (1) through (7), is guilty of driving while license suspended or revoked in the third degree, a misdemeanor.

His refusal to take a breath test after an earlier stop had put him on notice. Seattle v. Foley, 56 Wn.App. 485, 784 P.2d 176 (1990).

11.56.340 Operation of motor vehicle prohibited while license is suspended or revoked.

No person, whose driver's license or right or privilege to operate a motor vehicle has been suspended or revoked as provided in RCW Title 46, shall operate a motor vehicle on any street, alley or way open to the public in the City under a license, permit or registration certificate issued by any jurisdiction or otherwise during such suspension or after such revocation until a new license is obtained when and as permitted under RCW Chapter 46.20. (RCW 46.20.420) (Ord. 108200 § 2(11.56.340), 1979.)

11.56.350 Operation of motor vehicle without required ignition interlock or other biological or technical device.

No person whose driving record includes a notation, pursuant to RCW 46.20.740, that the person may operate only a motor vehicle equipped with an ignition interlock device shall operate a motor vehicle that is not so equipped. Violation of this section is a misdemeanor. (RCW 46.20.740) (Ord. 121525 § 12, 2004; Ord. 120481, § 7, 2001; Ord. 119189 § 7, 1998.)

11.56.355 Assisting another in starting and operating motor vehicle in violation of court order regarding ignition interlock or other biological or technical device.



- A. No person shall knowingly assist another person who is restricted to the use of a motor vehicle equipped with an ignition interlock or other biological or technical device to start and operate such a motor vehicle in violation of a court order regarding such device.
 - B. This section shall not apply to the starting of a motor vehicle or the request to start a motor vehicle equipped with an ignition interlock or other biological or technical device if done for the purpose of safety or mechanical repair of the device or the vehicle and the person subject to the court order does not operate the vehicle.
 - C. "Knowingly" has the same meaning as in Section 12A.04.030 B.
 - D. Violation of this section is a gross misdemeanor. (RCW 46.20.750) (Ord. 119189 § 8, 1998.)

11.56.360 Driving with a suspended vehicle registration.

- A. No person shall operate a motor vehicle on any street, alley or way open to the public while the vehicle registration is suspended as provided in RCW Title 46.
- B. Any person convicted of a violation of subsection A of this section shall be punished by imprisonment for not less than two (2) days nor more than five (5) days, or a fine of not less than One Hundred Dollars (\$100) nor more than Five Hundred Dollars (\$500), or by both such imprisonment and fine. (Ord. 115757 § 4, 1991: Ord. 110967 § 13, 1983.)

11.56.410 Hit and run--Definitions.


- A. "Accident" means a collision between two (2) or more vehicles, or between a vehicle and property, or between a vehicle and a person. "Accident" also means the operation of a vehicle in such a manner as to cause the driver of another vehicle, or a pedestrian, or a person on a device propelled by human power to take evasive action which results in damage to property or injury to a person.
- B. "Device propelled by human power" includes but is not limited to a scooter, skateboard, tricycle, wagon, and any other similar device.

11.56.420 Hit and run (attended)--Duty in case of accident with occupied vehicle.

The operator of any vehicle involved in an accident resulting in damage to a vehicle which is operated or occupied by any person shall do the following:

- A. Move the vehicle as soon as possible off the roadway or freeway main lanes, shoulders, medians, and adjacent areas to a location on an exit ramp shoulder, the frontage road, the nearest suitable cross street, or other suitable location and remain at the suitable location until he or she has done the following; and
- B. Give his or her name, address, insurance company, insurance policy number, and vehicle license number, and exhibit his or her vehicle operator's license to the operator or any occupant of the other vehicle;

C. Render to any person involved in such accident reasonable assistance including the carrying or the making of arrangements for the carrying of such person to a physician or hospital for medical treatment if it is apparent that such treatment may be necessary or if such carrying is requested by the person involved in the accident or on his or her behalf. Under no circumstances shall the rendering of assistance or other compliance with the provisions of this section be evidence of the liability of any operator for such accident. (Ord. 120885 § 6, 2002; Ord. 111861 § 10, 1984.)

Cases: This section was upheld as valid against a challenge claiming it conflicted with RCW 46.52.020. Seattle v. Wandler, 60 Wn.App. 309, 803 P.2d 833 (1991).

11.56.430 Hit and run (unattended vehicle)--Duty in case of accident with unattended vehicle.

The operator of any vehicle involved in an accident resulting in damage to another vehicle which is unattended shall do the following:

- A. Immediately stop such vehicle at the scene of the accident, or as close thereto as possible; and
 - B. Then and there:
 - 1. Locate and notify the operator or owner of such vehicle of the name and address of the operator and of the owner of the vehicle striking the unattended vehicle; or
- 2. Leave in a conspicuous place in the vehicle struck a written notice, giving the name and address of the operator and of the owner of the vehicle striking such other vehicle. (Ord. 111861 § 11, 1984.)

11.56.440 Hit and run (property damage)--Duty in case of accident with property.

The operator of any vehicle involved in an accident resulting in damage to property other than a vehicle shall do the following:

- A. Immediately stop such vehicle at the scene of the collision, or as close thereto as possible; and
- B. Then and there:
- 1. Locate and notify the owner or person in charge of such property of the name and address of the operator and of the owner of the vehicle striking the property; or
- 2. Leave in a conspicuous place upon the property struck a written notice, giving the name and address of the operator and of the owner of the vehicle so striking the property. (Ord. 111861 § 12, 1984.)

11.56.445 Hit and run (by unattended vehicle)--Duty in case of accident caused by unattended vehicle.

The last operator of any unattended vehicle which collides with any other vehicle or other property shall do the following:

- A. Immediately take reasonable steps to locate and notify the owner or person in charge of such property of such fact and of the name and address of the last operator and the owner of the vehicle striking such property; or
- Immediately leave in a conspicuous place upon the property struck a written notice, giving the name and address of the operator and of the owner of the vehicle so striking the property; and
- Make report of such collision as in the case of other collisions upon the streets and alleys of the City. (Ord. 112466 § 5, 1985.)

11.56.450 Hit and run (pedestrian or person on a device propelled by human power)-- Duty in case of accident with pedestrian or device propelled by human power.

The operator of any vehicle involved in an accident with a pedestrian, or with a device propelled by human power operated by any person, or on which a person is seated, shall do the following:

- Immediately stop such vehicle at the scene of such accident, or as close thereto as possible, and forthwith return to and remain at the scene of such accident until he has done the following;
- B. Give his or her name, address, insurance company, insurance policy number, and vehicle license number, and exhibit his or her operator's license to the pedestrian or person operating the device propelled by human power, or, if they are unconscious or incompetent, to another person whom he or she reasonably believes is acting on their behalf; and
- Render to any person involved in such accident reasonable assistance including the carrying or the making of arrangements for the carrying of such person to a physician or hospital for medical treatment if it is apparent that such treatment is necessary or if such carrying is requested by the person involved in the accident or on his or her behalf. Under no circumstances shall the rendering of assistance or other compliance with the provisions of this section be evidence of the liability of any operator for such accident. (Ord. 120885 § 7, 2002; Ord. 111861 § 13, 1984.)

11.56.460 Hit and run--Duty when specified persons are not in condition to receive information.

In the event that none of the persons specified in Sections 11.56.420, 11.56.430, 11.56.440, and 11.56.450 are in condition to receive the information to which they otherwise would be entitled, and no peace officer is present, the person with a duty to provide such information, after fulfilling all other requirements of the applicable provisions of this code, shall forthwith report such accident to the nearest office of a duly authorized police authority and submit thereto the information specified in the applicable ordinance. (Ord. 111861 § 14, 1984.)



11.57.080 Passenger interfering.

No operator shall carry any person, nor shall any person ride, in a position that will interfere with the operation or control of a motorcycle or the view of the operator. (UVC 11-1302(d)) (Ord. 108200 § 2(11.57.080), 1979.)

11.57.100 Mirrors.

- No person shall operate a motorcycle or motor-driven cycle not equipped with mirrors on the left and right sides of the handlebars which shall be so located as to give the operator a complete view of the street or alley for a distance of at least two hundred (200) feet to the rear of the motorcycle or motor-driven cycle.
- Mirrors shall not be required on any motorcycle or motor-driven cycle over twenty-five (25) years old originally manufactured without mirrors and which has been restored to its original condition and

1. Editor's Note: RCW 46.61.611 was amended in 1999, changing the maximum handlebar height to thirty (30) inches.

11.57.180 Both feet not to be on same side of motorcycle.

No person shall ride a motorcycle in such a position that both feet are placed on the same side of the motorcycle. (RCW 46.61.612) (Ord. 108200 § 2(11.57.180), 1979.)

11.57.200 Exemption for motorcycles in parades.

Sections 11.57.020 through 11.57.180 shall not apply to the operation of motorcycles as part of a parade for which a permit has been obtained pursuant to Section 11.25.020 of this subtitle. (RCW 46.61.613) (Ord. 108200 § 2(11.57.200), 1979.)

11.57.220 Lighted lamps required.

Every motorcycle and every motor-driven cycle shall have its head and tail lamps lighted whenever such vehicle is in motion upon a street or alley. (RCW 46.37.020) (Ord. 108200 § 2(11.57.220), 1979.)

11.57.240 Headlamps.

Every motorcycle and every motor-driven cycle shall be equipped with at least one (1) and not more than two (2) headlamps which shall comply with the requirements and limitations of this chapter. (RCW 46.37.040(2))

11.57.260 Height of headlamps.

- 11.58.005 Operating motor vehicle in a negligent manner--Penalty.
 - A person is guilty of negligent driving in the first degree if he or she operates a motor vehicle in a manner that is both negligent and endangers or is likely to endanger any person or property, and exhibits the effects of having consumed liquor or an illegal drug.
 - It is an affirmative defense to negligent driving in the first degree by means of exhibiting the effects of having consumed an illegal drug, that must be proved by the defendant by a preponderance of the evidence, that the driver has a valid prescription for the drug consumed and has been consuming it according to the prescription directions and warnings.
 - Negligent driving in the first degree is a misdemeanor.
 - A person is guilty of negligent driving in the second degree if, under circumstances not amounting to negligent driving in the first degree, he or she operates a motor vehicle in a manner that is both negligent and endangers or is likely to endanger any person or property.
 - 2. It is an affirmative defense to negligent driving in the second degree, that must be proved by the defendant by a preponderance of the evidence, that the driver was operating the motor vehicle on private property with the consent of the owner in a manner consistent with the owner's consent.
 - 3. Negligent driving in the second degree is a traffic infraction and is subject to a penalty of Two Hundred Fifty Dollars (\$250.00).
 - C. For the purposes of this section:
 - 1. "Negligent" means the failure to exercise ordinary care, and is the doing of some act that a reasonably careful person would not do under the same or similar circumstances or the failure to do something that a reasonably careful person would do under the same or similar circumstances.
 - 2. "Exhibiting the effects of having consumed liquor" means that the person has the odor of liquor on his or her breath, or that by speech, manner, appearance, behavior, lack of coordination, or otherwise exhibits that he or she has consumed liquor, and either:
 - Is in possession of or in close proximity to a container that has or recently had liquor in it; a. or
 - Is shown by other evidence to have recently consumed liquor. b.
 - 3. "Exhibiting the effects of having consumed an illegal drug" means that a person by speech, manner, appearance, behavior, lack of coordination, or otherwise exhibits that he or she has consumed an illegal drug, and either:

- "Illegal drug" means a controlled substance under RCW 69.50 for which the driver does not have a valid prescription or that is not being consumed in accordance with the prescription directions and warnings, or a legend drug under RCW Chapter 69.41 for which the driver does not have a valid prescription or that is not being consumed in accordance with the prescription directions and warnings.
- Any act prohibited by this section that also constitutes a crime under any other law of this City may be the basis of prosecution under such other law notwithstanding that it may also be the basis for prosecution under this section. (RCW 46.61.525)

11.58.008 Inattention.

- A. No person shall operate a vehicle in an inattentive manner over and along the streets, alleys or ways open to the public of this City. For the purpose of this section, "inattentive manner" means such a manner so as to fail to maintain a careful lookout for persons or property in the direction of travel.
- The offense of operating a vehicle in an inattentive manner shall be considered to be a lesser offense than, but included in, the offense of operating a vehicle in a negligent manner, and any person charged with operating a vehicle in a negligent manner may be convicted of the lesser offense of operating a vehicle in an inattentive manner.



11.58.010 Operating with gears in neutral or clutch disengaged.

- The driver of any motor vehicle when traveling upon a downgrade shall not coast with the gears Α. of such vehicle in neutral.
- No driver shall coast with the clutch disengaged when traveling upon a downgrade. This section shall not prevent the proper shifting of gears or the towing of a disabled vehicle. (RCW 46.61.630) (Ord. 108200 § 2(11.58.010), 1979.)

11.58.015 Use of compression brakes.

- No person shall use compression brakes while operating a motor vehicle upon any street where signs prohibit the use of compression brakes, except as such use is necessary in an emergency.



No person shall enter, leave, or open the door of a motor vehicle on the side adjacent to moving traffic unless and until it is reasonably safe to do so, and can be done without interfering with the movement of other traffic, nor shall any person leave a door open on the side of a vehicle adjacent to moving traffic for a period of time longer than necessary to load or unload passengers. 

- 1. If the child is less than six (6) years old and/or sixty (60) pounds and the passenger seating position equipped with a safety belt system allows sufficient space for installation, then the child will be restrained in a child restraint system that complies with standards of the United States Department of Transportation and that is secured in the vehicle in accordance with instructions of the manufacturer of the child restraint system:
 - 2. If the child is less than one (1) year of age or weighs less than twenty (20) pounds, the child shall be properly restrained in a rear-facing infant seat;
 - 3. If the child is more than one (1) but less than four (4) years of age or weighs at least twenty (20) pounds but less than forty (40) pounds, the child shall be properly restrained in a forward facing child safety seat restraint system;
 - 4. If the child is at least four (4) but less than six (6) years of age or weighs at least forty (40) pounds but less than sixty (60) pounds, the child shall be properly restrained in a child booster seat;
 - 5. If the child is six (6) years of age or older or weighs more than sixty (60) pounds, the child shall be properly restrained with the motor vehicle's safety belt properly adjusted and fastened around the child's body or an appropriately fitting booster seat; and
 - 6. Enforcement of 1 through 5 of this subsection is subject to a visual inspection by law enforcement to determine if the child restraint system in use is appropriate for the child's individual height, weight, and age. The visual inspection for usage of a forward facing child safety seat must ensure that the seat in use is equipped with a four-point shoulder harness system. The visual inspection for usage of a booster seat must ensure that the seat belt properly fits across the child's lap and the shoulder strap crosses the center of the child's chest. The visual inspection for the usage of a seat belt by a child must ensure that the lap belt properly fits across the child's lap and the shoulder strap crosses the center of the child's chest. In determining violations, consideration to the above criteria must be given in conjunction with the provisions of 1 through 5 of this subsection. The driver of a vehicle transporting a child who is under the age of six (6) years old or weighs less than sixty (60) pounds, when the vehicle is equipped with a passenger side air bag supplemental restraint system, and the air bag system is activated, shall transport the child in the back seat positions in the vehicle where it is practical to do so.
 - B. A person violating this section may be issued a notice of traffic infraction under Chapter 11.31.





No liability shall attach to the City by reason of any damage or injury to persons or property by reason of the existence of any structure over or across any street or alley where the vertical clearance above the roadway is fourteen (14) feet, or more, or where such vertical clearance is less than fourteen (14) feet if impaired clearance signs are erected and maintained on the side of any such street or alley in a conspicuous location at a distance of not less than two hundred feet (200') and not more than three hundred feet (300'). If any structure over or across any street or alley is not owned by the City, it shall be the duty of the owner thereof when billed therefor to reimburse the City for the actual cost of erecting and maintaining such impaired clearance signs.(RCW 46.44.020) (Ord. 112092 § 7, 1984: Ord. 108200 § 2(11.60.060), 1979.)

11.60.070 Hitting structure with impaired clearance.

No person shall operate a vehicle in a manner that allows the vehicle to strike any structure over or across any street or alley where impaired clearance signs are erected and maintained. (Ord. 108200 § 2(11.60.070), 1979.)

- "Stinger steered" as used in this section means a tractor and semitrailer combination that has the coupling connecting the semitrailer to the tractor located to the rear of the centerline of the rear axle of the tractor.
- F. These length limitations do not apply to vehicles transporting poles, pipe, machinery, or other objects of a structural nature that cannot be dismembered and operated by a public utility when required for emergency repair of public service facilities or properties, but, in respect to night transportation every such vehicle and load thereon shall be equipped with a sufficient number of clearance lamps on both sides and marker lamps upon the extreme ends of any projecting load to clearly mark the dimensions of the load.

It shall be a violation to operate upon the streets and alleys, any single unit vehicle, supported upon three (3) axles or more with a gross weight including load in excess of forty thousand (40,000) pounds or any combination of vehicles having a gross weight in excess of eighty thousand (80,000) pounds without first obtaining an additional tonnage permit as provided for in Section 11.23.290.
- It shall be a violation to operate any vehicle upon the streets and alleys equipped with two (2) axles spaced less than seven (7) feet apart, unless the two (2) axles are so constructed and mounted in such a manner as to provide oscillation between the two (2) axles and that either one (1) of the two (2) axles will not at any one time carry more than the maximum gross weight allowed for one (1) axle specified in this section. (RCW 46.44.041)



For the purpose of this section, the width of tire in case of solid rubber or hollow-center cushion tires, so long as the use thereof may be permitted by the law, shall be measured between the flanges of the rim. For the purpose of this section, the width of tires in case of pneumatic tires shall be the maximum overall normal inflated width as stipulated by the manufacturer when inflated to the pressure specified and without load thereon. (RCW 46.44.042)

In addition to the limitations of Section 11.60.370, if the gross axle weight is not more than five hundred (500) pounds in excess of the maximum gross axle weight for one (1) axle, and if the gross weight of two (2) axles spaced less than seven feet (7') apart is not more than one thousand (1,000) pounds in excess of the maximum gross weight for two (2) axles spaced less than seven feet (7') apart, and if the gross weight of any group of axles is not more than one thousand five hundred (1,500) pounds in excess of the maximum gross weight for any group of axles according to the wheelbase spacing of the group of axles as shown in the maximum gross load table of Section 11.60.370 and if the gross weight of a two (2) axle vehicle is not more than one thousand (1,000) pounds in excess of the legal gross weight for such two (2) axle vehicle, and if the gross weight of a three (3) axle vehicle is not more than one thousand five hundred (1,500) pounds in excess of the maximum legal gross weight for such three (3) axle vehicle, and if the maximum gross weight of the combination of vehicles is not more than two thousand pounds (2,000) in excess of the maximum legal gross weight of the combination of vehicles, the arresting officer may, within his discretion, permit the operator to proceed with his vehicle or vehicles in combination without penalty. For the purposes of determining gross weights the actual scale weight taken by arresting officer shall be prima facie evidence of such total gross weight. (RCW 46.44.105)



When such operator is not the owner of such vehicle, object or contrivance but is so operating or moving the same with the express or implied permission of the owner thereof, then the owner and the operator shall be jointly and severally liable for any such damage. 

Major Truck Streets are identified on Exhibit 11.62.060 A.¹

No person shall operate a vehicle except authorized buses or stages over eight feet (8') in width, over twenty-four feet (24') in length, or over twenty-four thousand (24,000) pounds gross weight in the downtown traffic-control zone between the hours of four p.m. and six p.m. without obtaining a permit for such operation as provided in Sections 11.23.080 and 11.23.100, except as provided in Section 11.62.130. No person shall operate a truck or truck tractor and semitrailer over eight feet (8') in width, over thirty feet (30') in length, or over thirty-two thousand (32,000) pounds gross weight, or a motor vehicle with a trailer attached, except authorized buses or stages, on the following arterial streets on any weekday during the hours indicated without a permit for such operation as provided in Sections 11.23.080 and 11.23.100, except as provided in Section 11.62.130:

The peace officer authorizing such parked vehicle to be moved shall affix a notice in writing to the vehicle on which shall be noted the location from which the vehicle has been moved and the location to which the vehicle has been moved and the reason for the move. Such tow shall be at the expense and liability of the person, agency, or utility making the request. The Police Department shall maintain a record of this information.

A railroad company shall provide a flagger on the ground, or a crew member on a locomotive or railroad car, one (1) of whose duties shall be to look out for and warn the public of an approaching locomotive and/or railroad car(s) whenever the railroad tracks occupy or cross an improved public place at grade where there are no automatic crossing gates (hereinafter "unprotected crossing"), and:



1. Conditions at the unprotected crossing due to weather, traffic, building structures or other temporary or permanent circumstances impair the train operator's ability to see traffic approaching the unprotected crossing or the ability of approaching traffic operators to see the

locomotive and/or railroad car(s); or

- 2. The cab end of the locomotive, i.e., the location of the engineer and controls, is not at the forwardmost portion of the train movement on approaching the crossing.
- B. When required by subsection A1 or A2, the railroad's flagger or crew member performing said function shall be a person other than the locomotive engineer. The sole duty of such person at such time shall be to look out for and give warning for the safety of people in or approaching the unprotected crossing whenever the locomotive or lead railroad car approaches within one hundred feet (100') of the unprotected crossing. (Ord. 117239 § 2(part), 1994.)

11.66.035 Sounding of horn or whistle.

No person shall sound the horn or whistle of any locomotive being operated on or along Alaskan Way from King Street to Broad Street, and along the waterfront area west of Elliott Avenue and northward to West Garfield Street, except to prevent accidents not otherwise avoidable. (Ord. 112977 § 1, 1986: Ord. 110686 § 2, 1982.)

11.66.040 Flagger at grade crossings.


No person shall operate or propel a train, in which the forwardmost unit is a car, whether attached to a locomotive or not, on, over, or across any grade crossing of a street or alley that is not protected by automatic railroad signals or gates without having stationed within the dedicated width of such street or alley, a flagger who before and while such crossing operation is under way shall give proper warning for the safety of traffic. 11.66.060 Blocking intersections and crosswalks.

No person who is responsible for the operation of any railroad train or car shall stop the same within an intersection or on a crosswalk except to avoid accident or upon direction of a peace officer. (Ord. 108200 § 2(11.66.060), 1979.)

11.66.080 Blocking use of street when switching.

- A. No person who is responsible for the operation of any railroad train or car which is engaged in switching shall direct the operation of or operate the same in such a manner as to prevent or interfere with the use of any street or alley for purposes of travel, or impede property access, for a period of time longer than four (4) consecutive minutes.
- B. A time interval between successive switching operations shall be provided if the initial switching operation prevents or interferes with the use of the street or alley for purposes of travel or property access, in order to allow the waiting traffic to proceed, provided that the time interval between successive switching operations need not exceed two (2) consecutive minutes.

11.66.120 Locomotive and train speed limit.

No person shall operate any locomotive or train over or across any street at a speed in excess of twenty (20) miles per hour except where:

- 1. The railroad exists on an underpass or overpass; or
- 2. The Federal Rail Safety Act of 1970 (45 U.S.C. Section 434) or rules of the United States thereunder preempt City authority to set a speed limit on mainline tracks;
- 3. Unless preempted, the speed limit shall be forty (40) miles per hour at mainline grade crossings of streets or alleys south of South Spokane Street when signals are in operation.

11.66.180 Fences, barriers and gates--When required.

Every owner, agent, lessee or operator of any railroad, trestle or other property in the City where the same is open or accessible to the public as a route of pedestrian, bicycle, horse, or motor or vehicle travel, either along or across the same, shall be and is required within ten (10) days after receipt of notice from the Director of Transportation, to guard and protect the public properly in the safe use of the same by the erection of fences, barriers, or other means of protection, approved by said Director along the edge of all trestles and at all other exposed and dangerous places in or along such railroads or other property. Every such owner, agent, lessee or operator of any such railroad or other property, upon notice from said Director, shall provide, within the time to be prescribed by said Director, in such official's reasonable discretion, proper lights and signals at crossings and other dangerous places, such lights to be of the same character and to be maintained during the same hours as the streetlights in the district adjacent to such crossing, or other dangerous place, and every agent, lessee or operator of any such railroad is further required, upon notice from the Director of Transportation, to provide within such time as may be specified by such official, in such official's reasonable discretion, gates or barriers

and flaggers at crossings over such tracks as may be designated by said Director.

- A. Any owner, agent, lessee or operator of any railroad, trestle or other property in the City, where the same is open or accessible to the public as a route of pedestrian, bicycle, horse, or motor vehicle travel, either along or across the same, who shall fail to erect proper fences or barriers or other suitable means of protection along the edge of all trestles and at all other exposed or dangerous places within thirty (30) days after notice from the Director of Transportation, or to thereafter maintain the same, or shall fail to provide the required lights and signals at the designated points within the time specified in the notice from said Director, and to thereafter maintain the same, or to provide gates or barriers and flaggers at crossings designated by said Director, within the time specified by said Director's notice, or to thereafter maintain the same, or who shall fail to repair or replace any of the things specified within ten (10) days after notice from said Director so to do, shall forfeit the right to use such track, trestle or other property until protection to the public is afforded as set forth in this chapter. The Director of Transportation shall forthwith proceed to erect such temporary barrier or other suitable means of protection as shall be necessary to prevent all access to any exposed or dangerous places, and to thoroughly protect any unlighted or unguarded crossing.
- B. Any person who shall remove, or attempt to remove, any such barricades, upon a finding thereof, shall be assessed a penalty not exceeding Three Hundred Dollars (\$300.00), and the cost of replacement thereof.
- C. In all cases where such temporary barricades have been erected by Seattle Department of Transportation, as provided in this section, the same shall not be removed until a permit shall be granted by the Director of Transportation for the construction of the required permanent fences or barricades, nor until the required lights, signals, gates or flaggers are provided, nor until the said owner, agent, lessee or operator shall have paid to the City the amount of all costs incurred by the City in the construction and maintenance of such temporary barricades or other suitable means of protection as shall be necessary, as indicated on a statement of such costs furnished by the Director of Transportation.

Nothing in this chapter shall be construed to relieve the owner, agent, lessee or operator of any railroad from any liability for any injury or damage which may be suffered by any person upon any such railroad property, but the safeguards and protection to the public prescribed shall be provided and maintained in addition to all other care and protection required by law: Provided, however, that nothing contained herein shall authorize or be considered as authorizing the use by the public for purposes of travel, of any railroad, trestle or other property, and such use of any trestle or bridge erected for the sole purpose of carrying railroad track by any person, except by express permission of the company or person whose tracks are carried by any such trestle or bridge, is prohibited, and any person using any such trestle or bridge, except as aforesaid, is declared to be a trespasser. The company or person whose tracks are carried by any such bridge or trestle shall keep at each end thereof a white sign bearing in black letters the words "Danger: Walking or driving on this bridge (or trestle) is prohibited by Ordinance of The City of Seattle."

If a railroad company shall violate any section of Sections 11.66.030 through 11.66.120, and its act or omission results in physical injury to the person or property of another, the railroad company shall be guilty of a misdemeanor, and it may be punished therefor by a criminal fine of not more than Five Thousand Dollars (5,000.00).

11.69.020 Designation of traffic congestion area.

- The Chief of Police shall declare all or a portion of a street or way open to the public to be a A. "traffic congestion area" when:
 - 1. Traffic congestion has slowed average vehicle speed to less than one-half the posted speed limit; and
 - 2. The congestion significantly interferes with passage of vehicles being driven to and from locations within the area; and
 - 3. In areas which contain transit routes, buses are or would be substantially delayed; and
 - 4. The congestion is likely to prevent or substantially delay emergency vehicles from responding to locations within the area, or from passing through the area; and
 - 5. The congestion is caused in whole or in substantial part by cruising.
- When a street or way open to the public is designated a traffic congestion area, officers of the Police Department shall post signs identifying it as a traffic congestion area and notifying drivers that passage of a motor vehicle more than one (1) time in the same direction within a four (4) hour period is a violation of law.
- The designation of a street or way open to the public as a traffic congestion area shall remain in effect for a period of four (4) hours, unless withdrawn earlier or extended for additional four (4) hour periods by the Chief of Police.

11.70.100 Parking stalls or spaces.

Where parking stalls or spaces are marked or painted upon the curb and/or pavement of the street, or alley, no person shall park any vehicle so that any part of such vehicle occupies more than one (1) such space, protrudes beyond the markings designating such space, or is in the adjacent area for use for safe maneuvering into and out of a designated parking space.

11.70.120 Right-of-way for parking.

The operator who first begins maneuvering his vehicle into a vacant parking space shall have a prior right-of-way to park in such space and no person shall attempt to deprive him thereof by blocking his access or otherwise. For the purpose of establishing right-of-way in this section it shall be considered proper to back into any but a front-in angle parking space.



If a person is charged with a violation, the person shall not be determined to have committed an infraction if the person produces in court or before the court appearance the special license plate or placard required under this section.
- It is a parking infraction, with a monetary penalty of Two Hundred Fifty Dollars (\$250), for any D. person to make inaccessible the access aisle located next to a space reserved for physically disabled persons.
- The court may not suspend more than one-half (1/2) of any fine imposed under subsection C or D of this section. For a second or subsequent violation of subsection C or D of this section, in addition to a monetary penalty, a violator must complete a minimum of forty (40) hours of either community service for a nonprofit organization that serves the disabled community or persons having disabling diseases or any other community service that may sensitize the violator to the needs and obstacles faced by persons who have disabilities.







- B. On dates with events likely to attract twenty-four thousand (24,000) or more people to Husky Stadium, and after following procedures set forth in SMC Section 11.16.317, the Director of Transportation is authorized to restrict public parking on eligible streets within the zone to vehicles of:
 - 1. Residents of the zone:
 - 2. Owners of businesses in the zone and used for business purposes;
 - 3. Service vehicles of persons having business in the street or used for law enforcement purposes;
- 4. Nonresidents with a handicapped card, decal or special license plate issued pursuant to RCW 46.61.580; and
- 5. Subject to such restrictions as may be established by the Director of Transportation, guests of residents of the zone.
- C. The restrictions on public parking shall be designed to exclude or restrict public parking only to the extent reasonably needed to preserve the capacity of the streets for travel and transportation during the event, to maintain for the residents only the parking needed, and to alleviate hazards of too closely packed parking, such as impairing sightlines or turning at driveways and intersections, blocking in residential vehicles and other unsafe practices. Restrictions on public parking may be placed on certain streets or block segments while others remain open, the restricted streets may be relocated from year to year, and restrictions may be changed from time to time.
- D. The restrictions upon or exclusion of public parking shall only be in effect on the dates with events likely to attract twenty-four thousand (24,000) or more people to Husky Stadium. The dates shall be stated on traffic-control devices in the zone. The restriction shall commence at times set by the Director of Transportation, which shall not be more than three (3) hours before the event is scheduled to begin nor continue more than two hours after the event is over. A restriction shall be given effect although the traffic-control device(s) in the immediate block or street segment may have been removed, damaged or obscured by theft, vandalism, weathering or other cause, if other traffic-control devices in the vicinity or a parking control or peace officer gives general notice to the public of the restriction.



No vehicle shall be driven or moved in any street or alley unless such vehicle is so constructed or loaded, and the load covered or tied down or confined or otherwise secured, as to prevent any of the load from dropping, sifting, leaking, spilling, or depositing any matter by dragging, tracking, or otherwise escaping, except that sand may be dropped for the purpose of securing traction, or water or other substances may be sprinkled on a roadway in the cleaning or maintaining of such roadway by the public authority having jurisdiction. It is unlawful to park or permit to be parked any vehicle in a space controlled by a "pay and display" parking pay station without properly displaying proof of payment as described in this section. For parallel parking on one- and two-way streets, proper display of proof of payment requires affixing the receipt dispensed by the parking pay station inside the vehicle to the front seat's side window nearest the curb in such a manner that the expiration time and date are readily visible from the exterior. For front-and rear-end angle parking, proper display of proof of payment means affixing the receipt to the interior of the side window next to the driver's seat of the vehicle in such a manner that the expiration time and date are readily visible from the exterior. For motorcycles, receipts shall be affixed on the headlight cover. No more than one receipt shall be displayed.

- The prohibitions in this section shall not apply to the act of parking or to the necessary time required to activate the time on the parking meter or to obtain a parking pay station receipt, or as indicated by signposting, to the parking of a vehicle in a residential parking zone in accordance with the provisions of 11.16.315, or to the parking of certified carpool vehicles in accordance with the provisions of Section 11.23.410.



One (1) on each side, one (1) amber side marker lamp and one (1) amber reflector, centrally located with respect to the length of the vehicle: Provided, that a mobile home need not be equipped with such side marker lamp or reflector while operated under the terms of a special permit authorized by RCW 46.44.090.

- E. Pole trailers:
- 1. On each side, one (1) amber side marker lamp at or near the front of the load;
- 2. One (1) amber reflector at or near the front of the load;
- 3. On the rearmost support for the load, one (1) combination marker lamp showing amber to the front and red to the rear and side, mounted to indicate the maximum width of the pole trailer.



Reflectors required to be mounted on the sides of the vehicle shall reflect the required color of light to the sides, and those mounted on the rear shall reflect a red color to the rear.
- B. Front and rear clearance lamps and identification lamps shall be capable of being seen and distinguished under normal atmospheric conditions at the times lights are required at all distances between five hundred feet (500') and fifty feet (50') from the front and rear, respectively, of the vehicle.
- C. Side marker lamps shall be capable of being seen and distinguished under normal atmospheric conditions at the time lights are required at all distances between five hundred feet (500') and fifty feet (50') from the side of the vehicle on which mounted. (RCW 46.37.120) (Ord. 108200 § 2(11.80.120), 1979.)

11.80.140 Certain vehicles to carry flares or other warning devices.

No flare, fuses, electric lantern or cloth warning flag shall be used for the purpose of compliance with the requirements of this section unless such equipment is of a type which has been approved by the State Commission on Equipment and approved by it. Whenever any motor truck, passenger bus, truck tractor over eighty inches (80") in overall width, trailer, semitrailer or pole trailer is disabled upon the traveled portion of any street or alley or the shoulder thereof at any time when lighted lamps are required on vehicles the driver of such vehicle shall display the following warning devices upon the street or alley during the time the vehicle is so disabled on the street or alley except as provided in subsection B:
 - 1. A lighted fusee, a lighted red electric lantern or a portable red emergency reflector shall be immediately placed at the traffic side of the vehicle in the direction of the nearest approaching traffic.
 - 2. As soon thereafter as possible but in any event within the burning period of the fusee (fifteen (15) minutes), the driver shall place three (3) liquid-burning flares (pot torches), or three (3) lighted red electric lanterns or three (3) portable red emergency reflectors on the traveled portion of the street or alley in the following order:
 - a. One (1), approximately one hundred feet (100') from the disabled vehicle in the center of the lane occupied by such vehicle and toward traffic approaching in that lane;
 - b. One (1), approximately one hundred feet (100') in the opposite direction from the disabled vehicle and in the center of the traffic lane occupied by such vehicle;
 - c. One (1) at the traffic side of the disabled vehicle not less than ten feet (10') rearward or forward thereof in the direction of the nearest approaching traffic. If a lighted red electric lantern or a red portable emergency reflector has been placed at the traffic side of the

- One (1) at a distance of approximately two hundred feet (200') from the vehicle in the center of the lane occupied by the stopped vehicle and in the direction of traffic approaching in that lane; one (1) at a distance of approximately one hundred feet (100') from the vehicle, in the center of the lane occupied by the vehicle and in the direction of traffic approaching in that lane; one (1) at the traffic side of the vehicle and approximately ten feet (10') from the vehicle in the direction of the nearest approaching traffic.
- D. Whenever any vehicle of a type referred to in this section is disabled upon the traveled portion of a street or alley or the shoulder thereof at any time when the display of fuses, flares, red electric lanterns or portable red emergency reflectors is not required, the driver of the vehicle shall display two (2) red flags upon the roadway in the lane of traffic occupied by the disabled vehicle, one (1) at a distance of approximately one hundred feet (100') in advance of the vehicle, and one (1) at a distance of approximately one hundred feet (100') to the rear of the vehicle.
- Whenever any motor vehicle used in the transportation of explosives or any cargo tank truck used for the transportation of any flammable liquid or compressed flammable gas, or any motor vehicle using compressed gas as a fuel, is disabled upon a street or alley at any time or place mentioned in subsection A, the driver of such vehicle shall immediately display the following warning devices: One (1) red electric lantern or portable red emergency reflector placed on the roadway at the traffic side of the vehicle, and two (2) red electric lanterns or portable red reflectors, one (1) placed approximately one hundred feet (100') to the front and one (1) placed approximately one hundred feet (100') to the rear of the disabled vehicle in the center of the traffic lane occupied by such vehicle. Flares, fusees or signals produced by flame shall not be used as warning devices for disabled vehicles of the type mentioned in this paragraph.

11.82.060 Headlamps on motor vehicles.

Every motor vehicle other than a motorcycle or motor-driven cycle shall be equipped with at least two (2) headlamps with at least one (1) on each side of the front of the motor vehicle, which headlamps shall comply with the requirements and limitations set forth in this chapter. (RCW 46.37.040(1)) (Ord. 108200 § 2(11.82.060), 1979.)

11.82.080 Visibility distance.

Whenever requirement is declared as to distance from which certain lamps and devices shall render objects visible or within which such lamps or devices shall be visible, the provisions shall apply a half hour after sunset until a half hour before sunrise and at any other time when due to insufficient light or unfavorable atmospheric conditions, persons and vehicles on the street or alley are not clearly discernible at a distance of five hundred feet ahead (500'), in respect to a vehicle without load when upon a straight level, unlighted street or alley under normal atmospheric conditions. (RCW 46.37.030(1)) (Ord. 108200 § 2(11.82.080), 1979.)

11.82.100 Height of headlamps.

Every headlamp upon every motor vehicle shall be located at a height measured from the center of the headlamp of not more than fifty-four inches (54") nor less than twenty-four inches (24") to be measured as set forth in Section 11.82.120. (RCW 46.37.040(3)) (Ord. 108200 § 2(11.82.100), 1979.)

11.82.120 Mounting height of lamps.

Whenever a requirement in this chapter or Chapter 11.80 is declared as to the mounted height of lamps or devices it shall mean from the center of such lamp or device to the level ground upon which the vehicle stands when such vehicle is without a load. (RCW 46.37.030(2)) (Ord. 108200 § 2(11.82.120), 1979.)

11.82.140 Multiple beam and road-lighting equipment.

Except as hereinafter provided, the headlamps or the auxiliary driving lamp or the auxiliary passing lamp or combination thereof on motor vehicles shall be so arranged that the driver may select at will between distribution of light projected to different elevations and such lamps may be so arranged that such selection can be made automatically subject to the following limitations:

- C. Every new motor vehicle, registered in this state after January 1, 1948, which has multiple-beam road-lighting equipment shall be equipped with a beam indicator, which shall be lighted whenever the uppermost distribution of light from the headlamps is in use, and shall not otherwise be lighted. The indicator shall be so designed and located that when lighted it will be readily visible without glare to the driver of the vehicle so equipped. 11.82.160 Lighting equipment on motor-driven cycles.

The headlamp or headlamps upon every motor-driven cycle may be the single-beam or multiple-beam type but in either event shall comply with the requirements and limitations as follows:

- A. Every headlamp or headlamps on a motor-driven cycle shall be of a sufficient intensity to reveal a person or a vehicle at a distance of not less than one hundred feet (100') when the motor-driven cycle is operating at any speed less than twenty-five (25) miles per hour and at a distance of not less than two hundred feet (200') when the motor-driven cycle is operated at a speed of twenty-five (25) or more miles per hour, and at a distance of not less than three hundred feet (300') when the motor-driven cycle is operated at a speed of thirty-five (35) or more miles per hour.
- B. In the event the motor-driven cycle is equipped with a multiple-beam headlamp or headlamps the upper beam shall meet the minimum requirements set forth above and shall not exceed the limitations set forth in Section 11.82.140 A and the lowermost beam shall meet the requirements applicable to a lowermost distribution of light as set forth in Section 11.82.140 B.
- C. In the event the motor-driven cycle is equipped with a single-beam lamp or lamps, the lamp or lamps shall be so aimed that when the vehicle is loaded none of the high-intensity portion of light, at a distance of twenty-five feet (25') ahead, shall project higher than the level of the center of the lamp from which it comes. (RCW 46.37.250)

11.82.180 Taillamps.

Every motor vehicle, trailer, semitrailer, and pole trailer, and any other vehicle which is being drawn at the end of a combination of vehicles, shall be equipped with at least two (2) taillamps mounted on the rear, which when lighted as required in Section 11.82.040 shall emit a red light plainly visible from a distance of one thousand feet (1,000') to the rear, except that passenger cars manufactured or assembled prior to January 1, 1939, and motorcycles and motor-driven cycles, shall have at least one (1) taillamp. On a combination of vehicles only the taillamps on the rearmost vehicle need actually be seen from the distance specified. On vehicles equipped with more than one (1) taillamp, the lamps shall be mounted on the same level and as widely

11.82.200 Taillamp height.

Every taillamp upon every vehicle shall be located at a height of not more than seventy-two inches (72") nor less than twenty inches (20"). (RCW 46.37.050(2)) complete text, graphics, (Ord. 108200 § 2(11.82.200), 1979.)

11.82.220 License plate lamp.

Either a taillamp or a separate lamp shall be so constructed and placed as to illuminate with a white light the rear license plate and render it clearly legible from a distance of fifty feet (50') to the rear. Any taillamp or taillamps, together with any separate lamp or lamps for illuminating the rear license plate, shall be so wired as to be lighted whenever the headlamps or auxiliary driving lamps are lighted. 11.82.240 Lamps, reflectors, and flags on projecting load.

Whenever the load on any vehicle extends to the rear four feet (4') or more beyond the bed or body of such vehicle there shall be displayed at the extreme rear end of the load, at the times specified in Section 11.82.040, two (2) red lamps, visible from a distance of at least five hundred feet (500') to the rear, two (2) red reflectors visible at night from all distances within six hundred feet (600') to one hundred feet (100') to the rear when directly in front of lawful lower beams of headlamps, and located so as to indicate maximum width, and on each side one (1) red lamp, visible from a distance of at least five hundred feet (500') to the side, located so as to indicate maximum overhang. There shall be displayed at all other times on any vehicle having a load which extends beyond its sides or more than four feet (4') beyond its rear, red flags, not less than twelve inches (12") square, marking the extremities of such loads, at each point where a lamp would otherwise be required by Section 11.82.040. 11.82.260 Lamps on overwidth load.

On every overwidth load clearance lamps shall be displayed on the front and on the rear of the load, one (1) at each side during the time specified in Section 11.82.040. 11.82.280 Lamps on overlength load.

Every vehicle, including animal-drawn vehicles and vehicles referred to in Section 11.82.020 C not specifically required by the provisions of Chapters 11.80 and 11.82 to be equipped with lamps, or other lighting devices, shall at all times specified in Section 11.82.040 be equipped with at least one (1) lamp displaying a white light visible from a distance of not less than one thousand feet (1,000') to the front of the vehicle, and shall also be equipped with two (2) lamps displaying a red light visible from a distance of not less than one thousand feet (1,000') to the rear of the vehicle, or as an alternative, one (1) lamp displaying a red light visible from a distance of not less than one thousand feet (1,000') to the rear and two (2) red reflectors visible from all distances of six hundred (600) to one hundred feet (100') to the rear when illuminated by the upper beams of headlamps. (RCW 46.37.170)

After June 1, 1978 every animal-drawn vehicle shall at all times be equipped with a slow-moving vehicle emblem complying with RCW 46.37.160(7). (Ord. 108200 § 2(11.82.340), 1979.)

11.82.360 Stop lamps.

Any vehicle may be equipped and when required under this chapter shall be equipped with a stop lamp or lamps on the rear of the vehicle which shall display a red or amber light, or any shade of color between red and amber, visible from a distance of not less than one hundred feet (100') and on any vehicle manufactured or assembled after January 1, 1964, three hundred feet (300') to the rear in normal sunlight, and which shall be actuated upon application of a service brake, and which may but need not be incorporated with one (1) or more other rear lamps. 11.82.380 Electric turn signals.

Any vehicle may be equipped and when required under Section 11.82.420 shall be equipped with electric turn signals which shall indicate an intention to turn by flashing lights showing to the front and rear of a vehicle or on a combination of vehicles on the side of the vehicle or combination toward which the turn is to be made. 

On a combination of vehicles, only the stop lamps on the rearmost vehicle need actually be seen from the distance specified in Section 11.82.360. (RCW 46.37.070(1)) (Ord. 108200 § 2(11.82.400), 1979.)

11.82.420 Electric turn signals required.

Every motor vehicle, trailer, semitrailer and pole trailer shall be equipped with electric turn-signal lamps meeting the requirements of Section 11.82.380, except that motor vehicles, trailers, semitrailers and pole trailers manufactured or assembled prior to January 1, 1954, and motorcycles and motor-driven cycles need not be equipped with electric turn-signal lamps: Provided, that any motor vehicle in use on a street or alley shall be equipped with a signal lamp or lamps or mechanical signal device when the distance from the center of the top of the steering post to the left outside limit of the body, cab, or load of such motor vehicle exceeds twenty-four inches (24"), or when the distance from the center of the top of the steering post to the rear limit of the body or load thereof exceeds fourteen feet (14'). The latter measurement shall apply to any single vehicle, and also to any combination of vehicles. (RCW 46.37.070(2)) (46.61.310(2)) (Ord. 108200 § 2(11.82.420), 1979.)

11.82.430 Additional lighting equipment.

- Any motor vehicle may be equipped with not more than two (2) side cowl or fender lamps which A. shall emit an amber or white light without glare.
- Any motor vehicle may be equipped with not more than one (1) running-board courtesy lamp on B. each side thereof which shall emit a white or amber light without glare.

11.82.520 Red lights on emergency vehicles, school buses, private carrier buses, police vehicles--Sirens on emergency vehicles--Blue lights authorized on certain police vehicles--Driver's duty to yield and stop.

- Every authorized emergency vehicle shall, in addition to any other equipment and distinctive marking required by this chapter, be equipped with at least one (1) lamp capable of displaying a red light visible from at least five hundred feet (500') in normal sunlight and a siren capable of giving an audible signal.
- Every school bus and private carrier bus shall, in addition to any other equipment and distinctive markings required by this chapter, be equipped with a stop signal upon a background not less than fourteen (14) by eighteen inches (18") displaying the word "stop" in letters of distinctly contrasting colors not less than eight inches (8") high. The stop signal shall be mounted on the left side of the bus just below the window line and adjacent to the driver of the bus. In addition, the sign shall be mounted so that it does not interfere with the driver's vision to the rear when the sign is extended. Every school bus and private carrier bus shall further be equipped with signal lamps mounted as high and as widely spaced laterally as practicable, which shall be capable of displaying to the front two (2) alternately flashing red lights located at the same level and to the rear two (2) alternately flashing red lights located at the same level and these lights shall have sufficient intensity to be visible at five hundred feet (500') in normal sunlight.
- **C**.. A police vehicle, when used as an authorized emergency vehicle, may but need not be equipped with alternately flashing red lights specified herein. A police vehicle may, in addition to or in lieu of the red lights specified in subsection A, be equipped with one (1) or more blue lights.
- The alternately flashing red lights described in subsections B and C shall not be used on any vehicle other than a school bus, a private carrier bus, or an authorized emergency vehicle. The blue lights described in subsection C may only be used on publicly owned police vehicles of a Police Department, Sheriff's office and the Washington State Patrol. 11.82.530 Red lights on emergency tow trucks.

All emergency tow trucks shall be identified by an intermittent or revolving red light capable of three-hundred-sixty-degree (360°) visibility at a distance of five hundred feet (500') under normal atmospheric conditions. This intermittent or revolving red light shall be used only at the scene of an emergency or accident, and it will be unlawful to use such light while traveling to or from an emergency or accident, or for any other

- Service Brakes--Adequacy. Every such vehicle and combination of vehicles, except special mobile equipment as defined in Section 11.44.585, shall be equipped with service brakes complying with the performance requirements of Section 11.84.040 and adequate to control the movement of and to stop and hold such vehicle under all conditions of loading, and on any grade incident to its operation.
- Parking Brakes--Adequacy. Every such vehicle and combination of vehicles, except motorcycles and motor-driven cycles, shall be equipped with parking brakes adequate to hold the vehicle on any grade on which it is operated, under all conditions of loading, on a surface free from snow, ice, or loose material. The parking brakes shall be capable of being applied in conformance with the foregoing requirements by the driver's muscular effort or by spring action or by equivalent means. The operation of parking brakes may be assisted by the service brakes or other source of power; provided, that failure of the service brake actuation system, or other power assisting mechanism, will not prevent the parking brakes from being applied in conformance with the foregoing requirements. The parking brakes shall be so designed that when once applied, they shall remain applied with the required effectiveness, despite exhaustion of any source of energy or leakage of any kind. The same brake drums, brake shoes and lining assemblies, brake-shoe anchors and mechanical brake shoe actuation mechanism normally associated with the wheel brake assemblies may be used for both the service brakes and the parking brakes. If the means of applying the parking brakes and the service brakes are connected in any way, they shall be so constructed that failure of any one (1) part shall not leave the vehicle without operative brakes.
 - C. Brakes on All Wheels. Every vehicle shall be equipped with brakes acting on all wheels except:
 - 1. Trailers, semitrailers, or pole trailers of a gross weight not exceeding three thousand (3,000) pounds, provided that:
 - The total weight on and including the wheels of the trailer or trailers shall not exceed a. forty percent (40%) of the gross weight of the towing vehicle when connected to the trailer or trailers; and
 - b. The combination of vehicles consisting of the towing vehicle and its total towed load, is capable of complying with the performance requirements of Section 11.84.040.
 - 2. Trailers, semitrailers, or pole trailers manufactured and assembled prior to July 1, 1965, shall not be required to be equipped with brakes when the total weight on and including the wheels of the trailer or trailers does not exceed two thousand (2,000) pounds.


- 3. Any vehicle being towed in drive-away or tow-away operations, provided the combination of vehicles is capable of complying with the performance requirements of Section 11.84.040.

 - 6. The wheel of a sidecar attached to a motorcycle or to a motor-driven cycle, or the front wheel of a motor-driven cycle need not be equipped with brakes, provided that such motorcycle or motor-driven cycle is capable of complying with the performance requirements of Section 11.84.040.
 - D. Automatic Trailer Brake Application upon Breakaway. Every trailer, semitrailer, and pole trailer equipped with air or vacuum actuated brakes and every trailer, semitrailer, and pole trailer with a gross weight in excess of three thousand (3,000) pounds, manufactured or assembled after January 1, 1964, shall be equipped with brakes acting on all wheels and of such character as to be applied automatically and promptly, and remain applied for at least fifteen (15) minutes, upon breakaway from the towing vehicle.
 - E. Tractor Brakes Protected. Every motor vehicle manufactured or assembled after January 1, 1964 and used to tow a trailer, semitrailer or pole trailer equipped with brakes, shall be equipped with means for stopping such towing vehicle by the use of its service brakes in the event the towed vehicle breaks away.
 - F. Trailer Air Reservoirs Safeguarded. Airbrake systems installed on trailers manufactured or assembled after January 1, 1964, shall be so designed that the supply reservoir used to provide air for the brakes shall be safeguarded against backflow of air from the reservoir through the supply line.
 - G. Two (2) Means of Emergency Brake Operation.
 - 1. Air Brakes. Every towing vehicle, when used in other than drive-away or tow-away operations to tow another vehicle (trailer) equipped with air-controlled brakes, shall be equipped with two (2) means for emergency application of the trailer brakes. One (1) of these means shall apply the trailer brakes automatically in the event of a reduction of the towing vehicle's air supply to a fixed pressure. The fixed pressure shall be not lower than twenty (20) pounds per square inch, nor higher than forty-five (45) pounds per square inch. The other means of applying the trailer brakes shall be a manually controlled device for applying and releasing of the brakes, readily operable by a person seated in the towing vehicle's driving seat; and its emergency position or method of operation shall be clearly indicated. In no instance may the manual means of operation of trailer brakes be so arranged as to permit its use to prevent operation of the automatic means of applying trailer brakes. The automatic and the manual means of operation of trailer brakes required by this section may be, but are not required to be, separate.
 - 2. Vacuum Brakes. Every towing vehicle used to tow other vehicles equipped with vacuum brakes, in operations other than drive-away or tow-away operations, shall have, in addition to the single

control device required by subsection H, a second control device which can be used to operate the brakes on towed vehicles in emergencies. The second control shall be independent of brake air, hydraulic and other pressure, and independent of other controls, unless the braking system be so arranged that failure of the pressure upon which the second control depends will cause the towed vehicle brakes to be applied automatically. The second control is not required to provide modulated braking.

- H. Single Control to Operate All Brakes. Every motor vehicle, trailer, semitrailer and pole trailer, and every combination of such vehicles, except motorcycles and motor-driven cycles, equipped with brakes shall have the braking system so arranged that one (1) control device can be used to operate all service brakes. This requirement does not prohibit vehicles from being equipped with an additional control device to be used to operate brakes on the towed vehicles. This regulation does not apply to drive-away or tow-away operations unless the brakes on the individual vehicles are designed to be operated by a single control in the towing vehicle.
 - Reservoir Capacity and Check Valve.
 - Air Brakes. Every bus, truck or trucktractor with air-operated brakes shall be equipped with at least one (1) reservoir sufficient to insure that, when fully charged to the maximum pressure as regulated by air compressor governor cut-out setting, a full service brake application may be made without lowering such reservoir pressure by more than twenty percent (20%). Each reservoir shall be provided with means for readily draining accumulated oil or water.
 - 2. Vacuum Brakes. Every truck with three (3) or more axles equipped with vacuum assistor type brakes and every truck-tractor and truck used for towing a vehicle equipped with vacuum brakes shall be equipped with a reserve capacity or a vacuum reservoir sufficient to insure that, with the reserve capacity or reservoir fully charged and with the engine stopped, a full service brake application may be made without depleting the vacuum supply by more than forty percent (40%).
 - 3. Reservoir Safeguarded. All motor vehicles, trailers, semitrailers and pole trailers, when equipped with air or vacuum reservoirs or reserve capacity as required by this section, shall have such reservoirs or reserve capacity so safeguarded by a check valve or equivalent device that in the event of failure or leakage in its connection to the source of compressed air or vacuum, the stored air or vacuum shall not be depleted by the leak or failure.
 - J. Warning Devices.
 - 1. Air Brakes. Every bus, truck or trucktractor using compressed air for the operation of its own brakes or the brakes on any towed vehicle, shall be provided with a warning signal, other than a pressure gauge, readily audible or visible to the driver, which will operate at any time the air reservoir pressure of the vehicle is below fifty percent (50%) of the air compressor governor cut-out pressure. In addition, each such vehicle shall be equipped with a pressure gauge visible to the driver, which indicates in pounds per square inch the pressure available for braking.
 - 2. Vacuum Brakes. Every truck-tractor and truck used for towing a vehicle equipped with

vacuum-operated brakes and every truck with three (3) or more axles using vacuum in the operation of its brakes, except those in drive-away or tow-away operations, shall be equipped with a warning signal, other than a gauge indicating vacuum, readily audible or visible to the driver, which will operate at any time the vacuum in the vehicle's supply reservoir or reserve capacity is less than eight inches (8") of mercury.

3. Combination of Warning Devices. When a vehicle required to be equipped with a warning device is equipped with both air and vacuum power for the operation of its own brakes or the brakes on a towed vehicle, the warning devices may be, but are not required to be, combined into a single device which will serve both purposes. A gauge or gauges indicating pressure or vacuum shall not be deemed to be an adequate means of satisfying this requirement. (RCW 46.37.340)

11.84.040 Performance ability of brakes.

- A. Every motor vehicle and combination of vehicles, at all times and under all conditions of loading, upon application of the service brakes, shall be capable of:
 - 1. Developing a braking force that is not less than the percentage of its gross weight tabulated herein for its classification:
 - 2. Decelerating to a stop from not more than twenty (20) miles per hour at not less than the feet per second tabulated herein for its classification; and
 - 3. Stopping from a speed of twenty (20) miles per hour in not more than the distance tabulated herein for its classification, such distance to be measured from the point at which movement of the service brake pedal or control begins.
- B. Tests for deceleration and stopping distance shall be made on a substantially level (not to exceed plus or minus one percent (1%) grade), dry, smooth, hard surface that is free from loose material. (See Table 11.84.040)

11.84.060 Maintenance of brakes.

All brakes shall be maintained in good working order and shall be so adjusted as to operate as equally effectively and simultaneously as practicable with respect to the front and back wheels and with respect to the wheels on opposite sides of the vehicle. (RCW 46.37.360) (Ord. 108200 § 2(11.84.060), 1979.)

11.84.080 Muffler.


Every motor vehicle shall at all times be equipped with a muffler in good working order and in constant operation to prevent excessive or unusual noise and no person shall use a muffler cut-out, bypass or similar device upon a motor vehicle on a street or alley. (RCW 46.37.390(1)) (Ord. 108200 § 2(11.84.080), 1979.)

11.84.090 Transporting children.

No person shall transport a child under the age of five on a motorcycle or motor-driven cycle. (Ord. 113906 § 3, 1988.)

11.84.100 Smoke and air contaminants--Standards--Definitions.

- No motor vehicle first sold and registered as a new motor vehicle on or after January 1, 1971, shall discharge into the atmosphere at elevations of less than three thousand feet (3,000') any air contaminant for a period of more than ten (10) seconds which is:
 - 1. As dark as or darker than the shade designated as No. 1 on the Ringelmann chart, as published by the United States Bureau of Mines: or
 - Of such opacity as to obscure an observer's view to a degree equal to or greater than does smoke 2.

B. No motor vehicle first sold and registered prior to January 1, 1971 shall discharge into the atmosphere at elevations of less than three thousand feet (3,000') any air contaminant for a period of more than ten (10) seconds which is:

- 1. As dark or darker than the shade designated as No. 2 of the Ringelmann chart, as published by the United States Bureau of Mines; or
- Of such opacity as to obscure an observer's view to a degree equal to or greater than does smoke described in subsection B2.
 - C. For the purposes of this subsection the following definitions shall apply:
- 1. "Opacity" means the degree to which an emission reduces the transmission of light and obscures the view of an object in the background.
 - 2. "Ringelmann chart" means the Ringelmann smoke chart with instructions for use as published by the United States Bureau of Mines in May, 1967, and as thereafter amended, information circular 7718, which is adopted by reference and three (3) copies of which are placed on file with the City Clerk. (RCW 46.37.390(2))

11.84.120 Mirrors.

- A. Every motor vehicle shall be equipped with a mirror mounted on the left side of the vehicle and so located to reflect to the driver a view of the highway for a distance of at least two hundred feet (200') to the rear of such vehicle.
- B. Every motor vehicle shall be equipped with an additional mirror mounted either inside the vehicle approximately in the center or outside the vehicle on the right side and so located as to reflect to the driver a view of the highway for a distance of at least two hundred feet (200') to the rear of such vehicle.
- C. All mirrors required by this section shall be maintained in good condition. (Ord. 108200 § 2(11.84.120), 1979.)

11.84.140 Windshield obstruction.

No person shall drive any motor vehicle with any sign, poster or other nontransparent material upon the front windshield, side wings or side or rear windows of such vehicle which obstructs the driver's clear view of the street or alley or any intersecting street or alley. (RCW 46.37.410(1)) (Ord. 108200 § 2(11.84.140), 1979.)

11.84.150 Application of tinting or coloring material.

A. No tinting or coloring material that reduces light transmittance to any degree, unless it meets

standards for such material adopted by the State Patrol, may be applied to the surface of the safety glazing material in a motor vehicle in any of the following locations:

- 1. Windshields,
- 2. Windows to the immediate right and left of the driving including windwings, or
- 3. Rearmost windows if used for driving visibility by means of an interior rear-view mirror.
- B. Nothing in this subsection prohibits the use of shaded or heat-absorbing safety glazing material in which the shading or heat-absorbing characteristics have been applied at the time of manufacture of the safety glazing material and which meet the standards of the State Patrol for such safety glazing materials.
- C. The term "safety glazing materials" means glazing materials so constructed, treated, or combined with other materials as to reduce substantially, in comparison with ordinary sheet glass or plate glass, the likelihood of injury to persons by objects from exterior sources or by these safety glazing materials when they may be cracked or broken.

 (Ord. 113906 § 1, 1988.)

11.84.160 Windshield wiper.

The windshield on every motor vehicle shall be equipped with a device for cleaning rain, snow, or other moisture from the windshield, which device shall be so constructed as to be controlled or operated by the driver of the vehicle. No person shall operate a motor vehicle which is not equipped with such device or devices in good working order capable of cleaning the windshield thereof over two (2) separate arcs, one each on the left and right side of the windshield, each capable of cleaning a surface of not less than one hundred twenty (120) square inches, or other device or devices capable of accomplishing substantially the same result. Every windshield wiper upon a motor vehicle shall be maintained in good working order. (RCW 46.37.410(2)(3)) (Ord. 108200 § 2(11.84.160), 1979.)

11.84.180 Tires--Pneumatic.

No person shall operate a vehicle upon a street or alley unless it is completely equipped with pneumatic rubber tires: Provided, that a permit may be issued by the Traffic Engineer for the use of nonpneumatic tires when it has been determined that such equipment will not harm the roadway surface nor interfere with normal traffic operation. (RCW 46.37.420(1), (3)) (Ord. 108200 § 2(11.84.180), 1979.)

11.84.200 Tire cleats and chains.

A. No tire on a vehicle moved on a street or alley shall have on its periphery any block, stud, flange, cleat or spike or any other protuberance of any material other than rubber which projects beyond the tread of the traction surface of the tire, except that it shall be permissible to use farm machinery with tires having protuberances which will not injure the street and except also that it shall be permissible to use tire chains or metal studs imbedded within the tire of reasonable proportions and of a type approved by the State Commission on Equipment, upon any vehicle when required for safety because of snow, ice, or other conditions tending to

cause a vehicle to skid: Provided, that it shall be unlawful to use metal studs imbedded within the tire between April 1st and November 1st: Provided further, that the use of tires with metal studs imbedded therein shall be lawful during additional periods when the State Highway Commission so determines.

B. Tires with metal studs imbedded therein may be used between November 1st and April 1st upon school buses and Fire Department vehicles, any law or regulation to the contrary notwithstanding. (RCW 46.37.420(2), (4))

11.84.220 Pneumatic passenger car tires--Standards--Exception for off-street use.

- A. No person, firm or corporation shall sell or offer for sale for use on any street or alley any new pneumatic passenger car tire which does not meet the standards established by Federal Motor Vehicle Safety Standard No. 109, as promulgated by the United States Department of Transportation under authority of the National Traffic and Motor Vehicle Safety Act of 1966 (80 Stat. 719, 728; 15 U.S.C. 1392, 1407).
- B. The applicable standard shall be the version of standard No. 109 in effect at the time of manufacture of the tire.
- C. No person, firm or corporation shall sell or offer for sale any new pneumatic passenger car tire which does not meet the standards prescribed in this section unless such tires are sold for off-street use, as evidenced by a statement signed by the purchaser at the time of sale certifying that he is not purchasing such tires for use on a street or alley. (RCW 46.37.423) (Ord. 108200 § 2(11.84.220), 1979.)

11.84.240 Regrooved tires--Standards--Exception for off-street use.

- A. No person, firm or corporation shall sell or offer for sale any regrooved tire and no person, firm or corporation shall regroove any tire for use on a street or alley which does not meet the standard established by Federal Motor Vehicle Standard part 569 regrooved tires, as promulgated by the United States Department of Transportation under authority of the National Traffic and Motor Vehicle Safety Act of 1966 (80 Stat. 719, 728; 15 U.S.C. 1392, 1407).
- B. The applicable standard shall be the version of the federal regrooved tire standard in effect at the time of regrooving.
- C. No person, firm or corporation shall sell or offer for sale any regrooved tire and no person, firm or corporation shall regroove any tire which does not meet the standards prescribed in this section unless such tires are sold or regrooved for off-street use, as evidenced by a statement signed by the purchaser or regroover at the time of sale or regrooving certifying that he is not purchasing or regrooving such tires for use on a street or alley. (RCW 46.37.424)

11.84.260 Tires--Safe operating condition.

A. No person shall drive or move or cause to be driven or moved upon a street or alley on tires

which have contact with the driving surface of the road, any vehicle subject to registration.

which have contact with the driving surface of the road, any vehicle subject to registration in this state, unless such vehicle is equipped with tires in safe operating condition in accordance with requirements established by the State Commission on Equipment.

- B. A tire shall be considered unsafe if it has:
- 1. Any ply or cord exposed either to the naked eye or when cuts or abrasions on the tire are probed; or
- 2. Any bump, bulge or knot, affecting the tire structure; or
- 3. Any break repaired with a boot; or
- 4. A tread depth of less than (2/32) of an inch measured in any two (2) major tread grooves at three (3) locations equally spaced around the circumference of the tire, or for those tires with tread wear indicators, a tire shall be considered unsafe if it is worn to the point that the tread wear indicators contact the road in any two (2) major tread grooves at three (3) locations equally spaced around the circumference of the tire; or
 - 5. A legend which indicates the tire is not intended for use on public highway such as, "not for highway use," or "for racing purposes only"; or
 - 6. Such conditions as may be reasonably demonstrated to render it unsafe; or
 - 7. If not matched in tire size designations, construction, and profile to the other tire and/or tires on the same axle.
- C. The condition or defect must be such that it can be detected by a visual inspection of tires mounted on vehicles, including visual comparison with simple measuring gauges. (RCW 46.37.425) (Ord. 109475 § 1(part), 1980: Ord. 108200 § 2(11.84.260), 1979.)

11.84.290 Helmets.

- A. It is unlawful for any person to operate or ride upon a motorcycle or motor-driven cycle, or moped on a street unless wearing upon his or her head a motorcycle helmet, except when the vehicle is an antique motor-driven cycle or automobile that is licensed as a motorcycle or when the vehicle is equipped with seat belts and roll bars approved by the Washington State Patrol. The motorcycle helmet neck or chin strap must be fastened securely while the motorcycle or motor-driven cycle is in motion. Persons operating electric-assisted bicycles shall comply with all laws and regulations related to the use of bicycle helmets.
- B. For purposes of this section, "motorcycle helmet" means a protective covering for the head consisting of a hard outer shell, padding adjacent to and inside the outer shell, and a neck or chin strap type retention system, with a sticker indicating that the motorcycle helmet meets standards established by the United States Department of Transportation. (RCW 46.37.530(1)(c) & (3)) (Ord. 121525 § 14, 2004; Ord. 113906 § 2, 1988.)

No person, firm or corporation shall sell any vehicle for use on a street or alley unless the vehicle is equipped with tires that are in compliance with the provisions of Section 11.84.260. If the tires are found to be in violation of Section 11.84.260, the person, firm or corporation selling the vehicle shall cause such tires to be removed from the vehicle and shall equip the vehicle with tires that are in compliance with the provisions of Section 11.84.260. 11.84.320 Horns and warning devices.

Every motor vehicle when operated upon a street shall be equipped with a horn in good working order and capable of emitting sound audible under conditions of no background noise from a distance of not less than two hundred feet (200'), but no horn or other warning device shall emit an unreasonably loud or harsh sound which exceeds eighty-five (85) dB(a) at two hundred feet (200'). The driver of a motor vehicle shall when reasonably necessary to insure safe operation give audible warning with his horn but shall not otherwise use such horn when upon a street or alley. (RCW 46.37.380) (Ord. 108200 § 2(11.84.320), 1979.)

11.84.340 Siren, whistle, or bell prohibited.

No vehicle shall be equipped with nor shall any person use upon a vehicle any siren, whistle, or bell, except as otherwise permitted in this chapter: Provided, that it is permissible for any vehicle to be equipped with a theft alarm signal device so long as it is so arranged that it cannot be used by the driver as an ordinary warning signal. Such a theft alarm signal device may use a whistle, bell, horn, or other audible sound but shall not use a siren: Provided further, that it is permissible to equip a vehicle with a bell that gives warning either when the vehicle is backing up or when the emergency brake system releases. (RCW 46.37.380(2), (3)) (Ord. 108200 § 2(11.84.340), 1979.)

11.84.345 Turning off automatic automobile alarms.

- Duty. The owner of a vehicle equipped with an automatic audible theft alarm device shall turn it off or cause it to be turned off within five (5) minutes after the alarm sounds, provided that if such a vehicle is owned by an agency engaged in the business of renting motor vehicles to the public (called a rental agency) and is under lease, the lessee of the vehicle shall turn off or cause the alarm device to be turned off within five (5) minutes after the alarm sounds.
 - B. Defenses. It is a defense that:
 - 1. The alarm sounded because the vehicle was damaged, or was the object of an unlawful entry or theft or an attempt at an unlawful entry or theft; or
 - 2. When the alarm sounded, the owner or operator attempted to turn the alarm off, but was unable to do so because the alarm equipment had been damaged or tampered with; or
 - 3. The alarm was deliberately sounded as a method of summoning assistance in an emergency

- 4. The vehicle was being used without the consent of the owner, express or implied, and the owner had reported its loss or theft to the police.
- C. Allocation of Responsibility Between Rental Agency and Lessee. The notice of civil infraction shall be placed upon the vehicle or issued to the operator and charged to the rental agency as owner unless the rental agency (a) shows that the vehicle had been rented to another at the time of the incident, (b) declares that the audible alarm equipment was in good operating order at the time the vehicle was rented, and (c) supplies the name and address of the lessee of the vehicle. A lessee who receives a notice of civil infraction as an operator or is charged on the basis of an identification by the rental agency may secure the reinstatement or substitution of the rental agency in his or her place, if the rental agency consents thereto at or before a hearing requested to contest the determination, or the rental agency accepts in writing responsibility for the failure of the alarm to be turned off within five (5) minutes, and promises to make payment of the monetary penalty. (Ord. 116701 § 1, 1993.)

11.84.360 Emergency vehicle audible sound.

Any authorized emergency vehicle may be equipped with a siren, whistle or bell, capable of emitting sound audible under conditions of no background noise from a distance of not less than five hundred feet (500') and of a type approved by the State Commission on Equipment, but such siren shall not be used except when such vehicle is operated in response to an emergency call or in the immediate pursuit of an actual or suspected violator of the law, in which said latter events the driver of such vehicle shall sound the siren when reasonably necessary to warn pedestrians and other drivers of the approach thereof. (RCW 46.37.380(4)) (Ord. 108200 § 2(11.84.360), 1979.)

11.84.380 Fire extinguishers.

Any person operating any vehicle transporting any explosive or flammable cargo upon a street or alley shall at all times keep the vehicle equipped with not less than two (2) fire extinguishers, filled and ready for immediate use, and placed at a convenient point on the vehicle so used. (RCW 46.37.460(2)) (Ord. 108200 § 2(11.84.380), 1979.)

11.84.400 Fenders or splash aprons.

No person shall operate any motor vehicle, trailer, or semitrailer that is not equipped with fenders, covers, flaps, or splash aprons adequate for minimizing the spray or splash of water or mud from the roadway to the rear of the vehicle. All such devices shall be as wide as the tires behind which they are mounted and extend downward at least to the center of the axle. (Ord. 108200 § 2(11.84.400), 1979.)

11.84.420 Use of litter receptacle.

No registered owner of any vehicle shall fail to keep available for use a litter receptacle in his vehicle. (RCW 70.93.100)

- A. No person shall drive any motor vehicle equipped with any television viewer, screen or other means of visually receiving a television broadcast which is located in the motor vehicle at any point forward of the back of the driver's seat, or which is visible to the driver while operating the motor vehicle.
- B. No person shall operate any motor vehicle on a public highway while wearing any headset or earphones connected to any electronic device capable of receiving a radio broadcast or playing a sound recording for the purpose of transmitting a sound to the human auditory senses and which headset or earphones muffle or exclude other sounds.

(Ord. 108200 § 2(11.84.440), 1979.)

Every motor truck or truck-licensed vehicle, trailer, and semitrailer shall have painted or stenciled upon the outside thereof in a conspicuous place, in letters not less than two inches (2") high, the maximum gross weight for which it is licensed. (RCW 46.16.170) (Ord. 108200 § 2(11.86.020), 1979.)

11.86.040 Improper gross weight figures.

No owner or operator of any vehicle shall display a maximum gross weight for which such vehicle is licensed other than that shown on the certificate of license registration of the vehicle. (RCW 46.16.170) (Ord.108200 § 2(11.86.040), 1979.)

11.86.060 Name marking.

All common and contract carriers shall have their trucks and trailers identified and marked as to name, permit number, and address, as required in the Rules and Regulations established by the Washington Utilities and Transportation Commission.

11.86.080 Flammable or combustible labeling.

Every tank motor vehicle used for the transportation of any flammable or combustible liquid, regardless

of quantity being transported, or whether loaded or empty, shall be conspicuously and legibly marked on each side and rear thereof with approved United States Department of Transportation labeling. When the vehicle contains flammable liquid or flammable vapors, the common name of the liquid shall be posted on each side and the rear in letters at least three inches (3") high.

11.86.100 Explosive cargo labeling.

Any vehicle transporting any explosive as a cargo or part of a cargo upon a street or alley shall be marked or placarded on each side and on the rear with the word "EXPLOSIVES" as required by rules and regulations of the United States Department of Transportation. 11.90.010 Duties and responsibilities.

The judges of the Seattle Municipal Court are authorized to provide by rule pursuant to RCW 35.20.140 that the Traffic Violations Bureau¹ shall be the appropriate office for the acceptance of bail, issuance of court appearance dates and notices thereof, preparation of subpoenas and notification of officers in connection with court appearances, and the performance of duties and responsibilities related thereto, all in connection with violations of those municipal ordinances under the jurisdiction of Department I of the court as may be designated by such rule. All functions of the Traffic Violations Bureau performed pursuant to court rules herein provided for shall be construed as a delegation of duties of Department I of the Seattle Municipal Court, and in the performance thereof the Traffic Violations Bureau shall be responsible to the judge of Department I. (Ord. 94893 § 1, 1966: Ord. 94730 § 1, 1966.)

For the purposes of this chapter, an "abandoned vehicle" means any vehicle left upon the private property of another without the consent of the owner of such property for a period of twenty-four (24) hours or longer, except that a vehicle shall not be considered abandoned if its owner or operator is unable to remove it from the place where it is located and so notifies law enforcement officials and requests assistance. A "wrecked, dismantled, or inoperative vehicle or automobile hulk" means the remnant or remains of a motor vehicle which is inoperative and cannot be made mechanically operative without the addition of vital parts or mechanisms and 11.92.020 Nuisance abatement. and to confirm accult the application of a substantial amount of labor to effect repairs.

Abandoned, wrecked, dismantled, or inoperative vehicles or automobile hulks or parts thereof on private property are declared to be public nuisances which shall be abated and removed as provided in this chapter; provided, that this chapter shall not apply to: (A) any vehicle or hulk or part thereof which is completely enclosed within a building in a lawful manner and not visible from the street or other public or private property, or (B) any vehicle or hulk or part thereof stored or parked in a lawful manner in connection with the business of a licensed dismantler or licensed vehicle dealer, on private property fenced in accordance with the provisions of RCW 46.80.130, or (C) any vehicle or hulk or part thereof stored or parked on private property in connection with the business of an auto-wrecking yard or junkyard fenced in accordance with provisions of the Comprehensive Zoning Ordinance of the City. 1

11.92.030 Enforcement authority.

The Director of Engineering shall enforce this chapter and shall be responsible for the abatement and removal of any vehicle or hulk or part thereof declared in Section 11.92.020 to be a public nuisance. (Ord. 98223 § 3, 1969.)

11.92.040 Public hearing--Notices.

- A. Before abatement and removal of any such vehicle or hulk or part thereof from private property, the Director of Engineering shall give notice that a public hearing may be requested before the City Council and that if no such hearing is requested within ten (10) days of the date of such notice, the vehicle or hulk or part thereof described in the notice will be abated and removed by the City and the costs of such abatement and removal collected from the registered owner of such vehicle or hulk or part thereof or from the owner of the property upon which such vehicle or hulk or part thereof is located.
- Upon receipt of any such request for public hearing, the City Council may by resolution set a date for public hearing on the question of abatement and removal of the vehicle or hulk or part thereof as a public nuisance and shall cause to be given notice of the time, location and date of such hearing.

and amending The owner of the property upon which any such vehicle or hulk or part thereof is located may appear at such hearing in person or may timely present a written statement for consideration at such hearing, and may deny responsibility for the presence of such vehicle or hulk or part thereof on such property, giving reasons for such denial. If it is determined at such hearing that the vehicle or hulk or part thereof was placed on such property without the consent of the property owner, and that he has not subsequently acquiesced in its presence, then the City shall not attempt to collect the cost of abatement and removal or any part thereof from the property owner.

11.92.060 Removal and disposal of vehicle.

After notice has been given of the City's intent to abate and remove any such nuisance, and after public hearing if such is requested all as provided in Section 11.92.040, the Director of Engineering shall cause such vehicle or hulk or part thereof to be removed and disposed of to a licensed auto wrecker and shall give notice to the Washington State Patrol and the Washington State Department of Motor Vehicles that such vehicle or hulk or part thereof has been wrecked, and the proceeds of any such disposition shall be used to defray the costs of abatement and removal of any such vehicle, hulk or part thereof, including costs of administration. (Ord. 98223 § 6, 1969.)

11.92.070 Costs of abatement and removal.

The costs of abatement and removal of any such vehicle, hulk or part thereof, including costs of administration, shall be collected from the last registered owner thereof if the identity of such owner can be determined and unless such owner in the transfer of ownership thereof has complied with RCW 46.12.101 as amended; or, except as provided in Section 11.92.050, the costs shall be collected from the owner of the property on which such vehicle, hulk or part thereof is located. In consideration of the acceptance of the further provisions of this chapter with reference to railroad tracks upon Railroad Avenue and Railroad Way in the City by all railroad companies possessing franchises for the operation of railroads thereon, the provisions of the foregoing sections with reference to fences and barriers, and the provisions thereof with reference to gates and flagmen shall not be required upon Railroad Avenue or Railroad Way in the City for the period of twelve (12) months from the date when this ordinance codified in this chapter takes effect.¹

11.94.050 Prohibited uses along portion of Railroad Avenue. Ext, graphics,

A. No railroad company shall run any locomotive, train or cars along any tracks owned or controlled by such railroad company, or which it shall be entitled to use, situated upon that part of Railroad Avenue lying between Bell Street and King Street, nor make any use of such tracks other than to furnish cars and railroad service in switching to and from local wharves or warehouses; provided, however, that this section shall not be construed as prohibiting the running and operating of passenger trains south of Washington Street to and from passenger stations or depots which may be located on said street or south thereof; and provided, further, that in connection with such switching service no such railroad company shall allow its locomotives or cars to stand upon the tracks within Railroad Avenue except long enough to do necessary switching, make up trains, or to receive and land passengers or load and unload freight, unless in case of accident or other unavoidable delay. All trains or cars switched between the hours of seven a.m. (7:00 a.m.) and ten p.m. (10:00 p.m.) shall be accompanied by an extra flagman for the protection of the public using said avenue, and no switching shall be done at a greater rate of speed than six (6) miles per hour.

The City reserves the right under its police power to hereafter, if public safety or necessity B. requires, by ordinance, designate closed hours for switching within that portion of Railroad Avenue described in

11.94.060 Movements across improved streets or highways.

It shall be unlawful to switch or move any railroad car or cars across any improved street or highway within the City limits unless either there is a locomotive coupled to such car or cars or a man is stationed at such crossing to flag and give warning of the movement over the crossing.

11.94.070 Liability of owner or operator--Trespassing.

Nothing in this chapter contained shall be taken to release the owner, agent, lessee or operator of any railroad or street railway from any liability for any injury or damage which may be suffered by any person upon any such railroad or street railway property, but the safeguards and protection to the public prescribed in this chapter shall be provided and maintained in addition to all other care and protection required by law; provided, however, that nothing herein contained shall authorize or be considered as authorizing the use by the public for purposes of travel, of any railroad, street railway, trestle or other property, and such use of any trestle or bridge erected for the sole purpose of carrying railroad or street railway tracks by any person, except by express permission of the company or person whose tracks are carried by any such trestle or bridge is prohibited, and any person using any such trestle or bridge, except as aforesaid, is declared to be a trespasser. person whose tracks are carried by any such bridge or trestle shall keep at each end thereof a white sign bearing in black letters the words "Danger: Walking or driving on this bridge (or trestle) is prohibited by ordinance of The City of Seattle."
