ORDINANCE 100562

AN ORDINANCE relating to and establishing a "Nutcracker Northwest Account" in the "General Donations and Gift Trust Fund," authorizing acceptance of donations thereto and appropriating the same for a dance ballet program.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. There is hereby established a "Nutcracker Northwest Account" in the "General Donations and Gift Trust Fund" and the Superintendent of Parks and Recreation is hereby authorized to accept on behalf of The City of Seattle contributions and donations from the public for the cost of Nutcracker Northwest, a dance-ballet program to be performed December 18 and 19, 1971, free to the public, and all such donations and contributions, which are to be deposited in said fund and credited to said account, are hereby appropriated for such purpose and the City Comptroller is authorized to draw and the City Treasurer to pay warrants against such account on vouchers approved by the Superintendent of Parks and Recreation, all as requested in C.F. 271564.

Section 2. Any act pursuant to the authority and prior to the effective date of this ordinance is hereby ratified and confirmed.

(To be used for all Ordinances except Emergency.)

Section <sup>3</sup>..... This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
