ORDINANCE 100582

AN ORDINANCE relating to the Executive Department, Model City Program, authorizing an agreement with the Skid Road Community Council to provide social services for Skid Road residents.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the Mayor is hereby authorized for and on behalf of the City of Seattle to enter an agreement with the Skid Road Community Council, effective December 17, 1971, to provide shelter, food, transportation and related social services to Skid Road residents, at a consideration not to exceed twelve thousand dollars (\$12,000), which sum, or so much thereof as may be necessary, shall be charged to unexpended funds of the Model City Youth Services Project, identified as Seattle Model City Project No. 31502; and the City Comptroller is authorized to draw and the City Treasurer to pay the necessary warrants to make the necessary transfers, all as recommended by the Mayor in C.F. 271681.

Section 2. Any act pursuant to the authority and prior to the effective date of this ordinance is hereby ratified and confirmed.

(To be used for all Ordinances except Emergency.)

Section . . . This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
