ORDINANCE 100973

AN ORDINANCE authorizing a collective bargaining agreement with Seattle Police Officers' Guild for the period January 1, 1972 through August 31, 1972.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the Mayor is hereby authorized for and on behalf of The City of Seattle to execute, and the City Comptroller to attest a collective bargaining agreement with Seattle Police Officers' Guild for the period January 1, 1972 through August 31, 1972 substantially in the form identified as "Agreement By and Between City of Seattle and Seattle Police Officers' Guild" and including Exhibits "A" through "F" attached thereto, all contained in C.F. 272540.

Section 2. That Ordinance 99575 (Salary Ordinance) and all other ordinances, insofar as inconsistent herewith are hereby superseded.

Section 3. That execution and delivery of the agreement authorized in Section 1 hereof and any act pursuant thereto prior to the effective date of this ordinance is hereby ratified and confirmed.

Section <sup>4</sup>..... This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
