BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the name of that portion of West Lawton Way between the west margin of 15th Avenue West extended and the east margin of 20th Avenue West extended is hereby changed to West Armory Way, as recommended by the Board of Public Works in C.F. 277126.

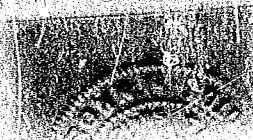
