ORDINANCE 102833

AN ORDINANCE adopting a budget for the City of Seattle for the year 1974.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the annual Budget submitted, as contemplated by Chapter 7, Laws of 1967, Regular Session, (R.W. Ch. 35.32A), by the Mayor and filed as C.F. 276991 with the following modifications, to wit:

Recommendations of the Budget Committee of the City Council for modifications, as adopted by amendments by the City Council on November 26, 1973, and set forth in C.F. 276991, as amended,

is hereby adopted, and the positions of the officers and employees of the various departments of the City government of Seattle shall be defined and designated as set forth therein. Should any budget recommendations, modification, adjustment, or amendment conflict, the last in time shall control.

Section 2. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
