AN ORDINANCE authorizing a collective bargaining agreement with Seattle Folice Officers' Guild for the period Sertember 1, 1974 through August 31, 1975.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That as recommended in C.F. 279955, the Mayor is hereby authorized to execute and the City Comptroller to attest, for and on behalf of The City of Seattle, a collective bargeining agreement with Seattle Police Officers' Guild for the period reptember 1, 1974 through August 31, 1975 substantially in the form contained in C.F. 280238 and identified as "Agreement

By and Between City of Seattle and Seattle Police Officers'

Guild".

Section 2. That Ordinance 102480 (Salary Ordinance) and all other ordinances, insofar as inconsistent herewith are hereby superseded.

Section 3. That execution and delivery of the agreement authorized in Section 1 hereof and any act pursuant thereto prior to the effective date of this ordinance is hereby ratified and confirmed.

(To be used for all Ordinances except Emergency.)

Section 4... This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
