ORDINANCE 104619

AN ORDINANCE relating to the Seattle Center Department; authorizing concession lease agreements with Pacific Northwest Aviation Historical Foundation, Inc. and Washington State Fire Service Historical Museum, Inc. for the use and occupancy of certain premises in the Seattle Center.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. The Director of the Seattle Center Department, is hereby authorized for and on behalf of The City of Seattle, to enter into an agreement with Pacific Northwest Aviation Historical Foundation, Inc., substantially in the form identified as "Seattle Center Lease Agreement" contained in C.F. 281546, for the operation of an historical aviation museum and sale of authentic related souvenir items at the Seattle Center premises described as follows:

The south portion of the Seattle Center Building No. 50 located in the southeast section of the Center site, and east of the Space Needle containing approximately 9,500 Square Feet.

for a period of one (1) year commencing January 1, 1975, and upon such further terms and conditions as are contained in said Lease Agreement.

Section 2. That the Director of the Seattle Center Department is hereby authorized for and on behalf of The City of Seattle to enter into an agreement with Washington State Fire Service Historical Museum, Inc., substantially in the form identified as "Seattle Center Lease Agreement" contained in C.F. 281546, for the installation and operation of an historical fire-fighting equipment museum and sale of authentic related souvenir items at Seattle Center premises described as follows:

The center portion of the Seattle Center Building No. 50, located on the southeast section of the Center site, and east of the Space Needle, containing approximately 12,632 Square Feet,






