ORDINANCE 105044

AN ORDINANCE relating to the Neighborhood Improvement Program; authorizing the preparation of plans, specifications and cost estimates for and the improvement of Albion Place North from North 34th Street to North 35th Street in the Fremont Neighborhood by the construction of concrete paving and sidewalks and a new storm drain, and making an appropriation from the Neighborhood Improvement Fund therefor.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That as requested by the Director of Community Development and the City Engineer and recommended by the Mayor in C.F. 282192, the City Engineer is authorized to prepare plans, specifications and cost estimates for, and in connection therewith to hire consultants, and upon approval thereof by the Board of Public Works to proceed with the improvement of Albion Place North from North 34th Street to North 35th Street in the Fremont Neighborhood by the construction of concrete paving and sidewalks and a new storm drain, which improvement may be effectuated by the awarding of a contract or contracts therefor or the same or any part thereof may be effected by day labor in the discretion of said Board, subject to applicable state law, and for such purpose the sum of Thirty-five Thousand Two Hundred Twenty-five Dollars (\$35,225) or so much thereof as may be necessary is hereby appropriated from the Neighborhood Improvement Fund and the City Comptroller is authorized to draw and the City Treasurer to pay the necessary warrants.

Section 2. That any act pursuant to the authority and prior to the effective date of this ordinance is hereby ratified and confirmed.

(To be used for all Ordinances except Emergency.)

Section 3. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
