ORDINANCE NO. 11404

An Ordinance providing for the laying off, extending and establishing of Lakeview Avenue, in the City of Seattle, as a public street
and highway over and across certain lets, blocks and tracts of land,
between the south line of France's Addition in the City of Seattle
to an intersection with Boylston Avenue North in Green's Addition
to the City of Seattle, and providing for the taking and demaging
of land and other property necessary therefor; and for the ascertainment and payment of the just compensation to be made for the private
preperty to be taken or damaged for said purpose, and for an assessment upon the property benefit (ed for the purpose of making such
compensation.

WHEREAS, public necessity demands that said Lakeview Avemee be laid off, extended and established as a public street and highway in the City of Seattle as herein provided, and that the same will be of special benefit to certain lands and other premises adjoining, centiqueus and proximate thereto, within the assessment district hereinafter described. Now, Therefore,

BE IT ORDAINED BY THE CITY OF SEATTLE AS POLLOWS:

Section 1. That Lakeview Avenue, in the City of Seattle, be and the same is hereby laid off, extended and established as a public street and highway in said city, through, over and across those certain lots, blocks and tracts of land lying between the south line of Prance's Addition in the City of Seattle and the north marginal line of East Newton Street at its intersection with Boylston Avenue North in the City of Seattle, as said pieces, parcels or portions of said lots, blocks and tracts of land are hereinafter more particularly described in the descriptions numbered from one to fifty-two, inclusive, successively, as follows:—

Sec. This ordinance shall take effect and be in force from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the City Charter.
