ORDINANCE 114378

AN ORDINANCE relating to taxicab, for-hire vehicle, and for-hire driver license fees, increasing license fee amounts therefor; and amending Seattle Municipal Code (SMC) Section 6.204.050.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Section 6.204.050 of the Seattle Municipal Code, as last amended by Ordinance 113185, is amended as follows:

6.204.050 Taxicabs and for-hire vehicles.

Annual fees for taxicabs, for-hire vehicles and their drivers shall be:

Taxicab .....	<del>\$85.00</del>	<u>\$110.00</u>
For-hire vehicle .....	<del>\$85.00</del>	<u>\$110.00</u>
For-hire driver .....	<del>\$25.00</del>	<u>\$ 35.00</u>

(To be used for all Ordinances except Emergency.)

Section 2... This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.

Dear Councilman Smith:

Please find attached, proposed legislation which will fund the City of Seattle portion of for-hire driver training of taxi drivers in the Seattle-King County region by increased license fees.

The training program is to be conducted by South Seattle Community College at an annual cost of \$37,500 to be equally shared at a cost of \$12,500 each by Seattle, King County and the Port of Seattle. The fee increases will generate an additional \$30,000 annually to Seattle's General Fund, which will recover our portion of the training program, as well as recover part of the Taxi Commission cost to the City.

AN ORDINANCE relating to taxicab, for-hire vehicle, and for-hire driver license fees, increasing license fee amounts therefor; and amending Seattle Municipal Code (SMC) Section 6.204.050.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Section 6.204.050 of the Seattle Municipal Code, as last amended by Ordinance 113185, is amended as follows:

6.204.050 Taxicabs and for-hire vehicles.

Annual fees for taxicabs, for-hire vehicles and their drivers shall be:

Taxicab .....	<del>\$85.00</del>	<u>\$110.00</u>
For-hire vehicle .....	<del>\$85.00</del>	<u>\$110.00</u>
For-hire driver .....	<del>\$25.00</del>	<u>\$ 35.00</u>

Section 2. This ordinance shall take effect and be in force thirty days from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the city charter.
