#### ORDINANCE WITAMO

AN ORDING CE authorizing the Mayor, as part of the City's part. :ipation in the proposed redevelopment of the former Frederick and Nelson Building, the present Nordstrom store, and the Frederick and Nelson parking garage, to enter into an agreement committing the City to reopen Pine Street between Fourth and Fifth Avenues to vehicular traffic, including transit vehicles; requiring that any such agreement include that the City retain full authority to temporarily close the street for special civic events, including celebrations, special events, and h. iday gatherings, and that the City shall not be obligated to reopen Pine Street until the developers meet specified benchmarks; and authorizing the Tayor to accept \$1,000,000 in grant funds and to develop a plan to spend the funds to enhance the pedestrian, design, and circulation potential of Pine Street and to enhance Westlake Plaza as a central civic gathering place.

WHEREAS, a proposed major redevelopment project for Downtown Seattle includes redevelopment of the former frederick and Nelsch store into Nordstrom corporate headquarters and a new flagship store, redevelopment of the current Nordstrom store into retail stores and a new hotel, and redevelopment of the Frederick and Nelson parking garage to provide additional parking and retail space, all at a private development cost of over \$300 million;

WHEREAS, a requirement of obtaining this \$300 million private investment in the downtown retail core is that the City reopen Pine Street between Fourth and Fifth Avenues to vehicular traffic, including transit vehicles; and

WHEREAS, the City of Seattle has received notice of the award of a \$1 million Special Grant funded through the Department of Housing and Urban Development for economic development activities in Dountown Feattle, particularly the Frederick & Nelson redevelopment project; and,

WHEREAS, the City has established, pursuant to Ordinance No.

1/7470 , Pine Street Advisory Task Force whose Juties include recommending ways in which the Special Grant funds can be used to enhance the pedestrian, design, and circulation potential of Pine Street and to enhance Westlake Plaza as a central civil gathering place.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF & ATTLE AS FOLLOWS:

Section 1. As part of the City's participation in the proposed redev lopment of the former Frederick and Nelson Store into Nordstrom corporate headquarters and a new Nordstrom flagship store, of the current Nordstrom store into new retail stores and a new hotel, and of the Frederick and Nelson parking

garage to prove both additional parking and new retail stores, the Mayor is authorized to enter into an agreement committing the City to recpen Pine Street between Fourth and Fifth Avenues to vehicular traffic, including transit vehicles.

Section 2. In any agreement committing the City to reopen Pine Street, the City shall not be obligated to reopen the street to vehicular traffic until and unless the project developers have filed for appropriate permits and begun major renovation within the Frederick and Nelson building.

Section 3. In any agreement committing the City to reopen Pine Street, the City shall retain full authority to temporarily close Pine Street for special civic events, including celebrations, special events, and holiday gatherings.

Section 4. The Mayor, or his designee, is hereby authorized, for and on behalf of the City, to enter into an agreement with the United States Department of Housing and Urban Exvelopment ("HUD") and to accept a grant award in the amount of

P. Street Advisory Task Force, to develop a plan for spending the grant funds to enhance the pedestrian, design, and circulation potential of Pine Street and to enhance Westlake Plaza as a central civic gathering place.

Section 5. Any acts made consistent with the authority and prior to the effective date of this ordinance are hereby ratified and confirmed.

Section 6. If the City Council exercises, p. suant to Seattle City Charter Article IV, Section 1H, the power of referendum and orders this ordinance placed on the ballot for a vote of the prople, the ordinance shall be in force and take effect upon certification that the people have voted to approve the ordinance. If the City council does not exercise the power of referendum as to this ordinance, it shall take effect and be in force thirty (30) days from and after its approval by the

I am Linnea Hirst, speaking for the League of Women Voters of Seattle, as Chair of the League's Land Use Committee.

Thank you for this opportunity to speak to the issue of Pine Street. We would like to use that opportunity to reaffirm our long-held position to keep the street closed and thus keep Westlake Park a single, integrated space for pedestrian use. That position in no way means that we are opposed to the proposed Rhodes/Nordstrom project. The problem is the connection currently required by Nordstrom.

The Pine Street issue has been much in the news since Nordstrom tied its reopening to the major redevelopment plans for the retail core. Yet, nothing in all those news articles gives us hard data with which to revisit our League position.

Yes, Frederick & Nelson's has closed, and I. Magnin's, and Woolworth's, too. But in all three cases, the closures were part of company-wide closings, for company-wide financial reasons. It was bad luck for Scattle that those companies had stores in our retail core.

Besides reading news articles, we have read the City Engineering studies on downtown circulation and on the Pine Street closing, and we have read the study of the Nordstrom project proposal done for the Downtown Seattle Association. None of those studies points to a need to open Pine Street to traffic.

I'd like to take a moment to look at the Downtown Seattle Association study. Table 2 of that study focuses on Seattle's market share of taxable retail sales in 1978, 1983, 1988, and 1993, and shows, as we all know, that Seattle's share of the region's sales is declining. But, if instead, we look at those Seattle retail sales numbers taken alone, we find: Department stores - decreasing (by 6.5% between 1988 and 1993)

Apparel/Accessories - increasing (by 30% between 1988 and 1993) Miscellaneous Retail - increasing (by 30% between 1988 and 1993), and Total Retail Sales in Seattle - increasing as follows:

1978 - 1983 by 26% 1983 - 1988 by 20% 1988 - 1993 by 28%

It seems to us, therefore, that the sales numbers for Seattle don't even show that the retail core is in trouble, but only that the City's proportional share of the region's sales is declining. That decline makes sense, given the population growth in the greater metropolitan area during those years.

But, I me the downtfigur it, these numbers are for all of Seattle. Can we use them to make assumptions about Are there specific facts and figures about downtown? Does anyone have those the facts? Where are the studies?

d to get to the issues. The argument "Open it." "No, keep it closed." doesn't furag, or invite real solutions. Why do Nordstrom and some other retailers want the
mause the #7 bus, for example, no longer stops within the block? Is it because
as are too confused about driving into the area? Is it because "undesirables" frequent
park? If the retailers could give us some issues to address, we could figure out some solutions.
Open it" is not an issue, but only a free-floating point of view.

Please, Seattle, let us figure out what the real problems are, and then go about solving them in a thoughtful, logical—and public—manner. And, may we add, with the show of genuine respect for the viewpoints of others.

Dear Seattle City Council,

The Washington Coalition for Transportation Alternatives (Alt-Trans) would like to declare its opposition to the proposal to re-open Pine Street between Fourth and Fifth Avenues. We feel that the street should remain closed for the following reasons:

- Westlake Park as it currently exists is a well-utilized park that offers the only opportunity in downtown Seattle for shoppers, tourists, workers and citizens to congregate and relax without the danger of traffic.
- Pedestrian areas are essential for a healthy downtown region. Re-opening Pine street would be a major set-back to addressing the need for adequate pedestrian access downtown and would provide a negative example for the entire Puget Sound region.
- The proposal to re-open Pine Street to traffic is based on the opinions of a single business interest and is not supported by any research of the issue.
- According to a study conducted by the City of Seattle's own Engineering Department, the closing of Pine Street has not adversely affected downtown traffic flows.
- Rather than encouraging more driving into the downtown area, the City of Seattle should look to the promotion of transit (lower fares rather than free parking, more bus lanes, etc.), traffic enforcement (motorist violation of pedestrian rights, illegal parking, etc.), and generally improving the pedestrian environment.
- ●Judging by hundreds of conversations that members of our organization have had with shoppers in Westlake Park, we feel that re-opening Pine Street will have a detrimental effect on businesses in the area.

Attached to this letter we submit to the Seattle City Council and to Nordstroms over 1300 signatures of shoppers of the Westlake area who are opposed to the re-opening of Pine Street.

If the City council does not exercise the power of referendum as to this ordinance, it shall take effect and be in force thirty (30) days from and after its approval by the Mayor, but if not approved and returned by the Mayor within ton (10) days after presentation, it shall take effect as provided by Municipal Code Section 1.04.020.
