1 B. ADMINISTRATIVE REVIEW

2 1. Administrative review and approval may be provided for the items listed in subsection 3  
3 according to the following procedures. The Owner shall submit to the City Historic  
4 Preservation Officer (CHPO) a written request for these alterations, including applicable  
5 drawings and/or specifications. If the CHPO, upon examination of submitted plans and  
6 specifications, determines that such alterations are consistent with the purposes of SMC  
7 25.12 the alterations shall be approved without the need for any further action by the  
8 Board. If the CHPO disapproves such alterations, the Owner may submit revised  
9 materials to the CHPO, or submit in accordance with the Certificate of Approval process  
10 set forth in SMC 25.12.

11 2. The CHPO shall submit his or her written decision on the Owner's submittal to the  
12 Owner. Failure of the CHPO to approve or disapprove the request shall constitute  
13 approval of the request.

14 3. Administrative review is available for the following:

15 *For the designated areas of the buildings, the addition or elimination of duct conduits,  
16 HVAC vents, grilles, fire escapes, pipes, and other similar wiring or mechanical elements  
17 necessary for the normal operation of the buildings.*

18 Section 3. INCENTIVES

19 A. Seattle Municipal Code Title 23 provides for authorization of uses in a designated  
20 Landmark that are not normally permitted in a particular zoning classification by means  
21 of an administrative conditional use.

22 B. Building and Energy Code exceptions on an application basis.

23 C. The availability of the Historic Preservation Special Tax Valuation (Chapter 84.26 RCW)  
24 to all Seattle landmarks subject to controls imposed by designation ordinance, on an  
25 application basis.







12 its approval by the Mayor, but if not approved and returned by the Mayor within ten (10) days  
13 after presentation, it shall take effect as provided by Municipal Code Section 1.04.020.



WHEREAS, on April 4, 2001, the Board and the owners of the designated property agreed to controls and incentives; and

WHEREAS, the Board recommends to the City Council approval of controls and incentives; NOW, THEREFORE,

### BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. DESIGNATION: The designation by the Landmarks Preservation Board of the North East Library, and its site, described as:

N 132 FT of the South 822 FT of that portion of the Southeast Quarter of Section 4T 25 N, 2 4E WM lying West of 35th Avenue NE and East of the East Line of the strip of land conveyed to the City of Seattle for alley by deed recorded in King Co. under Auditor's File No. 3368323, records of said county, said alley being a production of the alley in Block 1, Roosevelt Heights 2nd Addition according to the plot thereof recorded in Volume 33 of Plats, page 37, Records of King Co.

as a Landmark based upon satisfaction of the following standards of SMC Section 25.12.350:

D. It embodies the distinctive visible characteristics of an architectural style, or period, or of a method of construction;

E. It is an outstanding work of a designer or builder;

is hereby acknowledged.

Section 2. CONTROLS: The following controls are hereby imposed on the features and characteristics of the North East Library and its site that were designated by the Board for preservation:

#### A. CERTIFICATE OF APPROVAL PROCESS

1. A Certificate of Approval, issued by the City of Seattle's Landmarks Preservation Board pursuant to Seattle Municipal Code, 25.12, must be obtained, or the time for denying a Certificate of Approval application must have expired, before the owner may make alterations or significant changes to:

**The site, the exterior of the building, and the interior of the building excluding floor coverings, movable furniture and book stacks.**

2. A Certificate of Approval is not required for the following:

a. Any in-kind maintenance or repairs of the features listed in subsection 1, and

b. The removal of existing partition walls
