ORDINANCE NO. 12141

AN ORDINANCE providing for the laying off, widening, extending and establishing of Stone Avenue, in the City of Seattle, between Ewing Street, as established by Ordinance No. 9460, and the intersection of North Fiftieth Street and Interlake Avenue, over and across certain lands in Sections Seven (7) and Eighteen (18), Township Twenty-five (25) North, Range Four (4) East, W.M., and providing for the taking and damaging of land and other property necessary therefor, and for the ascertainment and payment of the just compensation to be made for the private property to be taken or damaged for said purpose, and for an assessment upon the property benefited for the purpose of making such compensation.

WHEREAS a public necessity demands that Stone Avenue, be laid off, widened, extended and established as a public street and highway, in the City of Seattle, as herein provided, and that the same will be of special benefit to certain lands and other premises adjoining, contiguous and proximate thereto, NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:---

Section 1. That Stone Avenue, in the City of Seattle, be, and the same is, hereby laid off, widened, extended and established as a public street and highway over and across certain portions of land in Sections Seven (7) and Eighteen (18), Township Twenty-five (25) North, Range Four (4) East, W.M., more particularly described as follows:

Across Blocks One (1), Two (2), Seven (7), Ten (10), Fifteen (15), Eighteen (18), and Nineteen (19), Porterfield's Addition to the City of Seattle, as follows;

Across Block One (1). Beginning at a point on the south line of Block (1), said point being three-tenths (.3) of a foot east of the southwest corner of said block; thence northeasterly to a point on the north line of said block, said point being seventy-eight and seventy-three hundredths (78.73) feet east of the northwest corner of said block; thence southerly along the west line of said block to the southwest corner thereof; thence easterly along the southline of said block three-tenths (.3) of a foot to the point of beginning, excepting from such descrip-

tion all that portion of said block owned or occupied by the Seattle Electric Company for street railway purposes.

Across Block Two (2). Beginning at the southeast corner of said Block Two (2); thence northerly along the east line of said block, ninety-three and forty-one hundredths (93.41) feet; thence southwesterly to a point on the south line of said block, said point being thirty-six and sixty-three hundredths (36.63) feet west of the southeast corner thereof; thence easterly along the south line of said block, thirty-six and sixty-three hundredths (36.63) feet to the point of beginning.

Across Block Seven (7). Beginning at a point on the south line of said Block (7), said point being forty-one and sixty-four hundredths (41.64) feet west of the southeast corner of said block; thence northeasterly to a point on the east line of said block, said point being ninety-three and seventy-eight hundredths (93.78) feet south of the north line of said block; thence northerly along the east line of said block, ninety-three and seventy-eight hundredths (93.78) feet to the northeast corner thereof; thence westerly along the north line of said block, sixty and sixteen hundredths (60.16) feet; thence southwest-erly to a point on the south line of said block, said point being one hundred thirty-eight and fifty-eight hundredths (138.58) feet west of the southeast corner of said block; thence easterly, along the south line of said block to a point, said point being forty-one and sixty-four hundredths (41.64) feet west of the southeast corner of said block and the point of beginning.

Across Block Ten (10). A strip of land ninety (90) feet in width (measured at right angles) being forty-five (45) feet on each side of the following described center line: Beginning on the south line of said block at a point one hundred seven and ninety-two hundredths (107.92) feet east of the southwest corner of said block; thence northeasterly to a point on the north line of said block, said point being one hundred eighty-six and thirty-five hundredths (186.35) feet west of the northwest corner of said block.

Across Block Fifteen (15). Beginning at a point on the south line of said Block Fifteen (15), said point being fifty-four and forty-three hundredths (54.43) feet east from the southwest corner thereof; thence northeasterly to a point on the north line of said block, said point being one hundred thirty-two and eighty-six hundredths (132.86) feet east from the northwest corner of said block; thence westerly along the north line of said block to a point, said point being thirty-

five and ninety-three hundredths (35.93) feet east of the northwest corner thereof; thence southwesterly to a point on the west line of said block, said point being ninety-one and sixty-one hundredths (91.61) feet south of the northwest corner of said block; thence southerly along the west line of said block to the southwest corner thereof; thence easterly along the south line of said block, fifty-four and forty-three hundredths (54.43) feet to the point of beginning.

Across Block Eighteen (18). Beginning at a point on the south line of said Block Eighteen (18), said point being ten and thirty-nine hundredths (10.39) feet east of the southwest corner thereof; thence northerly, a distance of one hundred seventy-four and nine hundredths (174.09) feet to a point in said block, said point being fourteen and seventy-seven hundredths (14.77) feet east of the west line of said block; thence northeasterly, a distance of twenty-two and fifty-eight hundredths (22.58) feet, more or less, to a point on the north line of said block, said point being twenty-three and six hundredths (23.06) feet easterly from the northwest corner thereof; thence southerly along the west line of said block to the southwest corner thereof; thence easterly, a distance of ten and thirty-nine hundredths (10.39) feet to the point of beginning.

Across Block Nineteen (19). Beginning at the southeast corner of said Block Nineteen (19), thence northerly along the east line thereof to the northeast corner of said block; thence westerly along the north line of said block, thirteen and eighty-seven hundredths (13.87) feet; thence southwesterly, a distance of two and thirty-five hundredths (2.35) feet to a point in said block, said point being fourteen and eight-one hundredths (14.81) feet westerly from the east line of said block; thence southerly to a point on the south line of said block, said point being nineteen and sixty-six hundredths (19.66) feet westerly from the southeast corner of said block; thence easterly along the south line of said block, nineteen and sixty-six hundredths (19.66) feet to the point of beginning.

S E C O N D.

Across Blocks Two (2), Three (3), Six (6), Seven (7), and Eleven (11), Smith & Burns Addition to the City of Seattle, described as follows:

Across Block Two (2). Beginning at a point on the south line of said block, said point being three and seventy-three hundredths (3.73) feet east of the southwest corner of said block; thence northerly to a point on the north line of said block, said point being eight and sixty-three hundredths (8.63) feet east of the northwest corner of said block; thence westerly along the north line of said

block eight and sixty-three hundredths (8.63) feet to the northwest corner thereof; thence southerly along the west line of said block to the southwest corner thereof; thence easterly along the south line of said block, three and seventy-three hundredths (3.73) feet to the point of beginning.

Across Block Three (3). Beginning at the southeast corner of said block, thence northerly along the east line to the northeast corner thereof; thence westerly along the north line of said block, twenty-one and forty-two hundredths (21.42) feet; thence southerly to a point on the south line of said block, said point being twenty-six and thirty-two hundredths (26.32) feet west of the southeast corner of said block; thence easterly along the south line of said block twenty-six and thirty-two hundredths (26.32) feet to the point of beginning.

Across Block Six (6). Beginning at the southeast corner of said block; thence northerly along the east line to the northeast corner thereof; thence westerly along the north line of said block, twenty-seven and eight-five hundredths (27.85) feet; thence southerly to a point on the south line of said block, said point being thirty-three and eight hundredths (33.08) feet westerly from the southeast corner of said block; thence easterly along the south line of said block thirty-three and eight hundredths (33.08) feet to the point of beginning.

Across Block Seven (7). Beginning at a point on the west line of said block, said point being eighty-four and nine hundredths (84.09) feet south of the northwest corner of said block; thence northerly to a point on the northline of said block, said point being two and twenty hundredths (2.20) feet east of the northwest corner of said block; thence westerly along the north line of said block, two and twenty hundredths (2.20) feet to the northwest corner thereof; thence southerly along the west line of said block, eighty-four and nine hundredths (84.09) feet to the point of beginning.

Across Block Eleven (11). Beginning at the southeast corner of said block, thence northerly along the east line of said block to the northeast corner thereof; thence westerly along the north line of said block, a distance of thirty-four and sixty-two hundredths (34.62) feet; thence southerly to a point on the south line of said block, said point being thirty-seven and forty-seven hundredths (37.47) feet westerly from the southeast corner of said block; thence easterly along the south line of said block thirty-seven and forty-seven hundredths (37.47) feet to the point of beginning.

Beginning at the northwest corner of Lot Eleven (11), Block One (1), C.P. Stone's Home Addition to the City of Seattle; thence easterly along the north line of said Lot Eleven (11), two and thirty-one hundredths (2.31) feet; thence northerly to a point on the south line of Block Nine (9), Edgewater Addition to the City of Seattle, said point being three and three hundredths (3.03) feet east of the southwest corner thereof; thence westerly along the south line of said Block Nine (9) three and three hundredths (3.03) feet to the southwest corner thereof; thence southerly along the east line of Block One (1), C. Also, beginning at a point on the south line of North Forty-second Street, as established by the City of Seattle, said point being twenty-seven and six hundredths (27.06) feet west of a line parallel to and five hundred forty-four and fifty hundredths (544.50) feet east of the north and south center line of said Section Eighteen (18); thence southerly two hundred seventy-eight and three hundredths (278.03) feet, more or less, to a point on a line parallel to the east and west center line of said Section Eighteen (18), said parallel line being eleven hundred nine and ninety-two hundredths (1109.92) feet north of said center line; and said point being thirty-four and four hundredths (34.04) feet, west of a line parallel to and five hundred forty-four and fifty hundredths (544.50) feet east of the north and south center line of said Section Eighteen (18); thence easterly along a line parallel to the east and west center line of said Section Eighteen (18), thirty-four and four hundredths (34.04) feet; thence northerly along a line parallel to the north and south center line of said Section Eighteen (18), two hundred seventy-seven and seventy-nine hundredths (277.79) feet, more or less, to the south line of North Forty-second Street; thence westerly along the south line of said North Forty-second Street twenty-seven and six hundredths (27.06) feet to the point of beginning.

Also, beginning at the intersection of the south line of Kilbourne Street, as established by the City of Seattle with the center line produced south of Stone Avenue, as platted in Stone's Home Addition to the City of Seattle; thence westerly along the south line of said Kilbourne Street, thirty-four and seventy-two hundredths (34.72) feet; thence southerly six hundred fourteen and sixty-four hundredths (614.64) feet to a point said point being fifty-two and nineteen hundredths (52.19) feet west of the center line of said Stone Avenue, produced south, thence southwesterly

sixty-one and fifty-nine hundredths (61.59) feet, more or less, along the arc of a curve to the right, having a uniform radius of thirty-five (35) feet to a point on the north line of Ewing Street, as established by the City of Seattle, said point being one hundred ninety-seven and forty-six hundredths (197.46) feet southeasterly from the northeast corner of the intersection of Ewing Street and Woodland Park Avenue; thence southeasterly along the northerly line of said Ewing Street one hundred sixty-two and ninety hundredths (162.90) feet; thence northwesterly forty-eight and thirty-seven hundredths (48.37) feet along the arc of a curve to the right, having a uniform radius of thirty-five (35) feet to a point, said point being thirty-six and ninety-one hundredths (36.91) feet east of the center line of said Stone Avenue produced south; thence northerly, six hundred forty-seven and nine hundredths (647.09) feet, more or less, to a point on the south line of said Kilbourne Street, said point being fifty-five and thirty hundredths (55.30) feet east of the center line of said Stone Avenue produced South; thence westerly, along the south line of said Kilbourne Street, fifty-five and thirty hundredths (55.30) feet to the point of beginning.

Section 2. That all the lands, rights and privileges and other property within the limits of the above bounded and described tracts of land are hereby condemned and appropriated to the public use for the purpose of a public street, and the same to be taken and appropriated only after just compensation has been made or paid into Court for the owner in the manner provided by law.

Section 3. That the Corporation Counsel be, and he hereby is, authorized and directed, to file in the Superior Court of King County, State of Washington, a petition in the name of the City of Seattle, praying that just compensation to be made for the private property to be taken or damaged for the purpose of laying off, widening, extending and establishing of said Stone Avenue, as provided in Section One (1) hereof, "be ascertained by a jury or by the Court in case a jury be waived," which petition shall comply with the requirements of the Act of the Legislature of the State of Washington, entitled "An act to enable cities of the first class to exercise the right of eminent domain for the taking and damaging of land and other property, ~~providing a method for~~ providing a method for making compensation therefor and providing for special assessments in certain cases upon property benefited, and declaring an emergency," approved March 9th, 1893, and all such acts and proceedings shall be taken and done as are provided by said act.

Section 4. An assessment shall be made in the manner provided by the act of the Legislature for the purpose of raising the amount necessary to pay the compensation and damages which shall be awarded for the property taken as aforesaid, and for the costs of the proceedings, and such assessments shall be made subject to the provisions of said act of the Legislature upon all the property specially benefited.

Any part of the compensation, damages or costs that is not finally assessed against said property benefited shall be paid from the General Fund of the city.

For the purpose of said special assessment, a supplemental petition shall be filed in said Court, and all other acts and proceedings shall be taken and done for the making, completion and collection of said assessment as in said act of the Legislature provided.

Sec. 5. This Ordinance shall take effect and be in force from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the City Charter.
