ORDINANCE 122332

AN ORDINANCE appropriating money to pay certain audited claims and ordering the payment thereof.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

SECTION 1. Payment of the sum of Eighteen Million, Four Hundred Twenty Eight Thousand, Five Hundred Forty Six and 70/100 dollars (\$18,428,546.70) on Summit mechanical warrants numbered, 4001167163 - 4001170398, plus manual or cancellation issues for claims, and Electronic Financial Transactions (EFT) in the amount of Nineteen Million, Four Hundred Fifty Six Thousand, Three Hundred Eleven and 96/100 dollars, (\$19,456,311.96) are presented for ratification by the City Council per Chapter 42.23RCW.

SECTION 2. Payment of the sum of Twenty Eight Million, Three Hundred Forty Seven Thousand, Two Hundred Forty Three and 64/100 dollars (\$28,347,243.64) on City General Salary Fund mechanical warrants numbered 50960717 - 50962213 plus manual warrants, agencies warrants, and direct deposits numbered 20001 - 30054 representing Gross Payrolls for payroll ending date Jan. 9, 2007 as detailed in the Payroll Summary Report for claims against the City which were audited by the Auditing Committee and reported by said committee to the City Council on Jan. 18, 2007 consistent with appropriations heretofore made for such purpose from the appropriate Funds, is hereby approved.

SECTION 3. That any act consistent with the authority and prior to the effective date of this ordinance is hereby ratified and confirmed.

SECTION 4. This ordinance, being an ordinance required for the payment of salaries or current expenses shall take effect and be in force immediately upon its approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the City Charter.




