BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:


SECTION 1. Payment of the sum of Fourteen Million, Seven Hundred Fifteen Thousand, One Hundred Ninety One and 56/100 dollars (\$14,715,191.56) on Summit mechanical warrants numbered, 4001447691-4001451637, plus manual or cancellation issues for claims, and Electronic Financial Transactions (EFT) in the amount of Twenty Million, Eight Hundred Ninety Eight Thousand, Eight Hundred Eight and 87/100 dollars, (\$20,898,808.87) are presented for ratification by the City Council per Chapter 42.23RCW.



SECTION 2. Payment of the sum of Thirty One Million, Six Hundred Eighty Eight Thousand, Eight Hundred Forty Five and 48/100 dollars (\$31,688,845.48) on City General Salary Fund mechanical warrants numbered 51044078 – 51045631 plus manual warrants, agencies warrants, and direct deposits numbered 430001 – 440869 representing Gross Payrolls for payroll ending date Oct. 14, 2008 in the Payroll Summary Report for claims against the City which were audited by the Auditing Committee and reported by said committee to the City Council on Oct 23, 2008 with appropriations heretofore made for such purpose from the appropriate Funds, is hereby approved.

SECTION 3. That any act consistent with the authority and prior to the effective date of this ordinance is hereby ratified and confirmed.

SECTION 4. This ordinance, being an ordinance required for the payment of salaries or current expenses shall take effect and be in force immediately upon its approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the City Charter.


