ORDINANCE 123001

AN ORDINANCE related to the Restricted Parking Zone program to update and clarify the program; amending Sections 3.12.120, 11.14.515, 11.16.120(F) and (G), 11.16.315, 11.16.317, 11.16.319, 11.23.440, 11.28.010(D), 11.31.121, 11.72.351, 11.76.015, 15.04.112 and 23.44.041(A) of the Seattle Municipal Code; adding new Section 11.16.316; and repealing Sections 15.04.112 (B) and (C), 11.73.010-.040, and 11.73.080.

WHEREAS, Ordinance 108354 established the Restricted Parking Zone program in 1979, for many years known generally as the residential parking zone program (or RPZ program) to help ease parking congestion in residential neighborhoods, and Ordinance 122853 amended the resident identification permit fees to cover the increased cost of administration; and

WHEREAS, restricted parking zones (RPZs) are often located adjacent to generators of high traffic demand, such as universities, high schools, hospitals, transit stations or stops, and business districts in order to limit the impact of employees, transit commuters, and students parking their vehicles for lengthy time periods and thereby using parking that might otherwise be used by residents and area visitors; and

WHEREAS, as of March 2009, Seattle has 27 restricted parking zones that operate seven days a week at varying days and hours, and the Seattle Department of Transportation (SDOT) issues approximately 17,000 RPZ permits annually; and

WHEREAS, as part of this ordinance to update and clarify the RPZ program, Seattle Municipal Code Sections 11.73.010-.040 and 11.73.080 are repealed; however, while the Director of SDOT continues to have the authority to create, modify or dissolve RPZs as needed, repeal of SMC 11.73.010-.040 and 11.73.080 is not intended to affect the validity of existing RPZs, which the SDOT Director intends to retain as valid RPZs. The boundaries of these zones can be reviewed at the SDOT RPZ permit counter; and

WHEREAS, SDOT initiated a major policy review starting in 2007 to redesign the existing RPZ program to better achieve the City of Seattle's goals in areas of parking management, transportation, economic development, social equity, and sustainability; and

WHEREAS, SDOT conducted a broad-based community engagement effort to generate feedback on draft recommendations issued in August 2008. As part of this effort, SDOT disseminated draft RPZ policy review recommendations to citizens, sought feedback from a broad range of stakeholders to help inform decisions, and, after an 80-day comment period, received over 500 comments from variety of residents, business owners and others;

1 WHEREAS, exceptions may be needed to the four-permit per household limit for those land use
2 zones that permit dwelling units that allow well in excess of eight unrelated occupants to
reside as part of one household unit; and

3 WHEREAS, the proposed amendments to the RPZ program are intended to support the
4 following four objectives: reduce traffic impacts to neighborhoods from commuters who
5 park around large parking demand generators; support mixed-use neighborhoods and
6 local business districts by creating a pilot program for businesses and institutions and by
7 broadening the community engagement program; continue to encourage a reduction in
8 overall energy use and vehicle emissions by discouraging non-residents from parking in
9 RPZ areas; and implement simple rules that are easily understood and clearly applied;
and, NOW, THEREFORE,

10 **BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:**

11 Section 1. Section 3.12.120, as last amended by Ordinance 121420, is amended as
12 follows:

13 **SMC 3.12.120 Disposition of permit fees.**

14 Fees collected by the Seattle Department of Transportation for permits or other means
15 of extending parking privileges in any restricted parking zone, as authorized in Seattle Municipal
16 Code Section ~~((11.16.315))~~ 11.16.120, shall be deposited in the Seattle Department of
17 Transportation Operating Fund for the purpose of reimbursing ongoing operating costs of
18 ~~((residential))~~ restricted parking zones.
19

20
21 Section 2. Section 11.14.515, as last amended by Ordinance 108354 is amended as
22 follows:

23 **SMC 11.14.515 Definitions ~~((Restricted parking zone.))~~**

24 ~~("Restricted parking zone" means a portion of the street commonly used for vehicular~~
25 ~~parking, which except as to vehicles displaying a card or decal issued pursuant to RCW~~
26 ~~46.16.380 is:~~
27

2 ~~A. Reserved for the exclusive use of vehicles owned or used by residents of the~~
3 ~~abutting property and/or in the discretion of the Board, residents in the prescribed vicinity, and~~
4 ~~vehicles used by their visitors; and service vehicles of persons having business in the street or~~
5 ~~with abutting or nearby residents;~~

6
7 ~~B. Reserved for such exclusive use during certain hours; or~~

8
9 ~~C. Subject to time limits that apply to parking of all vehicles except vehicles owned or~~
10 ~~used by such residents, or their visitors, or service vehicles of persons having business in the~~
11 ~~street or with the residents.))~~

12
13 A. "Business" means any business that possesses a valid City of Seattle business
14 license and where commercial work occurs on premises, including but not limited to, retail sales
15 and service, warehouse, non-household sales and service, or entertainment.

16
17 B. "Employee" means any individual who performs work, labor, or services and is on
18 the payroll of a business or institution. This includes all full-time, part-time and temporary
19 employees including partners of the business or institution located in or adjacent to an RPZ.

20
21 C. "Guest" means a person temporarily visiting residents or temporarily having
22 business with residents who are eligible for RPZ permits.
23
24
25
26
27
28

1 D. "Guest Permit" means a card, decal or other identification issued to an eligible
2 person to be placed in the vehicle that enables it to park in a restricted parking zone, for an
3 annual, biennial or single-day timeframe.

4
5 E. "Household Unit" means any self-contained house, apartment, condominium, town
6 house, floating home, detached or attached accessory dwelling unit, or group house that contains
7 living, sleeping and cooking quarters and is used by of any number of related persons or up to
8 eight unrelated individuals. For the purpose of this chapter, each unit of multiple-unit residential
9 dwelling is considered a separate household unit.

10
11 F. "Institution" means any organization of a public character, including but not limited
12 to, a school, hospital, religious facility, health care, social or community service agency, library,
13 university, or museum.

14
15 G. "Resident" means any person residing in a household unit that is located adjacent to
16 or in a prescribed vicinity of a restricted parking zone.

17
18 H. "Restricted parking zone" or "RPZ" means a portion of the street commonly used
19 for vehicular parking where vehicles properly displaying a permit or other authorization pursuant
20 to Chapter 11.16 SMC shall be exempt from the posted RPZ parking restrictions. This program
21 does not apply to vehicles displaying a card or decal issued pursuant to RCW 46.16.381.

22
23
24 I. "RPZ Permit" means a card, decal or other identification issued to an eligible person
25 to be placed on the vehicle that enables it to park in a restricted parking zone.

1 J. "Volunteer" means any individual who performs volunteer work for a business or
2 institution at least three times a week.

3 Section 3. Subsections F and G of 11.16.120, as last amended by Ordinance 121388,
4 are amended as follows:

5 **SMC 11.16.120 Director of Transportation -- Authority.**

6 The Director of Transportation is authorized:

7 ***

8 F. To establish, revise or abolish restricted parking zones. A decision to establish, or to
9 refuse to establish, a restricted parking zone is subject to ~~((review or))~~ reconsideration pursuant
10 to SMC Section 11.16.317~~((B))~~D. The Director may consider other parking demand management
11 tools in lieu of or prior to implementation of an RPZ. A restricted parking zone may have one (1)
12 or more of the following components:

13 1. Parking in the street is reserved for the exclusive use by those vehicles displaying a
14 valid RPZ permit, guest permit, or other identification issued by the Seattle Department of
15 Transportation as part of the RPZ program; or

16 2. Parking in the street is reserved during certain posted hours for exclusive use by
17 vehicles displaying a valid RPZ permit, guest permit, or other identification issued by the Seattle
18 Department of Transportation as part of the RPZ program and available at all other times without
19 restriction; or

1 3. Time limits are established for parking in the street that applies to all vehicles except
2 vehicles with valid RPZ permit, guest permit, or other identification issued by the Seattle
3 Department of Transportation as part of the RPZ program.

4
5 G. To promulgate rules and regulations for the RPZ program. ~~((use of restricted~~
6 ~~parking zones and the issuance or revocation of permits in accordance with the provisions of the~~
7 ~~Administrative Code (SMC Chapter 3.02).))~~

8
9 Section 4. Section 11.16.315, as last amended by Ordinance 121678, is amended as
10 follows:

11
12 **SMC 11.16.315 ~~((Authority for, a))~~ Administration of, restricted parking zones.**

13
14 ~~((A. The Director of Transportation may establish a restricted parking zone, consistent~~
15 ~~with Section 11.16.317 and according to the Policies and Procedures Concerning the~~
16 ~~Implementation of Residential Parking Zones. A restricted parking zone may have one (1) or~~
17 ~~more of the following provisions:~~

18
19 1. ~~Parking in the street is reserved for the exclusive use by the owners of abutting~~
20 ~~properties and/or residents in a prescribed vicinity; vehicles used by their visitors; and service~~
21 ~~vehicles of persons having business in the street or with the residents; and/or~~

22
23 2. ~~Parking in the street is reserved during certain posted hours for such exclusive use~~
24 ~~and available at all other times without restriction; and/or~~

1 ~~3. Time limits are established for parking in the street which apply to all vehicles~~
2 ~~except vehicles owned by or used by such residents, their visitors or service vehicles of persons~~
3 ~~having business in the street or with the residents; provided, that each restricted parking zone~~
4 ~~shall be subject to review by the Director of the Transportation after its first six (6) months of~~
5 ~~operation.))~~

6
7 A. Signage: Restricted parking zones shall be appropriately signed and/or marked.

8
9 B. Administration: In any restricted parking zone, the Director of Transportation or his
10 or her designee may issue permits or other means of identification, maintain lists of vehicles
11 owned or used by permit holders ~~((residents))~~, or adopt any other reasonable means of
12 distinguishing ~~((, from other vehicles,))~~ vehicles that are~~((may-))~~ validly ~~((be))~~ parked in a
13 ~~((any))~~ restricted parking zone. ~~((Restricted parking zones shall be appropriately signed and/or~~
14 ~~marked.))~~

15
16
17 1. A permit shall not guarantee or reserve to the holder an on-street parking
18 space within the designated RPZ.

19
20 2. If issued to a resident, a permit must be used within six contiguous city
21 blocks of the household unit address or, if issued to a business or institution, a
22 permit must be used within six contiguous city blocks of the place of business
23 or the institution.

24
25 C. Application: In order to obtain an RPZ permit, any applicant shall present proof of
26 residency in or adjacent to the restricted parking zone boundary in addition to submittal of a
27

1 complete application to the Seattle Department of Transportation. As of January 1, 2010, any
2 applicant must also present proof that the address of vehicle registration matches the applicant's
3 household unit address or that the applicant is an out of state non-resident or active military
4 personnel.

5
6 D. Permit Limit: As of January 1, 2010, each eligible household unit is entitled to
7 obtain no more than four permits per permit cycle.

8 1. Exception: The Director of Transportation may issue more RPZ permits than the
9 four-permit limit per household for the following land uses:

- 10
11 a. Adult family home;
12 b. Assisted living facility;
13 c. Domestic violence shelter; and
14 d. Permitted congregate residence.

15
16 In determining whether to grant additional permits in excess of the four-permit per household
17 limit, the Director of Transportation may also consider the availability of on-street parking in the
18 requestor's residential area and demonstrated need for additional permits.

19
20 E. Guest Permits. Each eligible resident may obtain no more than one annual or
21 biennial guest permit per household unit. It is illegal to use a guest permit on a resident's vehicle.
22 As of January 1, 2010, eligible residents may obtain a limited number of single-day use guest
23 permits.

24
25
26 F. Motorcycles and Scooters. As of January 1, 2010, motorcycles and scooters are
27 authorized to park in an RPZ without an RPZ permit.

1 Section 5. A new section, 11.16.316, of the Seattle Municipal Code is hereby added:

2 **SMC 11.16.316 Restricted Parking Zone Permits for Use by Businesses – Pilot**

3 A. The purpose of this section is to authorize the Director of Transportation or his or
4 her designee to create a specific program for qualified businesses and institutions to apply for
5 and receive restricted parking zone permits to park in a restricted parking zone in the Initial
6 Segment LINK Light Rail transit station areas, including Rainier Beach, Othello, Columbia City,
7 Mount Baker, Beacon Hill, SODO and Stadium stations. This is in addition to permits issued to
8 qualified residents in these RPZs.

9
10
11 B. The Director of Transportation or his or her designee is authorized to establish rules
12 and regulations for this pilot program, including permit eligibility, application submittal for
13 qualifying businesses and institutions, permit use, and alternate eligibility procedures as needed,
14 following the goals set forth in subsection D.

15
16
17 C. To inform communities about the intended creation of an RPZ in the LINK station
18 areas and to obtain public comment, Seattle Department of Transportation shall convene a series
19 of community meetings for the proposed zones prior to installation.

20
21 D. The purpose of the pilot program is to determine whether issuance of RPZ permits
22 to businesses or institutions and their employees assists the Seattle Department of Transportation
23 in reaching the following goals: reduce neighborhood traffic impacts by large parking demand
24 generators; support mixed-use neighborhoods and local business districts; continue to reduce
25 overall energy use and vehicle emissions; keep demand by residents and businesses (including
26

1 institutions) from exceeding available on-street parking spaces in residential areas; and,
2 implement a customer-oriented permit program.

3 E. In order to be issued a restricted parking permit, the permit holder must be an owner,
4 employee, or volunteer of a business or institution within or adjacent to an RPZ boundary.
5 Property owners for a business or institution within or adjacent to an RPZ boundary can also
6 obtain one permit per owner.

7
8 F. Permit holders who violate this section or the RPZ program rules may have their
9 permit revoked and may be excluded from obtaining future permits.

10 G. The Director of Transportation or his or her designee shall present a report to the
11 City Council two (2) and four (4) years after the pilot program becomes effective. The report
12 shall evaluate the pilot program relative to goals listed in subsection D. The biennial reports are
13 intended to assist Council in determining whether to continue the program for qualified
14 businesses and institutions located within the RPZs in the Initial Segment LINK Light Rail
15 transit station areas, including Rainier Beach, Othello, Columbia City, Mount Baker, Beacon
16 Hill, SODO and Stadium stations.

17
18 H. The Seattle Department of Transportation will annually monitor and survey RPZs
19 established under this pilot to determine utilization of parking spaces by residents and area
20 businesses and institutions within each of the pilot RPZs. The Seattle Department of
21 Transportation shall cease to renew RPZ permits for businesses and institutions in the next RPZ
22 cycle for an RPZ, excluding the SODO and Stadium station RPZs, when the annual monitoring
23 or survey of the RPZ indicate that twenty-five (25) percent or more of streets within any
24 particular RPZ have the following conditions: (1) at least seventy-five (75) percent of the
25 capacity of the street available for parking is generally occupied and (2) more than thirty-five
26
27
28

1 (35) percent of the vehicles parked on the street are owned by non-residents of the designated
2 area. In this subsection, the term “non-resident” includes businesses and institutions located in
3 the area.

4 I. The pilot program is intended to be in place no longer than four (4) years after its
5 creation. In determining whether to continue the pilot, either as a pilot or permanent program, or
6 discontinue it at the end of the four year period, the Council will consider the Seattle Department
7 of Transportation biennial reports.

8 J. The Seattle Department of Transportation shall not consider expansion of the pilot to
9 any other RPZs established in the City of Seattle except those RPZs located in the Initial
10 Segment LINK Light Rail transit station areas, including Rainier Beach, Othello, Columbia City,
11 Mount Baker, Beacon Hill, SODO and Stadium stations.

12
13
14 Section 6. Section 11.16.317, as last amended by Ordinance 118409, is amended as
15 follows:

16 **SMC 11.16.317 Establishing, expanding, ~~(and)~~ reducing, and dissolving**
17 **restricted parking zones**

18 A. The Director of Transportation or his or her designee shall consider whether a
19 restricted parking zone, within a designated area, would promote certain benefits or would result
20 in adverse impacts.

21
22
23 1. Benefits that may lead to establishing an RPZ may include, but are not limited to:
24 increased access for area residents, reduced traffic congestion, increased traffic or pedestrian
25 safety, reduced air or noise pollution, reduced commuter parking in neighborhoods, prevention
26 of blighted areas, and promoting the use of alternative modes of transportation.

2. Adverse impacts that may prevent implementation include, but are not limited to:

transferring a parking problem to a different area, inability to effectively enforce program restrictions, lack of alternative transportation modes, and availability of simpler, cheaper or more effective solutions.

3. Regardless of potential benefits or adverse impacts that may result from creating an RPZ in any downtown zone including all zones contained in Map 1A of Ch. 23.49 SMC, the Seattle Department of Transportation will not install RPZs in such zones, in part, because of high demand and multiple, competing needs for on-street parking.

~~((A.))~~ B. The Director of Transportation may establish a new or expand an existing restricted parking zone whenever seventy-five (75) percent or more of the capacity of the streets available for parking on ten (10) contiguous blocks (and/or twenty (20) block faces) in such designated area is generally occupied; ~~((during regular business hours or any consecutive eight (8) hour period during evenings or during any consecutive eight (8) hour period on both Saturdays and Sundays; at least twenty-five (25))~~ over thirty-five (35) percent of the vehicles parked on the street in the area ~~((during such hours))~~ are not owned by residents of the designated area; ~~((a petition signed by, or))~~ a strong and effective community engagement effort ~~((survey))~~ indicating that ~~((;))~~ generally ~~((a majority of the residents))~~ stakeholders in the designated area have reviewed and support ~~((approves))~~ the restricted parking zone, which could include a petition signed by a majority of the residents in the designated area in support of the restricted parking zone; and the public interest would be served. In cases where the criteria listed above are not ~~((all))~~ met, the Director of Transportation is authorized to establish a

1 restricted parking zone when, in his or her judgment, the parking problem will be ameliorated
2 by a restricted parking zone and the public interest would be served.

3 C. The Director of Transportation or his or her designee is authorized to engage
4 affected and interested community stakeholders to review and assist in refining any future RPZ
5 proposals.

6
7
8 1. The public information and involvement program may include department
9 presentations to business and community organizations, information distribution through the
10 City's web site, news releases and related media, direct mailings of informational materials,
11 facilitated meetings, sounding boards, walking tours, surveys, and other techniques as
12 appropriate to the scale of the proposal.

13
14 2. Prior to the Director of Transportation's decision to establish or not to establish, or
15 dissolve an RPZ, or to expand or reduce an RPZ by more than two (2) contiguous blocks, the
16 Seattle Department of Transportation shall hold an administrative public hearing where it will
17 provide interested persons an opportunity to submit written and spoken comment into the public
18 record.

19
20
21 3. The Seattle Department of Transportation shall mail a copy of a notice of hearing at
22 least twenty (20) days prior to the public hearing. The notice of hearing must contain a statement
23 of the hearing time and location and it must be sent to all owners, commercial lessees and
24 residents of property that lies within three hundred feet (300') of the affected restricted parking
25 zone.

1 4. The Seattle Department of Transportation shall publish the notice of hearing in a
2 local newspaper that states the hearing time and location at least twenty (20) days prior to the
3 public hearing.

4
5
6 ~~((B.))~~D.

7
8 1. The Director of Transportation's decision to establish or not to establish, or to
9 expand, reduce, or dissolve a restricted parking zone may be subject to ~~((review or))~~
10 reconsideration within fifteen (15) days of publication in ~~((the Seattle Daily Journal of~~
11 ~~Commerce and/or))~~ a local newspaper. Requests for ~~((review or))~~ reconsideration may be
12 initiated, in writing, by residents, business owners, employees or volunteers in or adjacent to the
13 proposed RPZ. On ~~((review or))~~ reconsideration, the Director ~~((, or his or her designee,))~~ shall
14 ~~((conduct a public hearing before the Director makes a final decision))~~ designate a review
15 officer, who shall, after reviewing the reconsideration materials and other relevant information,
16 make a recommendation to the Director. The Director may, at his or her discretion, stay
17 implementation of a decision pending review. The Director shall have thirty (30) days to issue a
18 Decision. The Director's decision on reconsideration shall be final unless appealed to the Office
19 of the Hearing Examiner under subsection (D) (2). Grounds for ~~((review or))~~ reconsideration
20 may include the validity of ~~((the))~~ any parking study ~~((; the stringency of the parking restrictions;~~
21 ~~the boundaries of the restricted parking zone; and violations of Policies and Procedures~~
22 ~~Concerning the Implementation of Residential Parking Zones.))~~ or compliance with the process
23 to establish a zone.

1 2. The Director's decision on reconsideration may be appealed to the Office of the
2 Hearing Examiner.

3 i) Time limit for initiation of an appeal. A notice of appeal shall be filed with the
4 Hearing Examiner within twenty (20) days following issuance of the Director's Decision on
5 Reconsideration.

6 ii) Form of Appeal. The notice of appeal must contain a brief statement of the issues on
7 appeal, the specific objections to the decision being appealed, along with supporting facts and
8 documentation, and the relief sought. The notice of appeal must list the name of the appellant,
9 and the signature, address, phone number, and fax or e-mail address if available, of the Person
10 appealing.

11 iii) Decision. After reviewing the notice of appeal and supporting documentation and
12 conducting a hearing, the Examiner shall issue a written decision within thirty (30) days after
13 conclusion of the hearing (or submission of the notice of appeal). The written decision shall
14 contain the reasons for the decision and the provisions for further appeal and shall be mailed to
15 the Person appealing by first class mail with proof of mailing attached and a copy retained in the
16 Examiner's files. This decision is the final decision of the City.

17
18
19 ~~((C.))~~E. The Director may modify hours of an existing RPZ or expand or reduce
20 boundaries of an existing RPZ by two (2) contiguous blocks or less by following an
21 administrative process that seeks to identify possible changes as suggested by the community,
22 review proposed changes to the RPZ with affected community stakeholders, and make a
23 determination for what best serves the public interest, without holding the public hearing
24 required in SMC 11.16.317(C)2. ~~((consistent with Policies and Procedures Concerning the~~
25 Implementation of Residential Parking Zones.))

1 ~~(D-))~~F. A restriction of parking shall take effect on a street segment when it is signed
2 or posted, and shall cease when the signs or posting are removed pursuant to lawful order;
3 provided, that vandalism or destruction of parking control signs shall not affect the validity of a
4 restriction upon parking on any street segment designated by the Director of Transportation if
5 other signs or traffic control devices give notice that parking in the street segment is restricted.
6

7 G. The Director may initiate dissolution of an RPZ when he or she determines that it
8 best serves the public interest and meets at least one of the following criteria, including but not
9 limited to, low permit sales in a zone, a small number of blocks with RPZ signs, or the original
10 traffic generator no longer exists. The zone would be removed at the beginning of a new permit
11 cycle.
12

13 Section 7. Section 11.16.319, as last amended by Ordinance 122853, is amended as
14 follows:
15

16 **SMC 11.16.319 Fees for restricted parking zone permits; Waiver or reduction of fees.**

17 A. The parking fees to be collected by the Seattle Department of Transportation for
18 restricted parking zone permits are as follows.
19

22	Temporary permit	\$10.00 for first 60-day period;
23		\$15.00 for second 60-day period

whenever:

1. the waiver or reduction is in the overall public interest due to extraordinary facts or circumstances,

2. the waiver or reduction is consistent with the goals of the RPZ program, or

3. dire consequences may result if the request is denied.

Section 8. Section 11.23.440, as last amended by Ordinance 108200, is amended as follows:

No person shall be granted a franchise or special privilege to the exclusion of any other like person for parking vehicles on any roadway. 



AN ORDINANCE related to the Restricted Parking Zone program to update and clarify the program, amending Sections 3.12.120, 11.14.515, 11.16.120(F) and (G), 11.16.315, 11.16.317, 11.16.319, 11.23.440, 11.28.010(D), 11.31.121, 11.72.351, 11.76.015, 15.04.112 and 23.44.041(A) of the Seattle Municipal Code; adding new section 11.16.316; and repealing Sections 15.04.112 (B) and (C), 11.73.010-.040, and 11.73.080.

• **Summary of the Legislation:**

Related to the City's Restricted Parking Zone (RPZ) program, this Ordinance proposes substantive and house-keeping changes to the Seattle Municipal Code to ensure better parking management for residential and mixed-use Seattle neighborhoods. The Ordinance covers RPZ and guest permit eligibility; payment of permit fees for new or expanded Major Institutions; zone creation and modification processes; parking enforcement; and customer service improvements for permit issuance.

• **Background:** *(Include brief description of the purpose and context of legislation and include record of previous legislation and funding history, if applicable):*

The RPZ program designates on-street parking for residents, their guests, service vehicles, and short-term visitor parking to reduce traffic impacts from nearby major institutions, transit stations, and business districts. As of March 2009, SDOT maintains 27 RPZs and issues approximately 17,000 permits. In 2007, SDOT initiated a major policy review to revise the RPZ program, last reviewed in 1994. Staff collected other cities' best practices and gathered community input. Current RPZ policy and technical requirements have, in some situations, fallen short of capturing complexities of business and residential districts' parking issues.

In mid-2008, SDOT conducted an extensive public engagement effort to gather feedback on draft recommendations. Staff received over 500 email comments and attended 15 community meetings in and around RPZ areas.

Based on review of public comments and best parking management practices, SDOT finalized and is concurrently releasing the Final RPZ Policy Review Recommendations. This proposed Ordinance contains the necessary substantive and house-keeping legislative changes to the Seattle Municipal Code to implement the Final Recommendations.

- Implement simple rules that are easily understood and clearly applied



SDOT conducted extensive community outreach on draft recommendations. With the proposed legislation, SDOT expects to have better parking management tools to resolve complex parking issues in residential and mixed-use neighborhoods.

This Council Bill proposes changes to the Seattle Municipal Code on the following issues:

- RPZ and guest permit eligibility;
- Major Institutions RPZ policy;
- RPZ zone creation, modification and removal process; and
- Parking enforcement and customer service for permit issuance.

8 WHEREAS, Ordinance 108354 established the Restricted Parking Zone program in 1979, for
9 many years known generally as the residential parking zone program (or RPZ program)
10 to help ease parking congestion in residential neighborhoods, and Ordinance 122853
11 amended the resident identification permit fees to cover the increased cost of
12 administration; and

13 WHEREAS, restricted parking zones (RPZs) are often located adjacent to generators of high
14 traffic demand, such as universities, high schools, hospitals, transit stations or stops, and
15 business districts in order to limit the impact of employees, transit commuters, and
16 students parking their vehicles for lengthy time periods and thereby using parking that
17 might otherwise be used by residents and area visitors; and

18 WHEREAS, as of March 2009, Seattle has 27 restricted parking zones that operate seven days a
19 week at varying days and hours, and the Seattle Department of Transportation (SDOT)

25 C. Application: In order to obtain an RPZ permit, any applicant shall present proof of
26 residency in or adjacent to the restricted parking zone boundary in addition to submittal of a
27



1 complete application to the Seattle Department of Transportation. As of January 1, 2010, any
2 applicant must also present proof that the address of vehicle registration matches the applicant's
3 household unit address or that the applicant is an out of state non-resident or active military
4 personnel.

5
6 D. Permit Limit: As of January 1, 2010, each eligible household unit is entitled to
7 obtain no more than four permits per permit cycle.

8 1. Exception: The Director of Transportation may issue more RPZ permits than the
9 four-permit limit per household for the following land uses:

- 10
11 a. Adult family home;
12 b. Assisted living facility;
13 c. Domestic violence shelter; and
14 d. Permitted congregate residence.

15
16 In determining whether to grant additional permits in excess of the four-permit per household
17 limit, the Director of Transportation may also consider the availability of on-street parking in the
18 requestor's residential area and demonstrated need for additional permits.

19
20 E. Guest Permits. Each eligible resident may obtain no more than one annual or
21 biennial guest permit per household unit. It is illegal to use a guest permit on a resident's vehicle.
22 As of January 1, 2010, eligible residents may obtain a limited number of single-day use guest
23 permits.

24

26 F. Motorcycles and Scooters. As of January 1, 2010, motorcycles and scooters are
27 authorized to park in an RPZ without an RPZ permit.



1 Section 5. A new section, 11.16.316, of the Seattle Municipal Code is hereby added:

2 **SMC 11.16.316 Restricted Parking Zone Permits for Use by Businesses – Pilot**

3 A. The purpose of this section is to authorize the Director of Transportation or his or
4 her designee to create a specific program for qualified businesses and institutions to apply for
5 and receive restricted parking zone permits to park in a restricted parking zone in the Initial
6 Segment LINK Light Rail transit station areas, including Rainier Beach, Othello, Columbia City,

17 C. To inform communities about the intended creation of an RPZ in the LINK station
18 areas and to obtain public comment, Seattle Department of Transportation shall convene a series
19 of community meetings for the proposed zones prior to installation.

20 D. The purpose of the pilot program is to determine whether issuance of RPZ permits
21 to businesses or institutions and their employees assists the Seattle Department of Transportation
22 in reaching the following goals: reduce neighborhood traffic impacts by large parking demand
23 generators; support mixed-use neighborhoods and local business districts; continue to reduce
24 overall energy use and vehicle emissions; keep demand by residents and businesses (including
25



1 institutions) from exceeding available on-street parking spaces in residential areas; and,
2 implement a customer-oriented permit program.

3 E. In order to be issued a restricted parking permit, the permit holder must be an owner,
4 employee, or volunteer of a business or institution within or adjacent to an RPZ boundary.

5 Property owners for a business or institution within or adjacent to an RPZ boundary can also
6 obtain one permit per owner.

7
8 F. Permit holders who violate this section or the RPZ program rules may have their
9 permit revoked and may be excluded from obtaining future permits.

10 G. The Director of Transportation or his or her designee shall present a report to the
11 City Council two (2) and four (4) years after the pilot program becomes effective. The report
12 shall evaluate the pilot program relative to goals listed in subsection D. The biennial reports are
13 intended to assist Council in determining whether to continue the program for qualified
14 businesses and institutions located within the RPZs in the Initial Segment LINK Light Rail
15 transit station areas, including Rainier Beach, Othello, Columbia City, Mount Baker, Beacon
16 Hill, SODO and Stadium stations.

17
18 H. The Seattle Department of Transportation will annually monitor and survey RPZs
19 established under this pilot to determine utilization of parking spaces by residents and area
20 businesses and institutions within each of the pilot RPZs. The Seattle Department of
21 Transportation shall cease to renew RPZ permits for businesses and institutions in the next RPZ
22 cycle for an RPZ, excluding the SODO and Stadium station RPZs, when the annual monitoring
23 or survey of the RPZ indicate that twenty-five (25) percent or more of streets within any
24 particular RPZ have the following conditions: (1) at least seventy-five (75) percent of the
25 capacity of the street available for parking is generally occupied and (2) more than thirty-five
26

1 (35) percent of the vehicles parked on the street are owned by non-residents of the designated
2 area. In this subsection, the term "non-resident" includes businesses and institutions located in
3 the area.

4 I. The pilot program is intended to be in place no longer than four (4) years after its
5 creation. In determining whether to continue the pilot, either as a pilot or permanent program, or
6 discontinue it at the end of the four year period, the Council will consider the Seattle Department
7 of Transportation biennial reports.

8
9 J. The Seattle Department of Transportation shall not consider expansion of the pilot to
10 any other RPZs established in the City of Seattle except those RPZs located in the Initial
11 Segment LINK Light Rail transit station areas, including Rainier Beach, Othello, Columbia City,
12 Mount Baker, Beacon Hill, SODO and Stadium stations.

13
14 Section 6. Section 11.16.317, as last amended by Ordinance 118409, is amended as
15 follows:

16 **SMC 11.16.317 Establishing, expanding, ~~((and))~~ reducing, and dissolving**
17 **restricted parking zones**

18 A. The Director of Transportation or his or her designee shall consider whether a
19 restricted parking zone, within a designated area, would promote certain benefits or would result
20 in adverse impacts.

23 1. Benefits that may lead to establishing an RPZ may include, but are not limited to:
24 increased access for area residents, reduced traffic congestion, increased traffic or pedestrian
25 safety, reduced air or noise pollution, reduced commuter parking in neighborhoods, prevention
26 of blighted areas, and promoting the use of alternative modes of transportation.

2. Adverse impacts that may prevent implementation include, but are not limited to:

transferring a parking problem to a different area, inability to effectively enforce program restrictions, lack of alternative transportation modes, and availability of simpler, cheaper or more effective solutions.

3. Regardless of potential benefits or adverse impacts that may result from creating an RPZ in any downtown zone including all zones contained in Map 1A of Ch. 23.49 SMC, the Seattle Department of Transportation will not install RPZs in such zones, in part, because of high demand and multiple, competing needs for on-street parking.

~~((A.))~~ B. The Director of Transportation may establish a new or expand an existing restricted parking zone whenever seventy-five (75) percent or more of the capacity of the streets available for parking on ten (10) contiguous blocks (and/or twenty (20) block faces) in such designated area is generally occupied; ~~((during regular business hours or any consecutive eight (8) hour period during evenings or during any consecutive eight (8) hour period on both Saturdays and Sundays; at least twenty five (25))~~ over thirty-five (35) percent of the vehicles parked on the street in the area ~~((during such hours))~~ are not owned by residents of the designated area; ~~((a petition signed by, or))~~ a strong and effective community engagement effort ~~((survey))~~ indicating that ~~((s))~~ generally ~~((a majority of the residents))~~ stakeholders in the designated area have reviewed and support ~~((approves))~~ the restricted parking zone, which could include a petition signed by a majority of the residents in the designated area in support of the restricted parking zone; and the public interest would be served. In cases where the criteria listed above are not ~~((all))~~ met, the Director of Transportation is authorized to establish a



1 restricted parking zone when, in his or her judgment, the parking problem will be ameliorated
2 by a restricted parking zone and the public interest would be served.

3 C. The Director of Transportation or his or her designee is authorized to engage
4 affected and interested community stakeholders to review and assist in refining any future RPZ
5 proposals.

8 1. The public information and involvement program may include department
9 presentations to business and community organizations, information distribution through the
10 City's web site, news releases and related media, direct mailings of informational materials,
11 facilitated meetings, sounding boards, walking tours, surveys, and other techniques as
12 appropriate to the scale of the proposal.

14 2. Prior to the Director of Transportation's decision to establish or not to establish, or
15 dissolve an RPZ, or to expand or reduce an RPZ by more than two (2) contiguous blocks, the
16 Seattle Department of Transportation shall hold an administrative public hearing where it will
17 provide interested persons an opportunity to submit written and spoken comment into the public
18 record.

21 3. The Seattle Department of Transportation shall mail a copy of a notice of hearing at
22 least twenty (20) days prior to the public hearing. The notice of hearing must contain a statement
23 of the hearing time and location and it must be sent to all owners, commercial lessees and
24 residents of property that lies within three hundred feet (300') of the affected restricted parking
25 zone.



1 4. The Seattle Department of Transportation shall publish the notice of hearing in a
2 local newspaper that states the hearing time and location at least twenty (20) days prior to the

16 be final. Grounds for ((review or)) reconsideration may include the validity of ((the)) any
17 parking study ((; the stringency of the parking restrictions; the boundaries of the restricted
18 parking zone; and violations of Policies and Procedures Concerning the Implementation of
19 Residential Parking Zones.)) or compliance with the process to establish a zone.

2 determination for what best serves the public interest, without holding the public hearing
3 required in SMC 11.16.317(C)2. ((consistent with Policies and Procedures Concerning the

6 ((D.))F. A restriction of parking shall take effect on a street segment when it is signed
7 or posted, and shall cease when the signs or posting are removed pursuant to lawful order;
8 provided, that vandalism or destruction of parking control signs shall not affect the validity of a
9 restriction upon parking on any street segment designated by the Director of Transportation if
10 other signs or traffic control devices give notice that parking in the street segment is restricted.

12 G. The Director may initiate dissolution of an RPZ when he or she determines that it

- 15 3. dire consequences may result if the request is denied.

Section 18. This ordinance shall take effect and be in force thirty (30) days from and after its approval by the Mayor, but if not approved and returned by the Mayor within ten (10) days after presentation, it shall take effect as provided by Municipal Code Section 1.04.020.

Section 19. Severability. The provisions of this ordinance are declared to be separate and severable. If any section, sentence, clause, phrase or portion of this ordinance is held to be

2 AN ORDINANCE related to the Restricted Parking Zone program to update and clarify the
3 program; amending Sections 3.12.120, 11.14.515, 11.16.120(F) and (G), 11.16.315,
4 11.16.317, 11.16.319, 11.23.440, 11.28.010(D), 11.31.121, 11.72.351, 11.76.015,
5 15.04.112 and 23.44.041(A) of the Seattle Municipal Code; adding new Section
6 11.16.316; and repealing Sections 15.04.112 (B) and (C), 11.73.010-.040, and 11.73.080.

7 WHEREAS, Ordinance 108354 established the Restricted Parking Zone program in 1979, for
8 many years known generally as the residential parking zone program (or RPZ program) to
9 help ease parking congestion in residential neighborhoods, and Ordinance 122853
10 amended the resident identification permit fees to cover the increased cost of
11 administration; and

12 WHEREAS, restricted parking zones (RPZs) are often located adjacent to generators of high
13 traffic demand, such as universities, high schools, hospitals, transit stations or stops, and
14 business districts in order to limit the impact of employees, transit commuters, and
15 students parking their vehicles for lengthy time periods and thereby using parking that
16 might otherwise be used by residents and area visitors; and

17 WHEREAS, as of March 2009, Seattle has 27 restricted parking zones that operate seven days a
18 week at varying days and hours, and the Seattle Department of Transportation (SDOT)
19 issues approximately 17,000 RPZ permits annually; and

20 WHEREAS, as part of this ordinance to update and clarify the RPZ program, Seattle Municipal
21 Code Sections 11.73.010-.040 and 11.73.080 are repealed; however, while the Director of
22 SDOT continues to have the authority to create, modify or dissolve RPZs as needed,
23 repeal of SMC 11.73.010-.040 and 11.73.080 is not intended to affect the validity of
24 existing RPZ zones, which the SDOT Director intends to retain as valid RPZ zones. The
25 boundaries of these zones can be reviewed at the SDOT RPZ permit counter; and

26 WHEREAS, SDOT initiated a major policy review starting in 2007 to redesign the existing RPZ
27 program to better achieve the City of Seattle's goals in areas of parking management,
28 transportation, economic development, social equity, and sustainability; and

WHEREAS, SDOT conducted a broad-based community engagement effort to generate feedback
on draft recommendations issued in August 2008. As part of this effort, SDOT
disseminated draft RPZ policy review recommendations to citizens, sought feedback from
a broad range of stakeholders to help inform decisions, and, after an 80-day comment
period, received over 500 comments from variety of residents, business owners and
others;



1 WHEREAS, the proposed amendments to the RPZ program are intended to support the
2 following four objectives: reduce traffic impacts to neighborhoods from commuters who
3 park around large parking demand generators; support mixed-use neighborhoods and
4 local business districts by creating a pilot program for businesses and institutions and by
5 broadening the community engagement program; continue to encourage a reduction in

9 A. “Business” means any business that possesses a valid City of Seattle business license
10 and where commercial work occurs on premises, including but not limited to, retail sales and
11 service, warehouse, non-household sales and service, or entertainment.

12 B. “Employee” means any individual who performs work, labor, or services and is on
13 the payroll of a business or institution. This includes all full-time, part-time and temporary
14 employees including partners of the business or institution located in or adjacent to an RPZ.

15 C. “Guest” means a person temporarily visiting residents or temporarily having
16 business with residents who are eligible for RPZ permits.

17 D. “Guest Permit” means a card, decal or other identification issued to an eligible
18 person to be placed in the vehicle that enables it to park in a restricted parking zone, for an
19 annual, biennial or single-day timeframe.



1 E. "Household Unit" means any self-contained house, apartment, condominium, town
2 house, floating home, detached or attached accessory dwelling unit, or group house that contains
3 living, sleeping and cooking quarters and is used by of any number of related persons or up to
4 eight unrelated individuals. For the purpose of this chapter, each unit of multiple-unit residential
5 dwelling is considered a separate household unit.

7 F. "Institution" means any organization of a public character, including but not limited
8 to, a school, hospital, religious facility, health care, social or community service agency, library,
9 university, or museum.

11 G. "Resident" means any person residing in a household unit that is located adjacent to
12 or in a prescribed vicinity of a restricted parking zone.

14 H. "Restricted parking zone" or "RPZ" means a portion of the street commonly used for
15 vehicular parking where vehicles properly displaying a permit or other authorization pursuant to
16 Chapter 11.16 SMC shall be exempt from the posted RPZ parking restrictions. This program
17 does not apply to vehicles displaying a card or decal issued pursuant to RCW 46.16.381.

19 I. "RPZ Permit" means a card, decal or other identification issued to an eligible person
20 to be placed on the vehicle that enables it to park in a restricted parking zone.

22 J. "Volunteer" means any individual who performs volunteer work for a business or
23 institution at least three times a week.

25 Section 3. Subsections F and G of 11.16.120, as last amended by Ordinance 121388,
26 are amended as follows:

The Director of Transportation is authorized:

F. To establish, revise or abolish restricted parking zones. A decision to establish, or to refuse to establish, a restricted parking zone is subject to ~~((review or))~~ reconsideration pursuant to SMC Section 11.16.317~~((B))~~D. The Director may consider other parking demand management tools in lieu of or prior to implementation of an RPZ. A restricted parking zone may have one (1) or more of the following components:

1 Section 4. Section 11.16.315, as last amended by Ordinance 121678, is amended as

3 Section 5. A new section, 11.16.316, of the Seattle Municipal Code is hereby added:

6 her designee to create a specific program for qualified businesses and institutions to apply for and

12 pilot program relative to goals listed in subsection D.

7 related media, direct mailings of informational materials, and other techniques as appropriate to
8 the scale of the proposal.

11 D. Any new or expanding major institution as defined in SMC 23.84A.025 applying for
12 a major institution plan or seeking any expansion of an approved major institution after January
13 1, 2010 that results in the installation of an RPZ shall pay the cost of a maximum of two RPZ
14 permits per household unit for no more than one biennial permit cycle, where warranted to
15 mitigate parking impacts of the major institution as a component of their transportation
16 mitigation program. This does not exempt major institutions from any other mitigation required

Legislation Title:

AN ORDINANCE related to the Restricted Parking Zone program to update and clarify the program, amending Sections 3.12.120, 11.14.515, 11.16.120(F) and (G), 11.16.315, 11.16.317, 11.16.319, 11.23.440, 11.28.010(D), 11.31.121, 11.72.351, 11.76.015, 15.04.112 and 23.44.041(A) of the Seattle Municipal Code; adding new section 11.16.316; and repealing Sections 15.04.112 (B) and (C), 11.73.010-.040, and 11.73.080.

• **Summary of the Legislation:**

Related to the City's Restricted Parking Zone (RPZ) program, this Ordinance proposes substantive and house-keeping changes to the Seattle Municipal Code to ensure better parking management for residential and mixed-use Seattle neighborhoods. The Ordinance covers RPZ and guest permit eligibility; payment of permit fees for new or expanded Major Institutions; zone creation and modification processes; parking enforcement; and customer service improvements for permit issuance.

• **Background:** *(Include brief description of the purpose and context of legislation and include record of previous legislation and funding history, if applicable):*

The RPZ program designates on-street parking for residents, their guests, service vehicles, and short-term visitor parking to reduce traffic impacts from nearby major institutions, transit stations, and business districts. As of March 2009, SDOT maintains 27 RPZs and issues approximately 17,000 permits. In 2007, SDOT initiated a major policy review to revise the RPZ program, last reviewed in 1994. Staff collected other cities' best practices and gathered community input. Current RPZ policy and technical requirements have, in some situations, fallen short of capturing complexities of business and residential districts' parking issues.

In mid-2008, SDOT conducted an extensive public engagement effort to gather feedback on draft recommendations. Staff received over 500 email comments and attended 15 community meetings in and around RPZ areas.

Based on review of public comments and best parking management practices, SDOT finalized and is concurrently releasing the Final RPZ Policy Review Recommendations. This proposed Ordinance contains the necessary substantive and house-keeping legislative changes to the Seattle Municipal Code to implement the Final Recommendations.



ORDINANCE 123001

AN ORDINANCE related to the Restricted Parking Zone program to update and clarify the program; amending Sections 3.12.120, 11.14.515, 11.16.120(F) and (G), 11.16.315, 11.16.317, 11.16.319, 11.23.440, 11.28.010(D), 11.81.121, 11.72.351, 11.76.015, 15.04.112 and 23.44.041(A) of the Seattle Municipal Code; adding new Section 11.16.316; and repealing Sections 15.04.112 (B) and (C), 11.73.010-.040, and 11.73.080.

WHEREAS, Ordinance 108354 established the Restricted Parking Zone program in 1979, for many years known generally as the residential parking zone program (or RPZ program) to help ease parking congestion in residential neighborhoods, and Ordinance 122853 amended the resident identification permit fees to cover the increased cost of administration; and

WHEREAS, restricted parking zones (RPZs) are often located adjacent to generators of high traffic demand, such as universities, high schools, hospitals, transit stations or stops, and business districts in order to limit the impact of employees, transit commuters, and students parking their vehicles for lengthy time periods and thereby using parking that might otherwise be used by residents and area visitors; and

WHEREAS, as of March 2009, Seattle has 27 restricted parking zones that operate seven days a week at varying days and hours, and the Seattle Department of Transportation (SDOT) issues approximately 17,000 RPZ permits annually; and

WHEREAS, as part of this ordinance to update and clarify the RPZ program, Seattle Municipal Code Sections 11.73.010-.040 and 11.73.080 are repealed; however, while the Director of SDOT continues to have the authority to create, modify or dissolve RPZs as needed, repeal of SMC 11.73.010-.040 and 11.73.080 is not intended to affect the validity of existing RPZs, which the SDOT Director intends to retain as valid RPZs. The boundaries of these zones can be reviewed at the SDOT RPZ permit counter; and

WHEREAS, SDOT initiated a major policy review starting in 2007 to redesign the existing RPZ program to better achieve the City of Seattle's goals in areas of parking management, transportation, economic development, social equity, and sustainability; and

WHEREAS, SDOT conducted a broad-based community engagement effort to generate feedback on draft recommendations issued in August 2008. As part of this effort, SDOT disseminated draft RPZ policy review recommendations to citizens, sought feedback from a broad range of stakeholders to help inform decisions, and, after an 80-day comment period, received over 600 comments from a variety of residents, business owners and others;

WHEREAS, exceptions may be needed to the four-permit per household limit for those land use zones that permit dwelling units that allow well in excess of eight unrelated occupants to reside as part of one household unit; and

WHEREAS, the proposed amendments to the RPZ program are intended to support the following four objectives: reduce traffic impacts to neighborhoods from commuters who park around large parking demand generators; support mixed-use neighborhoods and local business districts by creating a pilot program for businesses and institutions and by broadening the community engagement program; continue to encourage a reduction in overall energy use and vehicle emissions by discouraging non-residents from parking in RPZ areas; and implement simple rules that are easily understood and clearly applied; and, NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. Fees collected by the Seattle Department of Transportation for permits or other means of extending parking privileges in any restricted parking zone, as authorized in Seattle Municipal Code Section (11.16.315) 11.16.120, shall be deposited in the Seattle Department of Transportation Operating Fund for the purpose of reimbursing ongoing operating costs of (residential) restricted parking zones.

11.14.515 Definitions ((Restricted parking zone))

(("Restricted parking zone" means a portion of the street commonly used for vehicular parking, which except as to vehicles displaying a card or decal issued pursuant to ROW 46.16.380:--

A. Reserved for the exclusive use of vehicles owned or used by residents of the abutting property and/or in the discretion of the Board, residents in the prescribed vicinity, and vehicles used by their visitors; and ser-

vice vehicles of persons having business in the street or with abutting or nearby residents;

B. Reserved for such exclusive use during certain hours; or

C. Subject to time limits that apply to parking of all vehicles except vehicles owned or used by such residents, or their visitors, or service vehicles of persons having business in the street or with the residents;))

A. "Business" means any business that possesses a valid City of Seattle business license and where commercial work occurs on premises, including but not limited to, retail sales and service, warehouse, non-household sales and service, or entertainment.

B. "Employee" means any individual who performs work, labor, or services and is on the payroll of a business or institution. This includes all full-time, part-time and temporary employees including partners of the business or institution located in or adjacent to an RPZ.

C. "Guest" means a person temporarily visiting residents or temporarily having business with residents who are eligible for RPZ permits.

D. "Guest Permit" means a card, decal or other identification issued to an eligible person to be placed in the vehicle that enables it to park in a restricted parking zone, for an annual, biennial or single-day timeframe.

E. "Household Unit" means any self-contained house, apartment, condominium, town house, floating home, detached or attached accessory dwelling unit, or group house that contains living, sleeping and cooking quarters and is used by any number of related persons or up to eight unrelated individuals. For the purpose of this chapter, each unit of multiple-unit residential dwelling is considered a separate household unit.

F. "Institution" means any organization of a public character, including but not limited to, a school, hospital, religious facility, health care, social or community service agency, library, university, or museum.

G. "Resident" means any person residing in a household unit that is located adjacent to or in a prescribed vicinity of a restricted parking zone.

State of Washington, King County

H. "Restricted parking zone" or "RPZ" means a portion of the street commonly used for vehicular parking where vehicles properly displaying a permit or other authorization pursuant to Chapter 11.16 SMC shall be exempt from the posted RPZ parking restrictions. This program does not apply to vehicles displaying a card or decal issued pursuant to RCW 46.16.381.

I. "RPZ Permit" means a card, decal or other identification issued to an eligible person to be placed on the vehicle that enables it to park in a restricted parking zone.

J. "Volunteer" means any individual who performs volunteer work for a business or institution at least three times a week.

Section 3. Subsections F and G of 11.16.120, as last amended by Ordinance 121388, are amended as follows:

11.16.120 Director of Transportation -- Authority.

The Director of Transportation is authorized:

F. To establish, revise or abolish restricted parking zones. A decision to establish, or to refuse to establish, a restricted parking zone is subject to (review-or) reconsideration pursuant to SMC Section 11.16.317((B))D. The Director may consider other parking demand management tools in lieu of or prior to implementation of an RPZ. A restricted parking zone may have one (1) or more of the following components:

1. Parking in the street is reserved for the exclusive use by those vehicles displaying a valid RPZ permit, guest permit, or other identification issued by the Seattle Department of Transportation as part of the RPZ program; or

2. Parking in the street is reserved during certain posted hours for exclusive use by vehicles displaying a valid RPZ permit, guest permit, or other identification issued by the Seattle Department of Transportation as part of the RPZ program and available at all other times without restriction; or

3. Time limits are established for parking in the street that applies to all vehicles except vehicles with valid RPZ permit, guest permit, or other identification issued by the Seattle Department of Transportation as part of the RPZ program.

G. To promulgate rules and regulations for the RPZ program. (use of restricted parking zones and the issuance or revocation of permits in accordance with the provisions of the Administrative Code (SMC Chapter 3.02).)

11.16.315 ((Authority for, a)) Administration of, restricted parking zones.

((A. The Director of Transportation may establish a restricted parking zone, consistent with Section 11.16.317 and according to the Policies and Procedures Concerning the Implementation of Residential Parking Zones. A restricted parking zone may have one (1) or more of the following provisions:

1. Parking in the street is reserved for the exclusive use by the owners of abutting properties and/or residents in a prescribed vicinity, vehicles used by their visitors; and service vehicles of persons having business in the street or with the residents; and/or

2. Parking in the street is reserved during certain posted hours for such exclusive use and available at all other times without restriction; and/or

3. Time limits are established for parking in the street which apply to all vehicles except vehicles owned by or used by such residents, their visitors or service vehicles of persons having business in the street or with the residents; provided, that each restricted parking zone shall be subject to review by the Director of the Transportation after its first six (6) months of operation;))

A. Signage: Restricted parking zones shall be appropriately signed and/or marked.

B. Administration: In any restricted parking zone, the Director of Transportation or his or her designee may issue permits or other means of identification, maintain lists of vehicles owned or used by permit holders (residents), or adopt any other reasonable means of distinguishing ((-from other vehicles-)) vehicles that are ((may)) validly ((be)) parked in a ((any)) restricted parking zone. ((Restricted parking zones shall be appropriately signed and/or marked;))

1. A permit shall not guarantee or reserve to the holder an on-street parking space within the designated RPZ.

2. If issued to a resident, a permit must be used within six contiguous city blocks of the household unit address or, if issued to a business or institution, a permit must be used within six contiguous city blocks of the place of business or the institution.

C. Application: In order to obtain an RPZ permit, any applicant shall present proof of residency in or adjacent to the restricted parking zone boundary in addition to submission of a complete application to the Seattle Department of Transportation. As of January 1, 2010, any applicant must also present proof that the address of vehicle registration matches the applicant's household unit address or that the applicant is an out of state non-resident or active military personnel.

D. Permit Limit: As of January 1, 2010, each eligible household unit is entitled to obtain no more than four permits per permit cycle.

1. Exception: The Director of Transportation may issue more RPZ permits than the four-permit limit per household for the following land uses:

- a. Adult family home;
- b. Assisted living facility;
- c. Domestic violence shelter; and
- d. Permitted congregate residence.

In determining whether to grant additional permits in excess of the four-permit per household limit, the Director of Transportation may also consider the availability of on-street parking in the requestor's residential area and demonstrated need for additional permits.

E. Guest Permits. Each eligible resident may obtain no more than one annual or biennial guest permit per household unit. It is illegal to use a guest permit on a resident's vehicle. As of January 1, 2010, eligible residents may obtain a limited number of single-day use guest permits.

F. Motorcycles and Scooters. As of January 1, 2010, motorcycles and scooters are authorized to park in an RPZ without an RPZ permit.

Section 5. A new section, 11.16.316, of the Seattle Municipal Code is hereby added:

SMC 11.16.316 Restricted Parking Zone Permits for Use by Businesses - Pilot

A. The purpose of this section is to authorize the Director of Transportation or his or her designee to create a specific program for qualified businesses and institutions to apply for and receive restricted parking zone permits to park in a restricted parking zone in the Initial Segment LINK Light Rail transit station areas, including Rainier Beach, Othello, Columbia City, Mount Baker, Beacon Hill, SODO and Stadium stations. This is in addition to permits issued to qualified residents in these RPZs.

B. The Director of Transportation or his or her designee is authorized to establish rules and regulations for this pilot program, including permit eligibility, application, submission for qualifying businesses and institutions, permit use, and alternate eligibility procedures as needed, following the goals set forth in subsection D.

C. To inform communities about the intended creation of an RPZ in the LINK station areas and to obtain public comment, Seattle Department of Transportation shall convene a series of community meetings for the proposed zones prior to installation.

D. The purpose of the pilot program is to determine whether issuance of RPZ permits to businesses or institutions and their employees assists the Seattle Department of Transportation in reaching the following goals: reduce neighborhood traffic impacts by large parking demand generators; support mixed-use neighborhoods and local business districts; continue to reduce overall energy use and vehicle emissions; keep demand by residents and businesses (including institutions) from exceeding available on-street parking spaces in residential areas; and, implement a customer-oriented permit program.

E. In order to be issued a restricted parking permit, the permit holder must be an owner, employee, or volunteer of a business or institution within or adjacent to an RPZ boundary. Property owners for a business or institution within or adjacent to an RPZ boundary can also obtain one permit per owner.

F. Permit holders who violate this section or the RPZ program rules may have their permit revoked and may be excluded from obtaining future permits.

G. The Director of Transportation or his or her designee shall present a report to the City Council two (2) and four (4) years after the pilot program becomes effective. The report shall evaluate the pilot program relative to goals listed in subsection D. The biennial reports are intended to assist Council in determining whether to continue the program for qualified businesses and institutions located within the RPZs in the Initial Segment LINK Light Rail transit station areas, including Rainier Beach, Othello, Columbia City, Mount Baker, Beacon Hill, SODO and Stadium stations.

H. The Seattle Department of Transportation will annually monitor and survey RPZs established under this pilot to determine utilization of parking spaces by residents and area businesses and institutions within each of the pilot RPZs. The Seattle Department of Transportation shall cease to renew RPZ permits for businesses and institutions in the next RPZ cycle for an RPZ, excluding the SODO and Stadium station RPZs, when the annual monitoring or survey of the RPZ indicate that twenty-five (25) percent or more of streets within any particular RPZ have the following conditions: (1) at least seventy-five (75) percent of the capacity of the street available for parking is generally occupied and (2) more than thirty-five (35) percent of the vehicles parked on the street are owned by non-residents of the designated area. In this subsection, the term "non-resident" includes businesses and institutions located in the area.

I. The pilot program is intended to be in place no longer than four (4) years after its creation. In determining whether to continue the pilot, either as a pilot or permanent program, or discontinue it at the end of the four year period, the Council will consider the Seattle Department of Transportation biennial reports.

J. The Seattle Department of Transportation shall not consider expansion of the pilot to any other RPZs established in the City of Seattle except those RPZs located in the Initial Segment LINK Light Rail transit station areas, including Rainier Beach, Othello, Columbia City, Mount Baker, Beacon Hill, SODO and Stadium stations.

Section 6. Section 11.16.317, as last amended by Ordinance 118409, is amended as follows:

((B.))D.

1. The Director of Transportation's decision to establish or not to establish, or to expand, reduce, or dissolve a restricted

parking zone may be subject to (review or) reconsideration within fifteen (15) days of publication in ((the Seattle Daily Journal of Commerce and/or) a local newspaper. Requests for (review or) reconsideration may be initiated, in writing, by residents, business owners, employees or volunteers in or adjacent to the proposed RPZ. On (review or) reconsideration, the Director ((or his or her designee)) shall (conduct a public hearing before the Director makes a final decision) designate a review officer, who shall, after reviewing the reconsideration materials and other relevant information, make a recommendation to the Director. The Director may, at his or her discretion, stay implementation of a decision pending review. The Director shall have thirty (30) days to issue a Decision. The Director's decision on reconsideration shall be final unless appealed to the Office of the Hearing Examiner under subsection (D) (2). Grounds for (review or) reconsideration may include the validity of (the) any parking study ((the stringency of the parking restrictions; the boundaries of the restricted parking zone; and violations of Policies and Procedures Concerning the Implementation of Residential Parking Zones)) or compliance with the process to establish a zone.

2. The Director's decision on reconsideration may be appealed to the Office of the Hearing Examiner.

i) Time limit for initiation of an appeal. A notice of appeal shall be filed with the Hearing Examiner within twenty (20) days following issuance of the Director's Decision on Reconsideration.

ii) Form of Appeal. The notice of appeal must contain a brief statement of the issues on appeal, the specific objections to the decision being appealed, along with supporting facts and documentation, and the relief sought. The notice of appeal must list the name of the appellant, and the signature, address, phone number, and fax or e-mail address if available, of the Person appealing.

iii) Decision. After reviewing the notice of appeal and supporting documentation and conducting a hearing, the Examiner shall issue a written decision within thirty (30) days after conclusion of the hearing (or submission of the notice of appeal). The written decision shall contain the reasons for the decision and the provisions for further appeal, and shall be mailed to the Person appealing by first class mail with proof of mailing attached and a copy retained in the Examiner's files. This decision is the final decision of the City.

((C.)) E. The Director may modify hours of an existing RPZ or expand or reduce boundaries of an existing RPZ by two (2) contiguous blocks or less by following an administrative process that seeks to identify possible changes as suggested by the community, review proposed changes to the RPZ with affected community stakeholders, and make a determination for what best serves the public interest, without holding the public hearing required in SMC 11.16.317(C)2. ((consistent with Policies and Procedures Concerning the Implementation of Residential Parking Zones.))

((D.)) E. A restriction of parking shall take effect on a street segment when it is signed or posted, and shall cease when the signs or posting are removed pursuant to lawful order; provided, that vandalism or destruction of parking control signs shall not affect the validity of a restriction upon parking on any street segment designated by the Director of Transportation if other signs or traffic control devices give notice that parking in the street segment is restricted.

G. The Director may initiate dissolution of an RPZ when he or she determines that it best serves the public interest and meets at least one of the following criteria, including but not limited to, low permit sales in a zone, a small number of blocks with RPZ signs, or the original traffic generator no longer exists. The zone would be removed at the beginning of a new permit cycle.

Section 7. Section 11.16.319, as last amended by Ordinance 122853, is amended as follows:

SMC 11.16.319 Fees for restricted parking zone permits; Waiver or reduction of fees.

A. The parking fees to be collected by the Seattle Department of Transportation for restricted parking zone permits are as follows.

- TYPE OF PERMIT- FEE
- Resident parking permit -- \$45.00
- Temporary permit -- \$10.00 for first 60-day period; \$15.00 for second 60-day period
- Guest permit issued with resident permit -- \$15.00
- Guest permit as only permit -- \$45.00

Replacement of resident and guest permit -- \$15.00 for first permit; \$25.00 for second permit

Elderly/low-income permanent permit - \$10.00

B. The Director of Transportation may waive or reduce an RPZ fee in subsection A whenever:

- 1. the waiver or reduction is in the overall public interest due to extraordinary facts or circumstances,
- 2. the waiver or reduction is consistent with the goals of the RPZ program, or
- 3. dire consequences may result if the request is denied.

Section 8. Section 11.23.440, as last amended by Ordinance 108200, is amended as follows:

No person shall be granted a franchise or special privilege to the exclusion of any other like person for parking vehicles on any roadway. Zones may be granted for taxicabs, official foreign career consul vehicles, moving or loading, disabled persons, curb space parking, service parking, carpool parking, or similar uses, or for any (resident) restricted parking program which may be developed. Establishment of such a zone does not constitute a grant of franchise.

A. No person shall stop, stand or park a vehicle in violation of the posted or marked restrictions or when a permit or other authorization issued by the city is required as a condition for parking unless an RPZ permit pursuant to chapter 11.16 SMC or a disabled placard permit or license plate pursuant to RCW 46.16.381 or 46.16.390 (the same or a card or decal issued pursuant to RCW 46.16.381 or recognized under RCW 46.16.390) is displayed in a specified (prominent) place on the vehicle. As of January 1, 2010, motorcycles and scooters are authorized to park in an RPZ without an RPZ permit. It shall be a violation of this section if:

- 1. The RPZ permit does not match the vehicle;
2. A guest permit is being used improperly;
3. The zone permit does not match the zone where vehicle is parked, or 4. The vehicle is parked within the same zone as the permit indicates, but it is parked more than six blocks away from the address for which the permit is issued.
B. It is unlawful and is a parking infraction to display an RPZ permit in an improper location on a vehicle. The RPZ permit must be affixed to the vehicle at the lower center of the rear window for which it is issued unless the vehicle is a truck, a vehicle without a rear window, has a dark-tinted rear window or a surface defroster, or where the Seattle Department of Transportation has approved an exemption, whereby the permit may, in the alternative, be placed in the lower (left-hand) corner of the driver's side front windshield.

C. It is unlawful and is a parking infraction to sell, transfer, purchase or otherwise acquire for value a permit or decal issued by the City per SMC 11.16.315 or 11.16.316 and to subsequently use or display the permit to park in an RPZ.
