BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

SECTION 1. Payment of the sum of \$7,824,074.53 on Summit mechanical warrants numbered 4001890609 – 4001892377 plus manual or cancellation issues for claims, E- Payables of \$50,686.67 on Summit 9000003641 – 9000003686 and Electronic Financial Transactions (EFT) in the amount of \$11,218,270.53 are presented for ratification by the City Council per Chapter 42.23RCW.

SECTION 2.
