5 BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

6 SECTION 1. Payment of the sum of \$12,881,764.55 on Summit mechanical warrants
7 numbered 4001950084 – 4001952363 plus manual or cancellation issues for claims, E- Payables of
8 \$130,553.91 on Summit 9000005158 – 9000005211 and Electronic Financial Transactions (EFT) in
9 the amount of \$13,316,132.45 are presented for ratification by the City Council per Chapter
10 42.23RCW.

11 SECTION 2. Payment of the sum of \$33,098,510.00 on City General Salary Fund
12 mechanical warrants numbered 51148677 – 51149509 plus manual warrants, agencies warrants, and
13 direct deposits numbered 470001 – 480777 representing Gross Payrolls for payroll ending date Nov.
14 22, 2011 as detailed in the Payroll Summary Report for claims against the City which were audited by
15 the Auditing Committee and reported by said committee to the City Council Dec. 1, 2011 consistent
16 with appropriations heretofore made for such purpose from the appropriate Funds, is hereby
17 approved.

18 SECTION 3. That any act consistent with the authority and prior to the effective date of this
19 ordinance is hereby ratified and confirmed.


20 Section 4. This ordinance shall take effect and be in force 30 days after its approval by the




