COUNCIL BILL 117708

AN ORDINANCE accepting the gift of an automated bicycle counter, a display totem, funding for installation of the counter and totem, and a website to share resulting counts with the public, and ratifying and confirming prior acts.

WHEREAS, the City of Seattle, through the Seattle Department of Transportation (SDOT), currently conducts systematic quarterly counts of cyclists to monitor the number of cyclists using the City's transportation network; and

WHEREAS, SDOT is seeking to extend the value of its existing quarterly systematic spot counts of bicycles by collecting data using automated counters at select locations, including the Spokane Street Bridge, to enable modeling of weekly, monthly, and annual bicycle volumes from existing systematic quarterly count data; and

WHEREAS, the Cascade Bicycle Club and the Mark and Susan Torrance Foundation wish to make a gift of a automated continuous bike counter, a display totem, \$11,880 for installation of the counter and totem, and a website to share the resulting counts with the public; and

WHEREAS, while the City is open to accepting third party private donations to pay for additional automated bicycle counting equipment contingent on the ability of the City to operate and maintain such equipment; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. The Director of Transportation is authorized to accept the gift of an automated bicycle counter, a display totem, \$11,880 for installation the counter and totem, and a website to display count data to the general public.

Section 2. The Director of Transportation is authorized to install the gifted bicycle counter and display totem on the east approach of the Spokane Street Bridge to count bicycles using the pedestrian and bicycle pathways of the Spokane Street Bridge, and the City of Seattle



1 shall own the counter, display totem, website, and resulting data, and shall maintain these as
2 funds allow.

3 Section 3. Any act consistent with the authority of this ordinance taken after its passage
4 and prior to its effective date is hereby ratified and confirmed.


5 Section 4. This ordinance shall take effect and be in force 30 days after its approval by
6 the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it
7 shall take effect as provided by Seattle Municipal Code Section 1.04.020.

The gift includes a cash gift of \$11,880 to fund the installation of the bicycle counter and display totem. The installation is estimated to cost \$11,880. The gift also includes an in-kind donation of the bicycle counter, display totem and web site, valued at \$22,120 for a total gift of \$34,000.

SDOT will be responsible for approximately \$500.00 in annual operating costs for the life of the counter. This will be funded from the department's operating budget (Traffic Data and Records TG355450) and does not require new appropriation.

Not implementing the legislation would result in the loss of a gift with a total value of approximately \$34,000.

Dear Council President Clark:

I am pleased to transmit the attached proposed Council Bill that accepts the gift of a bicycle counter and display totem, to be located on the Spokane Street Bridge.

The Cascade Bicycle Club Educational Foundation, in cooperation with the Mark and Susan Torrance Foundation, wishes to make a gift to the city of Seattle of an automated bike counter and display totem to be located on the east approach to the Spokane Street Bridge. The proposed counter on the Spokane Street Bridge will be very similar to the Fremont Bridge counter installed in 2012, except that the display will be two-sided. The counter will count cyclists traveling in both directions across the Spokane Street Bridge, with the totem displaying a running daily volume and a cumulative annual total of cyclists. The gift also includes the construction of a website that will make the data available remotely over the internet, and funding for installation of the counter and display totem.

Seattle Department of Transportation (SDOT) currently conducts systematic quarterly spot counts of cyclists to monitor the number of cyclists using the city's transportation network. The use of automated counters adds continual data, which can be used to extend the value of spot counts by enabling modeling of weekly, monthly, and annual cyclist volumes, and by providing adjustment factors for variations due to weather.

AN ORDINANCE accepting for general street purposes 17 deeds and three correction deeds conveyed to the City of Seattle by the Central Puget Sound Regional Transit Authority ("Sound Transit") in connection with the Central Link Light Rail Transit Project as agreed to in a Property Acquisition and Transfer Procedures Agreement between the City of Seattle and Sound Transit, dated August 12, 2003 ("Property Transfer Agreement"); laying off, opening, widening, extending, and establishing portions of the rights-of-way located on Martin Luther King Jr. Way South between South Byron Street and South Walden Street, between South Alaska Street and South Angeline Street, and between South Graham Street and South Myrtle Street, and at the confluence of Martin Luther King Jr. Way South and Merton Way South; accepting a deed and correction deed conveying to the City the rights of Sound Transit under a certain Retaining Wall Easement; placing the real property conveyed by the deeds under the jurisdiction of the Seattle Department of Transportation; and ratifying and confirming certain prior acts.
