11 WHEREAS, on July 27, 2012, the United States Department of Justice (DOJ) and the City of  
12 Seattle entered into a settlement agreement (Agreement) and memorandum of  
13 understanding (MOU) (collectively Agreements) related to ensuring police services are  
14 delivered to the people of Seattle in a manner consistent with the Constitution and laws of  
15 the United States; and

16 WHEREAS, on August 30, 2012, the United States District Court for the Western District of  
17 Washington provisionally approved the Agreement and ordered that the deadlines in the  
18 Agreement would run from August 27, 2012; and

19 WHEREAS, the Seattle Police Department (SPD) and the elected leadership of the City are  
20 committed to providing effective and constitutional policing for all of Seattle's residents  
21 and value the role of community input and participation to enhance and promote public  
22 safety; and

23 WHEREAS, the Agreements outline a substantive and meaningful role for the newly created  
24 Community Police Commission (CPC) to provide ongoing community input regarding the  
25 reform process; and

26 WHEREAS, on October 9, 2012, the Mayor issued Executive Order 02-2012 outlining the  
27 parameters for creating the CPC in order to begin the application process for selecting  
28 members; and

WHEREAS, City Council by Ordinance 124021 established the CPC and its purposes and duties,  
consistent with and complementary to the Agreement and MOU regarding the role of the  
CPC in order to provide additional clarity to CPC members and transparency for  
members of the public; and



1 WHEREAS, on March 12, 2013, the Court approved the Monitoring Plan that envisions the CPC  
2 as “a powerful, independent policymaking body that proceeds carefully based upon  
3 evidence and whose conclusions and recommendations have great integrity and  
4 persuasive power”; and

5 WHEREAS, the City will provide the staff support necessary for the CPC to perform all of the  
6 duties and responsibilities outlined in this ordinance and the Agreements; NOW,  
7 THEREFORE,

8 **BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:**

9 Section 1. **Budget Control Level.** The 2013 Adopted Budget is amended with the  
10 creation of the Office of the Community Police Commission budget control level (BCL) in the  
11 Executive Department added to Attachment A of Ordinance 124058 as follows:

22 Termination of this BCL may not occur prior to the termination of the settlement agreement between the United States and the City.

24 Section 2. **2013 Funding Appropriation.** The appropriations for the following items in the 2013 Budget are modified, as follows:

Funding in future years will be appropriated through the annual budget process.

Section 3. **Position Authority.** To carry out the purposes of the appropriation in Item 2.1, the following new positions, which are exempt from Civil Service and Public Safety Civil Service rules and laws, are created in the Executive Department – Office of the Community Police Commission:

These positions are created upon the effective date of this Ordinance.

Section 4: Section 1 of Ordinance 124021 is amended as follows:

Section 1. Commission Established. The City of Seattle hereby establishes the Community Police Commission. The CPC will consist of 15 members and remain in existence until terminated by the City, but this termination may not occur prior to the termination of the settlement agreement between the United States and the City of Seattle. Within six months of the termination of the settlement agreement by the Federal Court, the Mayor and City Council will assess the need for continuation of the CPC and the Office of the Community Police Commission.



1 Section 5. A new Subchapter IX to Chapter 3.14 is added to the Seattle Municipal Code  
as follows:

2 Subchapter IX

3 Office of the Community Police Commission

4 3.14.981 Background. On July 27, 2012, the United States Department of Justice and The City  
5 of Seattle entered into a Settlement Agreement and Memorandum of Understanding (collectively  
6 Agreements) related to ensuring police services provided by the Seattle Police Department are  
7 delivered to the people of Seattle in a manner consistent with the Constitution and laws of the  
8 United States. The Agreements outline a substantive and meaningful role for a newly created  
9 Community Police Commission.

10 3.14.982 Office created -- Purpose.

11 There is created within the Executive Department an Office of the Community Police  
12 Commission, under the direction of the Mayor. The purpose of the Office of the Community  
13 Police Commission is to provide staff support to the Community Police Commission created by  
14 Executive Order 02-2012 and Ordinance 124021. It is intended that if the Community Police  
Commission is terminated, this staff support will be eliminated.

15 3.14.983 Executive Director -- Appointment and Removal.

16 A. The Executive Director of the Office of the Community Police Commission shall be  
17 appointed by the Mayor, subject to confirmation by a majority vote of all members of the  
18 City Council and the Commission, and may be removed by the Mayor at any time upon filing  
a statement of reason with the City Council and the Commission.

19 B. In case of a vacancy, the Mayor may appoint an interim Executive Director for a period  
20 not to exceed 120 days from the date of appointment. The Mayor shall appoint an Executive  
21 Director before the end of the interim appointment for confirmation by the City Council.

22 3.14.984 Executive Director -- Duties.

23 The duties of the Executive Director of the Office of the Community Police Commission are as  
24 follows:



1 A. Oversee and manage the functions of the Office of the Community Police Commission to  
2 advance the mission of the Office and perform other duties as the Commission may  
3 prescribe;

4 B. Appoint, remove, supervise and control officers and employees in the Office of the  
5 Community Police Commission;

6 C. Manage the preparation of the proposed budget of the Office of the Community Police  
7 Commission, authorize necessary expenditures and enter into contracts for professional and  
8 expert services in accordance with the adopted budget, develop and manage programs, and  
9 undertake authorized activities;

10 D. Execute, administer, modify and enforce such agreements and instruments as he or she  
11 shall deem reasonably necessary to implement programs and carry out the responsibilities,  
12 functions, and activities of the Office of the Community Police Commission; apply for grants  
13 and donations for department programs; and solicit and use volunteer services;

14 E. Serve, in conjunction with other affected Department heads, as the City's representative to  
15 boards, commissions, and organizations engaged in issues pertaining to Constitutional  
16 policing;

17 F. Exercise such other and further powers and duties as shall be prescribed by ordinance; and

18 H. Report to the Commission, Mayor, City Council, Monitor, and public on the City's efforts  
19 to advance the mission of the Office of the Community Police Commission.

20 Section 6. Section 4.13.010 of the Seattle Municipal Code, last amended by Ordinance  
21 124092 is amended as follows:

22 4.13.010 Exemptions from the Civil Service and Public Safety Civil Service Systems.

**Legislation Title:**

AN ORDINANCE related to the creation of the Office of the Community Police Commission within the Executive Department; amending Ordinance 124058 by establishing a budget control level, position authority and appropriations for the 2013 fiscal year; amending Section 1 of Ordinance 124021; creating new sections in Chapter 3.14 of the Seattle Municipal Code; and amending Section 4.13.010 of the Seattle Municipal Code to exempt a position from the Civil Service system; all by a 2/3 vote of the City Council.

**Summary of the Legislation:**

This legislation creates the structure and staffing in support of the Community Police Commission (CPC) established and defined by Executive Order 02-2012 and Ordinance 124021 per the United States Department of Justice (DOJ) and the City of Seattle settlement agreement and memorandum of understanding filed with the United States District Court: Western District of Washington. It also amends a related Ordinance and Section of the Seattle Municipal Code.

**Background:**

On July 27, 2012, the DOJ and the City of Seattle entered into a Settlement Agreement (Agreement) and Memorandum of Understanding (MOU) filed with the United States District Court: Western District of Washington, related to ensuring police services are delivered to the people of Seattle in a manner consistent with the Constitution and laws of the United States. These documents outline a substantive and meaningful role for a newly created CPC to provide ongoing community input regarding the reform process. The CPC was to be created within 90 days of the August 30, 2012 court filing of the Agreements.

On October 9, 2012, the Mayor issued Executive Order 02-2012 outlining the parameters for creating the CPC in order to begin the application process for selecting members. In addition, the City Council through Ordinance 124021, provided additional guidance consistent with and complementary to the Agreement and MOU regarding the role of the CPC in order to provide additional clarity to commission members and transparency for members of the public.

The City of Seattle is committed to providing the staff support necessary for the CPC to perform all of the duties and responsibilities outlined in this ordinance and the Agreements. The creation of the Office of the Community Police Commission (OCPC) Budget Control Level (BCL), authorization of positions, and appropriation of funding helps accomplish this task.



This action will not impact net 2013 Budget appropriations. It moves \$362,865 from the Finance General reserve to a new BCL in the Executive Department. This leaves a remaining balance of approximately \$532,000 in the reserve for miscellaneous implementation costs that may emerge as the work plan is developed. As required in the proviso in the 2013 Adopted Budget, the amount that remains in reserve may only be accessed if authorized through Council-approved legislation.

The CPC will consist of 15 members and remain in existence until terminated by the City, but this termination may not occur prior to the termination of the settlement agreement between the United States and the City of Seattle. Within six months of the termination of the settlement agreement by the Federal Court, the Mayor and City Council will assess the need for continuation of the CPC and the Office of the Community Police Commission.

4 Office of the Community Police Commission

5 3.14.981 Background. On July 27, 2012, the United States Department of Justice and the City  
6 of Seattle entered into a Settlement Agreement and Memorandum of Understanding (collectively  
7 Agreements) related to ensuring police services provided by the Seattle Police Department are  
8 delivered to the people of Seattle in a manner consistent with the Constitution and laws of the  
9 United States. The Agreements outline a substantive and meaningful role for a newly created  
10 Community Police Commission.

11 3.14.982 Office created -- Purpose.

12 There is created within the Executive Department an Office of the Community Police  
13 Commission, under the direction of the Mayor. The purpose of the Office of the Community  
14 Police Commission is to provide staff support to the Community Police Commission created by  
15 Executive Order 02-2012 and Ordinance 124021. It is intended that if the Community Police  
16 Commission is terminated, this staff support will be eliminated.

17 3.14.983 Executive Director -- Appointment and Removal.

18 A. The Executive Director of the Office of the Community Police Commission shall be  
19 appointed by the Mayor, subject to confirmation by a majority vote of all members of the  
20 City Council, and may be removed by the Mayor at any time upon filing a statement of  
21 reason with the City Council.

22 B. In case of a vacancy, the Mayor may appoint an interim Executive Director for a period  
23 not to exceed 120 days from the date of appointment. The Mayor shall appoint an Executive  
24 Director before the end of the interim appointment for confirmation by the City Council.

25 3.14.984 Executive Director -- Duties.

26 The duties of the Executive Director of the Office of the Community Police Commission are as  
27 follows:

28 A. Oversee and manage the functions of the Office of the Community Police Commission to  
advance the mission of the Office;

1 B. Appoint, remove, supervise and control officers and employees in the Office of the  
2 Community Police Commission;

3 C. Manage the preparation of the proposed budget of the Office of the Community Police  
4 Commission, authorize necessary expenditures and enter into contracts for professional and  
5 expert services in accordance with the adopted budget, develop and manage programs, and  
6 undertake authorized activities;

7 D. Execute, administer, modify and enforce such agreements and instruments as he or she  
8 shall deem reasonably necessary to implement programs and carry out the responsibilities,  
9 functions, and activities of the Office of the Community Police Commission; apply for grants  
10 and donations for department programs; and solicit and use volunteer services;

11 E. Serve, in conjunction with other affected Department heads, as the City's representative to  
12 boards, commissions, and organizations engaged in issues pertaining to Constitutional  
13 policing;

14 F. Exercise such other and further powers and duties as shall be prescribed by ordinance; and

15 H. Report to the Mayor and City Council on the City's efforts to advance the mission of the  
16 Office of the Community Police Commission.

17 Section 6. Section 4.13.010 of the Seattle Municipal Code, last amended by Ordinance  
18 124092 is amended as follows:




