15 WHEREAS, in April 2011, the Washington State Department of Transportation (WSDOT), the
16 Arboretum and Botanical Garden Committee (ABGC), the Arboretum Foundation, the
17 Seattle Department of Parks and Recreation (DPR), the Seattle Department of
18 Transportation (SDOT), and the University of Washington (UW) executed a
19 Memorandum of Understanding (MOU) that memorialized the intent and roles and
20 responsibilities of the parties related to implementing an Arboretum Mitigation Plan to
21 address impacts from the State's SR 520, I-5 To Medina: Bridge Replacement and HOV
22 Project; and

23 WHEREAS, to implement the MOU, the parties developed a "Cooperative Agreement for
24 Implementation of Arboretum Mitigation Plan Projects as Mitigation for SR 520, I-5 To
25 Medina: Bridge Replacement and HOV Project," which agreement was executed on
26 January 14, 2013; and

27 WHEREAS, WSDOT has transferred funds to the City to implement the Washington Park
28 Arboretum Trail Development, one of the Arboretum Mitigation Plan projects; NOW,
THEREFORE

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. The City's execution of the Cooperative Agreement for Implementation of
Arboretum Mitigation Plan Projects as Mitigation for SR 520, I-5 To Medina: Bridge
Replacement and HOV Project attached hereto as Attachment 1 is hereby approved.



1 Section 2. The Superintendent of Parks and Recreation, or his designee, is authorized to
2 accept from WSDOT on behalf of the City of Seattle, the sum of \$7,810,431, which funds shall
3 be used for construction of the Washington Park Arboretum Trail as described in the attached
4 agreement.

5 Section 3. The funds described in Section 2 shall be deposited into the Park Mitigation
6 and Remediation Fund, which is hereby created in the City Treasury to account for monies
7 received for development, renovation or improvements to Department of Parks and Recreation
8 properties. Money in that Fund may be temporarily deposited or invested in such manner as may
9 be lawful for the investment of City money and interest and other earnings shall be deposited in
10 the Fund.

12 Section 4. The 2013 Adopted Budget is amended with the creation of the following new
13 budget control level added to Attachment A of Ordinance 124058 as follows:



**COOPERATIVE AGREEMENT FOR IMPLEMENTATION OF ARBORETUM MITIGATION PLAN PROJECTS AS
MITIGATION FOR SR 520, I-5 TO MEDINA: BRIDGE REPLACEMENT AND HOV PROJECT**

**AMONG WASHINGTON STATE DEPARTMENT OF TRANSPORTATION, SEATTLE PARKS AND
RECREATION, SEATTLE DEPARTMENT OF TRANSPORTATION, UNIVERSITY OF WASHINGTON,
ARBORETUM FOUNDATION, AND MEMBERS OF THE ARBORETUM AND BOTANICAL GARDEN
COMMITTEE**

THIS AGREEMENT is entered into by the members of the **ARBORETUM AND BOTANICAL GARDEN COMMITTEE**, which is composed of the Arboretum Foundation (AF), City of Seattle Parks and Recreation (Seattle Parks), the University of Washington (UW), two appointees from the City of Seattle Mayor's office and one appointee from the State of Washington Governor's office, acting by and through its members, hereinafter the "ABGC"; the **STATE OF WASHINGTON, DEPARTMENT OF TRANSPORTATION**, acting by and through the Secretary of the Department of Transportation, hereinafter "WSDOT"; the **CITY OF SEATTLE**, acting by and through its Superintendent of Parks and Recreation, hereinafter "Seattle Parks"; the **CITY OF SEATTLE, DEPARTMENT OF TRANSPORTATION**, acting by and through its Director, hereinafter "SDOT"; the **UNIVERSITY OF WASHINGTON**, acting by and through its Dean of the College of the Environment, hereinafter "UW"; and the **ARBORETUM FOUNDATION**, acting by and through its President; collectively the "PARTIES" and individually the "PARTY."

WHEREAS, Engrossed Substitute Senate Bill (ESSB) 6392 (RCW 47.56.870), which became effective on June 10, 2010, requires that WSDOT mitigate the effects of the SR 520 Project on and enhance the Washington Park Arboretum, specifically providing that "[w]etland mitigation required by state and federal law . . . must, to the greatest extent practicable, include on-site wetland mitigation at the Washington Park Arboretum"; and

WHEREAS, RCW 47.56.870 directs that "the department shall consult with the governing board of the Washington Park Arboretum..." and the ABGC was established by Seattle City Council Ordinance #65130 approved December 27, 1934 as the advisory committee for the Arboretum, and therefore for purposes of fulfilling the terms agreed to in this AGREEMENT, the ABGC is considered to be the governing board of the Washington Park Arboretum; and

WHEREAS, WSDOT coordinated with the ABGC to develop the December 2010 Arboretum Mitigation Plan, which outlines projects intended to mitigate anticipated adverse effects on the Arboretum resulting from the SR 520 Project; and

WHEREAS, In April 2011, WSDOT, the ABGC, the Arboretum Foundation, Seattle Parks, the UW, and SDOT signed a Memorandum of Understanding (MOU), that contains additional detail on agency roles and responsibilities under the Arboretum Mitigation Plan, as well as future implementation steps; and

WHEREAS, in June 2011, WSDOT published a Final Environmental Impact Statement (FEIS) for the SR 520 Project, and in August 2011, the Federal Highway Administration (FHWA) signed the Record of Decision, which lists commitments made by WSDOT and FHWA, including the commitment to implement the mitigation measures identified in the Arboretum Mitigation Plan and the MOU, both of which documents are included as attachments to the FEIS and documented as commitments in the Record of Decision; and

WHEREAS, WSDOT has applied for and received a federal Transportation Infrastructure Finance and Innovation Act (TIFIA) loan, which will fund the West Approach Bridge North (WABN) portion of the SR 520 Project and the associated mitigation that is required to be constructed concurrently, and the PARTIES acknowledge that implementation of mitigation for other portions of the SR 520 Project are contingent on receiving further funding; and

WHEREAS, the SR 520 Project incorporates elements that will benefit the Washington Park Arboretum such as removal of the Lake Washington Boulevard ramps, an increased bridge profile to improve and expand trail user access, minimized bridge lane and shoulder widths, improved open space connectivity through pedestrian and bicycle connections across the Montlake Lid and a crossing beneath the SR 520 bridge adjacent to the lid, and noise reduction methods including quieter concrete pavement; and

WHEREAS, it is the intention of all the PARTIES that the property in the area known informally as the "WSDOT Peninsula" will be conveyed to the City of Seattle as mitigation for impacts of the SR 520 Project. The details of such conveyance would depend on property value and site protection considerations; and

WHEREAS, WSDOT intends to implement, under a separate agreement, Foster Island Tribal / Cultural Improvements as required by SR 520 Project Programmatic Agreement among the FHWA, National Oceanic and Atmospheric Administration, Washington State Historic Preservation Officer, WSDOT, and The Advisory Council on Historic Preservation Implementing Section 106 of the National Historic Preservation Act dated May 2011. Those Foster Island Tribal / Cultural Improvements are outside the scope of the Arboretum Mitigation Plan, but within the geographic limits of the Arboretum, as a result of its SR 520 Project tribal consultation efforts. Those improvements are referenced in Exhibit A, row c. While not part of the Arboretum Mitigation Plan projects contemplated herein, WSDOT is seeking the PARTIES' cooperation in allowing those improvements to be made within the Arboretum;

NOW, THEREFORE, in order to implement the goals identified in the Arboretum Mitigation Plan, memorialized in the MOU, and committed to in the Record of Decision, and pursuant to RCW 47.28.140 and RCW 47.56.870, and in consideration of the terms, conditions, covenants, and performances contained herein, and the attached Exhibits A, B, C, D, E, F, and G which are incorporated and made a part hereof; **IT IS MUTUALLY AGREED AS FOLLOWS:**



I. PURPOSE AND BACKGROUND

A. The purpose of this AGREEMENT is to confirm the general terms and conditions that the PARTIES believe will be necessary to implement Arboretum Mitigation Plan projects. The PARTIES agree that these projects have both regional and individual agency benefits. The PARTIES agree to work collaboratively to arrive at solutions that will enhance the benefits and value of these projects while respecting established budgets identified herein.

B. The PARTIES agree that the Arboretum Mitigation Plan projects described herein fully and fairly mitigate for environmental impacts to the Arboretum from the SR 520 Project. The PARTIES also agree that the terms of this AGREEMENT constitute a full and fair settlement regarding WSDOT's contributions toward those Arboretum Mitigation Plan projects for which specific WSDOT contribution amounts are identified in Exhibit A. For projects where WSDOT contribution amounts are described as "to be determined" in Exhibit A, the PARTIES agree to determine those full and fair settlement contributions through future amendments to this AGREEMENT or separate agreements.

II. ARBORETUM MITIGATION PLAN PROJECTS

This AGREEMENT identifies the overall scopes, funding sources, implementation leads, project costs, and schedules for the Arboretum Mitigation Plan projects defined in the Arboretum Mitigation Plan and the MOU, and as shown in Exhibit A. See Exhibit B for the location of Arboretum Mitigation Plan projects. The PARTIES agree that each project will be designed and implemented as outlined by this AGREEMENT, and to comply with the applicable federal, state and local regulations identified in Exhibit A.

III. GENERAL RESPONSIBILITIES OF THE PARTIES

This AGREEMENT describes and establishes general roles and responsibilities for all Arboretum Mitigation Plan projects in the Arboretum Mitigation Plan and the MOU. Where this AGREEMENT specifies a different project role or responsibility from that stated in the MOU or Arboretum Mitigation Plan, this AGREEMENT takes precedence.

It also describes additional roles and responsibilities on the North Entry project and the Multi-Use Trail project.

A. General Roles and Responsibilities for All Projects

1. Seattle Parks Roles and Responsibilities

- a) For Arboretum Mitigation Plan projects where Seattle Parks is identified as the lead, Seattle Parks will lead the project planning, design and construction. Planning, design and construction includes, but is not limited to, public involvement,



environmental documentation and permitting, design management and procurement of consulting services, construction management and procurement of contractor services and materials.

b) Seattle Parks will endeavor to ensure the scope of the projects where it is identified as the lead remains within the budgets outlined in Exhibit E subject to any contingencies to which WSDOT and Seattle Parks have agreed in writing in order to bring the preliminary estimates in line with actual project costs. Seattle Parks will also endeavor to reduce the estimated costs of the projects it leads below the amounts shown in Exhibit E through value engineering and dollars saved will be used to fund other identified projects in the Arboretum Mitigation Plan.

c) Seattle Parks will work collaboratively with WSDOT to ensure compliance with the overall SR 520 Project design and construction schedule.

d) Seattle Parks will review WSDOT design submittals within established timelines to ensure no delay to the SR 520 Project. Seattle Parks' review will be for coordination, not for purposes of approval. To the extent any Arboretum Mitigation Plan project or project element is predominantly transportation related, *e.g.* a roadway or roadway signage, Seattle Parks will obtain SDOT review, input and approval on such element(s).

e) When any Arboretum Mitigation Plan project element affects a historic or cultural resource, or has the potential to adversely affect such a resource, Seattle Parks will work with the City's and/or State's Historic Preservation Officer (as applicable) to seek Arboretum Mitigation Plan project approval. Seattle Parks will be responsible for compliance with local and state historic preservation and cultural resources laws, and will coordinate with agencies who administer these regulations, as applicable. WSDOT has disclosed preliminary expectations regarding cultural resources in the Arboretum vicinity developed as part of the Archaeological Treatment Plan, SR 520 Bridge Replacement and HOV Program, I-5 to Medina: Bridge Replacement and HOV Project dated September 2011.

f) Seattle Parks will provide ample review time to Arboretum Mitigation Plan project partners, *i.e.* SDOT, UW, WSDOT, and the ABGC, either individually or through its working committees to review and comment on the individual Arboretum Mitigation Plan projects at appropriate Arboretum Mitigation Plan project milestones.

g) Seattle Parks will record and respond to Arboretum Mitigation Plan project comments and endeavor to incorporate comments into the Arboretum Mitigation Plan project's design.

h) Long term operation and maintenance of the Arboretum Mitigation Plan projects will be undertaken cooperatively by Seattle Parks and the UW, as outlined in any existing and/or future agreement(s) between Seattle Parks and UW.

i) Seattle Parks will inform the ABGC on a regular basis of status updates on fulfillment of this AGREEMENT.

2. WSDOT Roles and Responsibilities

a) WSDOT will lead the development of subsequent agreements or amendments to this AGREEMENT for remaining settlement contributions toward individual Arboretum Mitigation Plan projects identified in this AGREEMENT within 90 days of when funding is authorized for SR 520 Project elements after the WABN. Remaining settlements for Arboretum Mitigation Plan projects will be made concurrently with the portions of the SR 520 Project causing the impacts that are being mitigated for in those



mitigation projects.

b) WSDOT will fund individual Arboretum Mitigation Plan projects up to the maximum amount noted in Exhibit A of this AGREEMENT; WSDOT's contributions to certain Arboretum Mitigation Plan projects are contingent upon receiving further funding for the SR 520, I-5 to Medina: Bridge Replacement and HOV Project, and are described as "to be determined" in Exhibit A.

c) WSDOT will review all plans, designs, and schedules developed by other PARTIES for Arboretum Mitigation Plan projects defined in this AGREEMENT not for approval purposes but to ensure that they do not conflict with SR 520 construction. In the case of a conflict, the SR 520 Project plans and schedule shall prevail.

d) WSDOT will collaborate with SDOT on the development of the Neighborhood Traffic Management Plan (NTMP) as shown in Exhibit A and work with SDOT to engage ABGC in review.

e) WSDOT will provide periodic status reports on the implementation of this AGREEMENT and the individual Arboretum Mitigation Plan projects to the ABGC on a regular basis.

f) WSDOT engaged the ABGC in the Seattle Community Design Process, and will engage the ABGC for input during the design of the West Approach Bridge (WAB) portion of the SR 520 Project.

g) WSDOT will develop a sustainable landscaping plan in coordination with the ABGC and the Affected Tribes as defined in WSDOT's Foster Island Treatment Plan, SR 520, I-5 to Medina: Bridge Replacement and HOV Project, SR 520 Bridge Replacement and HOV Program dated September 2011. The plants included in the landscaping plan will be identified by ABGC in consultation with the Affected Tribes, and will consist of plants that are suitable for the Foster Island environment. The landscape plan will be developed in phases, but finalized prior to construction completion on Foster Island. WSDOT will provide funding for the plan elements within WSDOT right-of-way, as agreed upon through consultation with the Affected Tribes and ABGC. Planting and maintenance activities will be conducted by WSDOT in consultation with the Affected Tribes and ABGC. The WSDOT contracted plant establishment period will extend for a period of years to be determined through consultation with ABGC.

3. ABGC, Arboretum Foundation, and UW Roles and Responsibilities

a) Long term operation and maintenance of the Arboretum Mitigation Plan projects will be undertaken cooperatively by Seattle Parks and the UW, as outlined in any existing and/or future agreement(s) between Seattle Parks and UW.

b) Members of the ABGC and their working committees will work cooperatively with Seattle Parks and other City agencies as appropriate in the planning, design and construction of each Arboretum Mitigation Plan project. In addition, the ABGC and their working committees will provide their review, input and approval, if requested, in a timely manner.

c) To the extent any Arboretum Mitigation Plan project or project element involves work on property owned by the UW or the Arboretum Foundation, UW and the Arboretum Foundation will provide their respective review, input and approval in a timely manner.

d) To provide for efficient and effective implementation of the mitigation projects identified in this AGREEMENT, the ABGC will operate in accordance with the 2004



Washington Park Arboretum Master Plan Implementation Plan.

e) Management of the implementation process for the mitigation projects included in this AGREEMENT will be delegated to the Master Plan Implementation Group (MPIG), a subcommittee of the ABGC. The MPIG will be responsible for planning, and recommending to the ABGC for approval, the sequencing, timing, scope, schedule and budget for each mitigation project included in this AGREEMENT.

f) The ABGC will grant access and parking assistance to the Muckleshoot Indian Tribe (MIT) to host and attend a cultural event at Foster Island in preparation for the Foster Island Tribal/Cultural Improvements project referenced in Exhibit A, row c. Specifics related to these improvements are covered in separate agreement(s) between WSDOT and the MIT and Seattle Parks and the MIT.

4. SDOT Roles and Responsibilities

a) To the extent any Arboretum Mitigation Plan project or project element is predominantly transportation-related, e.g. a roadway or roadway signage, SDOT will review, provide input on and approve such element(s) in a timely manner.

b) SDOT will also participate in the formal plan review process and issue permits, as needed, according to the SDOT's standard practices.

c) SDOT and WSDOT will coordinate to ensure integration of traffic management strategies between the two agencies through the Neighborhood Traffic Management Plan (NTMP) process as described in Exhibit A, Project "i" (Support for Traffic Management Evaluation).

5. Joint Roles and Responsibilities of the PARTIES

a) The PARTIES agree to jointly seek grant funding in an effort to ensure full implementation of the projects identified in the MOU and to potentially help offset the amount of WSDOT contributions required to implement the Arboretum Mitigation Plan projects. The PARTIES agree to each bear their own costs for pursuit of grant funding. The PARTIES agree to determine the lead agency for each grant application based on the type and requirements for the subject grant. Should grant funds be obtained, then the amount of WSDOT contribution will be offset by the grant amount, and WSDOT will reserve that offset amount, as well as unspent funds from the Multi-Use Trail and the Art, Aesthetic and Landscape Enhancements at Foster Island Crossing, as partial contribution for the North Entry Project. Should the PARTIES be unsuccessful in pursuing grant funding, the WSDOT contribution committed to herein will not be reduced.

B. Multi-Use Trail Project-Specific Roles and Responsibilities

1. Seattle Parks Roles and Responsibilities

a) Seattle Parks will provide and coordinate design review of the Multi-Use Trail with the ABGC and SDOT as necessary and prior to implementation to ensure consistency with the scope outlined by this AGREEMENT or any future agreements.

b) Seattle Parks agrees to provide WSDOT a statement of the final amount spent on the construction of the Multi-Use Trail, and to apply any remaining unspent funds from that project to offset the amount of WSDOT contribution toward other Arboretum Mitigation Plan projects.



2. WSDOT Roles and Responsibilities

- a) WSDOT will review the Seattle Parks-led Multi-use Trail project Plans, Specifications, and Estimate (PS&E) (as used herein, PS&E means those design stages beyond the preliminary design) in a timely manner for the purpose of verifying that they do not conflict with the SR 520 Project.
- b) WSDOT and its contractor will work with Seattle Parks and its contractor to ensure coordination in implementing the Multi-use Trail project elements to ensure that they do not conflict with the SR 520 Project.

3. ABGC Roles and Responsibilities

- a) ABGC will review the Multi-Use Trail plans, designs, and cost estimates in a timely manner so that Multi-Use Trail project delivery is not delayed as required by either WSDOT or Seattle Parks.
- b) ABGC will participate in public meetings as requested by Seattle Parks in support of the Multi-Use Trail concept.

4. SDOT Roles and Responsibilities

- a) SDOT will review, in a timely manner, the Multi-use Trail plans and designs for the points where the Arboretum Multi-use Trail connects to the larger City of Seattle pedestrian and bicycle system at the north and south ends of the Arboretum.

C. North Entry Project-Specific Roles and Responsibilities

1. Seattle Parks Roles and Responsibilities

- a) Seattle Parks will lead PS&E design and construction of the North Entry project as outlined in Exhibit D. Seattle Parks will not begin the construction of North Entry project until after the WAB is completed and WSDOT no longer needs access within the WSDOT Peninsula, so that it does not conflict with SR 520 construction.
- b) Upon WSDOT's receipt of full funding for the WAB, Seattle Parks will work with WSDOT towards the development of an agreement or amendment that identifies WSDOT's contribution for the North Entry project.
- c) Seattle Parks will provide and coordinate PS&E design review of the North Entry with the ABGC, WSDOT and other City of Seattle departments as necessary and prior to implementation to ensure consistency with the scope outlined generally in Exhibit A or any future agreements.

2. WSDOT Roles and Responsibilities

- a) WSDOT will review the Seattle Parks-led North Entry project PS&E in a timely manner for the purpose of verifying that they do not conflict with the SR 520 Project.
- b) Once the WAB is fully funded, WSDOT will negotiate an agreement or amendment with Seattle Parks for the remaining settlement contribution toward the North Entry Project. At that time, WSDOT and Seattle Parks will re-evaluate the budget for the North Entry project, and WSDOT's contribution, to reflect any contributions from other Arboretum Mitigation Plan projects' unspent budget amounts, grant funding received, scope adjustments, and savings identified through Seattle Parks' value engineering.



3. ABGC Roles and Responsibilities

- a) ABGC will review the North Entry plans, designs, and cost estimates in a timely manner so that North Entry project delivery is not delayed, as required by either WSDOT or Seattle Parks.
- b) ABGC will participate in public meetings as requested by Seattle Parks in support of the North Entry concept.

4. SDOT Roles and Responsibilities

- a) SDOT will review the Seattle Parks-led North Entry project PS&E in a timely manner.

IV. FUNDING AND PAYMENT

A. This AGREEMENT includes provisions for payment of the WSDOT contribution only for selected Arboretum Mitigation Plan projects as shown in Exhibit A. Payment provisions for other Arboretum Mitigation plan projects shall be established in subsequent agreement(s) or amendments to this AGREEMENT between Seattle Parks and WSDOT related to specific Arboretum Mitigation Plan projects. Implementation of Arboretum Mitigation Plan projects, except for those funded by the TIFIA loan referred to in the recitals to this AGREEMENT, is subject to funding and the cost constraints of the SR 520 Project. Engrossed House Bill (EHB) 2814, which became effective on March 23, 2012 and is codified at RCW 90.58.140(5)(b)(i), prohibits the construction of SR 520 Project elements between Interstate 5 and the western landing of the floating bridge until tolling is authorized on Interstate 90 or full funding is in place to construct the complete SR 520 project. The construction of the Arboretum Mitigation Plan projects is bound by these conditions contained in EHB 2814 and RCW 90.58.140(5)(b)(i)(the "EHB 2814 conditions").

B. WSDOT will pay Seattle Parks to construct individual Arboretum Mitigation Plan projects as specified in Exhibit A. This payment shall not represent authorization to begin work; unless otherwise determined by WSDOT and Seattle Parks in individual Arboretum Mitigation Plan project agreements, WSDOT shall provide written authorization for the start of Arboretum Mitigation Plan project construction concurrently with the component(s) of the SR 520 Project that result in an impact to the Arboretum. Specifically:

1. Within 30 days of execution of this AGREEMENT, WSDOT shall pay Seattle Parks the amount of \$7,810,431, which is the sum of amounts shown in the "WSDOT Contribution" column in Exhibit A, rows a and d(3). A signed original of this AGREEMENT shall serve as an invoice for payment.
2. Once EHB 2814 conditions are met as described above in subsection IV.A, assuming no other constraints prevent WSDOT from beginning construction on the WABN, WSDOT shall then authorize Seattle Parks in writing to construct the Multi-use Trail project.



3. Once EHB 2814 conditions are met as described above in subsection IV.A, assuming no other constraints prevent WSDOT from beginning construction on the WABN, WSDOT shall then authorize the selected lead agency in writing through a separate agreement or an amendment to this AGREEMENT to construct the undercrossing improvements within the WSDOT right-of-way as shown in Exhibit A, row d(2). The amount of WSDOT's contribution is to be determined.

4. Once construction of the WABN is completed, assuming WSDOT is performing no other construction in the area, WSDOT shall authorize Seattle Parks in writing to construct the portions of the northern half of the Art, Aesthetic and Landscape Enhancements at Foster Island Crossing as described in Exhibit A, row d(3) for which it is responsible (*i.e.*, trail/landscape improvements approaching WSDOT right-of-way from the north).

5. Once construction of the West Approach Bridge South (WABS) is completed, assuming WSDOT is performing no other construction in the area, WSDOT shall authorize Seattle Parks in writing to construct the portions of the southern half of the Art, Aesthetic and Landscape Enhancements at Foster Island Crossing as described in Exhibit A, row d(3) for which it is responsible (*i.e.*, trail/landscape improvements approaching WSDOT right-of-way from the south).

6. Once the WAB is complete and WSDOT no longer needs access within the WSDOT Peninsula, WSDOT shall authorize Seattle Parks to construct North Entry Project through a separate agreement or an amendment to this AGREEMENT. The amount of WSDOT's contribution is to be determined.

C. One or more of the members of the ABGC may bring additional financial resources other than the grant funding described in Section III.A.5. to a Seattle Parks-led Arboretum Mitigation Plan mitigation project to expand and/or enhance the scope or breadth of a project beyond the elements outlined in Exhibit A, or to fully realize a project as it is envisioned in the Arboretum Master Plan. Any such additional funds shall not supplant funds identified and agreed to in this AGREEMENT.

V. AMENDMENT

Any PARTY may request changes and/or additions to the provisions contained in this AGREEMENT. Such changes that are mutually agreed upon by all PARTIES shall be incorporated by written amendment to this AGREEMENT. No variation or alteration of the terms of this AGREEMENT shall be valid unless made in writing and signed by authorized representatives of the PARTIES hereto.



VI. TERM/TERMINATION

A. This AGREEMENT shall become effective as of the PARTIES' signature date last written and dated below and shall remain in effect through the design and construction of the Arboretum Mitigation Plan projects, unless terminated sooner as set forth below.

B. A PARTY may terminate this AGREEMENT only after going through the Dispute Resolution process outlined under Section IX herein.

C. In the event that WSDOT makes material modifications to the SR 520 Project that may increase the significant adverse impact of the SR 520 Project on the Arboretum, any PARTY may withdraw from this AGREEMENT after providing at least 30 calendar days written notice to the other PARTIES and after complying with the dispute resolution requirements of Section IX of this AGREEMENT. Any dispute about whether modifications to the SR 520 Project are "material" or whether they result in increased significant adverse impacts to the Arboretum shall be resolved in accordance with the dispute resolution provisions of Section IX. In the event that a PARTY withdraws from this AGREEMENT pursuant to this Section, the PARTY agrees to enter into additional negotiations with WSDOT regarding the extent of the modified SR 520 Project's increased adverse impact to the Arboretum. In the event that the withdrawing PARTY and WSDOT enter into a subsequent agreement regarding the SR 520 Project's impact to the Arboretum, any mitigation or compensation already provided to that PARTY by WSDOT shall be included in any new agreement negotiated between the PARTY and WSDOT.

VII. CONTACT AND NOTIFICATION INFORMATION

All contact among the PARTIES, and any notice required pursuant to this AGREEMENT shall be in writing and shall be sent postage prepaid by U.S. Mail, return receipt requested, to the following addresses unless otherwise indicated in writing by the PARTIES to this AGREEMENT:

Any PARTY may update the contact information above which shall not be considered an amendment to this AGREEMENT. An electronic message [email] exchanged among the contacts, indicating the updated information shall be sufficient, provided that the changed contact information is sent to all PARTIES.

VIII. INDEMNIFICATION

A. To the extent allowed by law, each PARTY shall protect, defend, indemnify, and save harmless the other PARTIES, their officers, officials, employees, and agents, while acting within the scope of their employment as such, from any and all costs, claims, judgment, and/or awards of damages, arising out of, or in any way resulting from any acts or omissions or intentional misconduct of the indemnifying PARTY. No PARTY will be required to indemnify, defend, or save harmless another PARTY if the claim, suit, or action for injuries, death, or damages is caused by the sole negligence of the indemnified PARTY. Where such claims, suits, or actions result from the concurrent negligence of the PARTIES, the indemnity provisions provided herein shall be valid and enforceable only to the extent of the indemnifying PARTY's own negligence.

B. Each of the PARTIES agrees that its obligations under this subparagraph extend to any claim, demand and/or cause of action brought by, or on behalf of, any of its employees or agents. For this purpose, each of the PARTIES, by mutual negotiation, hereby waives, with respect to the other PARTIES only, any immunity that would otherwise be available against such claims under the Industrial Insurance provision of Title 51 RCW. The obligations of this Section shall survive termination of this AGREEMENT.

IX. DISPUTE RESOLUTION

A. The PARTIES shall make good faith efforts to quickly and collaboratively resolve any dispute arising under or in connection with this AGREEMENT. The dispute resolution process outlined in this Section applies to disputes arising under or in connection with this AGREEMENT.

B. Informal Resolution. The designated representatives herein under the CONTACT AND NOTIFICATION INFORMATION section of this AGREEMENT shall use their best efforts to resolve disputes among the PARTIES promptly and at the lowest organizational level.

C. In the event that the PARTIES are unable to resolve the dispute, the PARTIES shall submit the matter to non-binding mediation facilitated by a mutually agreed-upon mediator. The ABGC, SDOT, and WSDOT shall share equally in the cost of the mediator because the other PARTIES participate in the ABGC.

D. The PARTIES agree that they shall have no right to seek relief in a court of law until and unless the Dispute Resolution process has been exhausted.





This letter memorializes WSDOT's intent to convey property in the area known informally as the "WSDOT peninsula" to the City of Seattle as mitigation for impacts of the SR 520, I-5 to Medina: Bridge Replacement and HOV Project. Although the legal details, structure, and quantity of the property transfer are still being worked out, this serves as a statement of our commitment to identify the transfer mechanism when these issues have been resolved.

The property known as the WSDOT peninsula (shown on the attached map) is approximately 26 acres in size and is contiguous with the northwestern boundary of the Washington Park Arboretum. It consists of several parcels that WSDOT (then the State Highway Department) acquired from the Arboretum in the early 1960s, when SR 520 was being planned and built. The site contains both upland and aquatic area. The property currently contains active freeway ramps connecting SR 520 to Lake Washington Boulevard, as well as unused ramps originally planned for the R.H. Thomson Expressway.

Property ownership in this area is complex. Research conducted by the state Attorney General's Office indicates the WSDOT peninsula parcels are currently owned in fee by WSDOT and are restricted in use to highway purposes. Environmental mitigation required for a highway project is considered a highway use and land conveyed to satisfy such an environmental mitigation obligation would not require monetary compensation. However, the value of the land conveyed must be equivalent in value to the mitigation obligation being satisfied. To the extent the value of the property to be conveyed exceeds the value of the mitigation obligation, WSDOT would need to determine the excess property is no longer needed for a highway purpose and the grantee would be required to pay the fair market value of that property to WSDOT.

As you know, WSDOT's wetland mitigation plan for the I-5 to Medina project currently proposes the use of the peninsula area to provide approximately 11 acres of wetland creation and enhancement. This will satisfy a portion of WSDOT's regulatory obligations for mitigation under state and federal law. As a result, the property used for wetland mitigation may be conveyed to the Seattle Parks Department at no cost, provided a



conservation easement is established for the wetland site and the Seattle Parks Department maintains the wetland in perpetuity.

The remaining portion of the peninsula is not suitable for wetland mitigation. However, because the project would acquire Section 4(f) properties under the jurisdiction of Seattle Parks that have not already been mitigated through the Section 6(f) process, the opportunity exists to use land on the peninsula to mitigate for the 4(f) impact to these properties. Accordingly, WSDOT is developing appraisals of both the Section 4(f) properties and the peninsula property to determine what proportion of the peninsula property could be appropriately used as mitigation, based on a comparison of the properties' relative values.

We anticipate that the appraisals will be completed by fall 2011. At that time, we will meet with you to discuss the property available to be used as mitigation and the appropriate process and timing for the transfer. We also anticipate discussing the commitments made in the Arboretum Mitigation Plan in the context of this additional mitigation being provided. 



Summary and background of the Legislation:

This legislation approves the mitigation agreement with the Washington State Department of Transportation (WSDOT), the University of Washington, and the Washington Park Arboretum Foundation signed January 14, 2013 addressing impacts to the Arboretum from the State’s SR 520 project. To implement the agreement, this legislation creates a new fund, Capital Improvement Program Budget Control Level and project; and accepts and appropriates \$7,810,341 of State funds for mitigation projects, including development of a multi use trail in the Washington Park Arboretum.

The agreement approved by this legislation ensures the implementation of key projects in the Arboretum’s 2001 Master Plan as required mitigation for the impacts from the upcoming replacement of the SR 520 Bridge. The multi-use trail is a major component of the Master Plan. It provides an important bicycle and pedestrian corridor connecting East Madison Street to the Montlake and University of Washington neighborhoods. The new trail will eventually link to Arboretum Drive East, forming a 2.0-mile interior bicycle-and-pedestrian loop in the Arboretum.

In addition to the mitigation projects covered by the \$7.8 million appropriated by this legislation, the agreement creates a framework for a final phase of mitigation that will take place in the Arboretum once funding is secured for the construction of West Approach Bridge South. These projects include transfer of the WSDOT Peninsula to the Arboretum, shoreline restoration, the creation of a new North Entry to the Arboretum, a new roundabout at Foster Island Road and Lake Washington Blvd, and day lighting and restoration of sections of Arboretum Creek.




