Dear Council President Clark:

I am pleased to transmit the attached proposed Council Bill that, if approved by the City Council, will adopt the City of Seattle's 2014 Budget, including position modifications, and the 2014-2019 Capital Improvement Program. The 2014 Proposed Budget totals \$4.4 billion, including \$1 billion for the General Fund. As the gradual recovery from the Great Recession continues, the 2014 Proposed Budget marks the first budget since 2009 that does not include major programmatic reductions in the City's General Fund. Rather, the 2014 Proposed Budget makes a series of modest investments to address the many needs that have emerged since 2009.

While there are signs that economic growth moderated slightly in the second quarter of 2013, the economy continues to slowly recover from the Great Recession. Relatively high employment, construction, and real estate transfers have led to increased revenue. In addition to an improved revenue outlook, the City's financial picture is considerably better as a result of our efforts to restore the health of the City's General Fund financial reserves. When I took office in 2010, the Rainy Day Fund totaled only \$10.5 million (after reaching an all-time high of \$30.6 million in 2008). By 'saving before spending,' we have regrown the Fund and with a proposed contribution of \$4.3 million in this budget, the Rainy Day Fund balance will be \$34.7 million, the largest dollar value ever.

This budget prioritizes investments to enhance public safety, protect and expand the human services safety net, empower Seattle residents, strengthen the vitality of our diverse neighborhoods, maintain and grow the City's Transportation infrastructure, and improve the efficiency and effectiveness of City government

I thank you and all of the members of the Seattle City Council for your help in producing a responsible and thoughtful budget. 4 AN ORDINANCE adopting a budget, including a capital improvement program and position
5 modifications, for The City of Seattle for 2014; creating positions exempt from civil service;
6 all by a two-thirds vote of the City Council.

7 WHEREAS, in accordance with RCW 35.32A.030, the Mayor submitted the proposed budget for
8 2014 to the City Council; and

9 WHEREAS, the Mayor submitted a list of proposed position modifications as part of the 2014
10 Proposed Budget; and

11 WHEREAS, by Resolution 24964, the City Council adopted the concept of implementing the City's
12 Capital Improvement Program through appropriations in budgets adopted annually to the
13 greatest extent feasible; and

14 WHEREAS, the proposed budget for 2014 includes certain appropriations for capital programs that
15 are described in the 2014-2019 Proposed Capital Improvement Program; and

16 WHEREAS, the City's 2014-2019 Capital Improvement Program, in conjunction with the Capital
17 Facilities, Utility and Transportation Elements of the Comprehensive Plan, is in accordance
18 with the State Growth Management Act; NOW, THEREFORE,

19 **BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:**

20 **Section 1.** (a) In accordance with RCW 35.32A.050, the City Council has modified the
21 proposed budget submitted by the Mayor.

22 (b) The appropriations for the budget control levels in Attachment A to this ordinance, as
23 restricted by the budget provisos included in Clerk File (C.F.) 313295, are adopted as the City's
24 annual budget for 2014. If a budget proviso refers to a City Council committee, and a committee by
25 that name ceases to exist, the reference shall be to the successor committee with policy oversight of
26 the same subject matter area.

27 (c) The appropriation for each budget control level in Attachment A may be used only for the
28 purpose listed in Attachment A for that budget control level, unless transferred pursuant to Seattle



1 Municipal Code (SMC) Chapter 5.08. Each budget control level listed in Attachment A is a "budget
2 item" as that term is used in SMC 5.08.020. Use of any amount of any appropriation restricted by one
3 or more of the provisos in C.F. 313295 for any other purpose than that stated, or for any purpose
4 expressly excluded, or in violation of any condition specified by proviso, whether by transfer
5 pursuant to SMC 5.08.020 or by any other means, is prohibited.

6 (d) In addition to each budget control level in Attachment A, any budget control level created
7 by a previous budget, for which appropriations remain that have not lapsed, is part of the 2014
8 budget and the un-lapsed appropriations for that budget control level are subject to the restrictions in
9 subsection 1(c) above. These un-lapsed appropriations continue to be subject to any provisos
10 previously placed on them that have yet to be removed or satisfied.

11 (e) The funds appropriated in each budget control level are available to first satisfy any
12 obligations incurred by contract, including but not limited to satisfaction of any bond obligation,
13 contractual indemnity provision or lease obligation.

14 (f) Unspent funds for the Executive Department Office of Housing's Low-Income Housing
15 Fund 16400 Budget Control Level appropriated by Subsection 1(b) shall carry forward to subsequent
16 fiscal years until they are exhausted or abandoned by ordinance.

17 (g) The revenue estimates for 2014 contained in the Mayor's 2014 Proposed Budget, filed in
18 C.F. 313293, as modified by the changes of the City Council in C.F. 313295, are adopted.

19 **Section 2.** The 2014-2019 Proposed Capital Improvement Program submitted by the Mayor,
20 filed in C.F. 313294, as modified by the changes of the City Council in C.F. 313295, is adopted as
21 the City's six-year Capital Improvement Program ("CIP").

22 **Section 3.** (a) The officer and employee position modifications in Attachment B, including
23 the creation of some positions exempt from civil service, are adopted effective January 1, 2014.
24

1 (b) The City by enacting Ordinance 124234 established a position list effective as of January
2 1, 2013. Subsection 3(a) of this ordinance modifies that list. It is anticipated that the Personnel
3 Department will submit a proposed list of the City's regular positions for each department or office as
4 of January 1, 2014, to the City Council for possible action in early 2014. The proposed list should
5 reflect (i) the modifications made in Subsection 3(a) of this ordinance that take effect on January 1,
6 2014; (ii) the reclassifications of regular positions made by the Personnel Director from January 1,
7 2013, through December 31, 2013; and (iii) the creation, modification, or abrogation of regular
8 positions, by ordinance, that took effect from January 1, 2013, through December 31, 2013.
9

10 **Section 4.** (a) Subject to the conditions in Section 1 above, the appropriation of money in the
11 budget adopted by this ordinance, for a budget control level that includes a program or project
12 assigned a project identification number in the 2014-2019 Adopted CIP, constitutes authority for the
13 designated City department, commission, or office (after compliance with the State Environmental
14 Policy Act) to acquire personal property; obtain options to acquire real property; negotiate to acquire
15 right-of-way and other real property interests; prepare plans and designs; demolish, construct, make
16 improvements; and obtain any ancillary services, including, without limitation, planning,
17 engineering, design, appraisal, escrow, title insurance, construction, inspection, environmental audits,
18 and remediation appraisals or other reviews; all in order to carry out the project or program
19 substantially as described in the 2014-2019 Adopted CIP. Each department may obtain the
20 authorized services or property using City staff or by contract as authorized in Section 4(j). If
21 projects or programs are identified in the 2014-2019 Adopted CIP to be carried out by other entities
22 wholly or in part with City funds, the appropriation constitutes authority to provide such funds to
23 such other entities for such purposes, subject to applicable laws and ordinances.
24
25

26 (b) None of the appropriations in the 2014 Adopted Budget may be spent on capital projects
27 or programs unless the projects or programs are specifically identified and assigned a project
28



1 identification number in the 2014-2019 Adopted CIP or are added to the 2014-2019 Adopted CIP by
2 a future amending ordinance.

3 (c) Without future Council authorization by ordinance, expenditures in 2014 on any project
4 or program identified and assigned a project identification number in the 2014-2019 Adopted CIP for
5 Seattle City Light, Seattle Public Utilities, or the Seattle Department of Transportation, other than
6 expenditures pursuant to unspent capital appropriations carried forward from 2013 into 2014 in
7 accordance with RCW 35.32A.080 and allocated to the same project or program, shall not exceed by
8 more than \$1,000,000 the amount shown as the Appropriations Total in the 2014 column for that
9 project or program in the Adopted CIP, as that amount may be amended by ordinance. The City
10 Budget Office shall certify to the Chair of the City Council Budget Committee a list of those unspent
11 capital appropriations not subject to the expenditure restriction imposed by this subsection by May 1,
12 2014, and shall also file the list with the City Clerk. The list shall include the project identification
13 number and the dollar amount by project or program not subject to the expenditure restriction, at
14 minimum.
15

16 (d) Moneys appropriated from funds, subfunds, accounts, and subaccounts in which are
17 deposited the proceeds derived from the issuance of bonded obligations shall be expended only in
18 accordance with the terms, conditions, and restrictions of ordinances authorizing such obligations
19 and establishing the respective funds.
20

21 (e) The 2014-2019 Adopted CIP is part of the 2014 Adopted Budget and identifies, among
22 other projects, those capital projects funded wholly or in part from the proceeds of the taxes
23 authorized in RCW 82.46.010 and/or RCW 82.46.035, and/or from the proceeds of bonds, for the
24 repayment of which tax revenues under RCW 82.46.010 have been pledged. Such taxes are intended
25 to be in addition to other funds that may be reasonably available for such capital projects.
26

1 (f) The portions of the 2014-2019 Adopted CIP pertaining to Seattle City Light and Seattle
2 Public Utilities, as those portions of the 2014-2019 Adopted CIP may be amended from time to time,
3 are adopted as systems or plans of additions to, and betterments and extensions of, the facilities,
4 physical plants, or systems of Seattle City Light and Seattle Public Utilities, respectively.

5 (g) The Director of Finance and Administrative Services and the City's Director of Finance
6 are authorized to draw and pay the necessary warrants or checks and to make any necessary transfers
7 among funds and accounts.

8 (h) Except as limited by this Section or by Section 1 above or by any other ordinance, the
9 funds appropriated in the 2014 Adopted Budget are subject to transfer for use with other projects as
10 provided in SMC Chapter 5.08.

11 (i) The Mayor or, at the Mayor's request, the head of the department that is designated to
12 carry out a project for and on behalf of The City of Seattle, is authorized to submit applications as
13 may be deemed appropriate to the United States of America, or any of its departments, and the State
14 of Washington, or any of its departments, for financial assistance in carrying out the authorized
15 projects included in the 2014-2019 Adopted CIP; to make for and on behalf of the City all
16 assurances, promises, representations, and consent to suit, and/or covenants to comply with any
17 applicable regulations of the United States relating to implementation of the projects; to act in
18 connection with the applications as the authorized representative of the City; to provide additional
19 information as may be required; and to prepare plans for implementation of terms and conditions as
20 may accompany financial assistance, provided that the submission of an application shall not result in
21 the making of a contract, in incurring of any indebtedness, or in the acceptance of moneys imposing
22 any duties or obligations upon the City except as is authorized by this or other ordinance.

23 (j) The Director of Transportation, the Superintendent of Parks and Recreation, the Director
24 of the Office of Arts and Cultural Affairs, the General Manager and Chief Executive Officer of City
25



1 Light, the Director of Seattle Public Utilities, the Director of the Department of Finance and
2 Administrative Services, the City Librarian, the Chief Technology Officer, and the Director of the
3 Seattle Center Department are authorized to negotiate for and enter into non-public works contracts,
4 within their appropriation authority, to obtain property and services authorized in Section 4 to carry
5 out those capital projects and programs included in the 2014-2019 Adopted CIP and assigned to their
6 respective departments or offices.

7 **Section 5.** The Mayor and the City Council find that the General Fund's 2014 contribution to
8 the Park and Recreation Fund exceeds the requirements established in Article XI, Section 3 of the
9 City Charter.
10

11 **Section 6.** Pursuant to the requirements of Ordinance 117216, Ordinance 118814,
12 Ordinance 122293, Ordinance 122859, Ordinance 123459, and Ordinance 124057, the City in
13 Section 1(b) and Attachment A to this ordinance appropriates to the Firefighters' Pension Fund (the
14 Fund) \$19,320,392, of which \$18,047,538 comes from General Fund resources. No beneficiary of
15 the Fund has a vested contractual right to the appropriation of the foregoing amount or any amount
16 appropriated by the City to the Fund.
17

18 The Mayor and the City Council, under the authority granted by RCW 41.16.060, find that
19 the General Fund's 2014 contribution to the Fund is equal to \$0.140858 per \$1,000 of assessed value
20 and provides, in accordance with the 2013 Actuarial Report on the condition of the Fund received
21 from a qualified actuary and dated September 16, 2013, together with other amounts appropriated by
22 the City for the Fund, an amount equal to or greater than the estimated demands on the Fund for 2014
23 and maintains the actuarial soundness of the Fund as it prevents recording a positive net pension
24 obligation for the Fund.
25

26 The Mayor and the City Council find that the amount appropriated by this ordinance is
27 appropriated for the purpose of keeping the Fund flexible, and maintaining its integrity and actuarial
28




1 soundness. The Mayor and City Council also find that such amount is reasonable for the purposes
2 established in the ordinances listed at the beginning of Section 6, and that such amount bears a
3 material relation to the successful operation of the Fund.

4 **Section 7.** The provisions of this ordinance are declared to be separate and severable. If one
5 or more of the provisions of this ordinance is declared by any court of competent jurisdiction to be
6 contrary to law, the provision shall be severed from the rest of the ordinance and all other provisions
7 shall remain valid.


8 **Section 8.** This ordinance shall take effect and be in force 30 days after its approval by the
9 Mayor, but if not approved and returned by the Mayor within ten days after presentation, it shall take
10 effect as provided by Seattle Municipal Code Section 1.04.020.

4 AN ORDINANCE adopting a budget, including a capital improvement program and position
5 modifications, for The City of Seattle for 2014; creating positions exempt from civil service;
6 all by a two-thirds vote of the City Council.

7 WHEREAS, in accordance with RCW 35.32A.030, the Mayor submitted the proposed budget for
8 2014 to the City Council; and

9 WHEREAS, the Mayor submitted a list of proposed position modifications as part of the 2014
10 Proposed Budget; and

11 WHEREAS, by Resolution 24964, the City Council adopted the concept of implementing the City's
12 Capital Improvement Program through appropriations in budgets adopted annually to the
13 greatest extent feasible; and

14 WHEREAS, the proposed budget for 2014 includes certain appropriations for capital programs that
15 are described in the 2014-2019 Proposed Capital Improvement Program; and

16 WHEREAS, the City's 2014-2019 Capital Improvement Program, in conjunction with the Capital
17 Facilities, Utility and Transportation Elements of the Comprehensive Plan, is in accordance
18 with the State Growth Management Act; NOW, THEREFORE,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

19 **Section 1.** (a) In accordance with RCW 35.32A.050, the City Council has modified the
20 proposed budget submitted by the Mayor.

21 (b) The appropriations for the budget control levels in Attachment A to this ordinance, as
22 restricted by the budget provisos included in Clerk File (C.F.) 313295, are adopted as the City's
23 annual budget for 2014.

24 (c) The appropriation for each budget control level in Attachment A may be used only for the
25 purpose listed in Attachment A for that budget control level, unless transferred pursuant to Seattle
26 Municipal Code (SMC) Chapter 5.08. Each budget control level listed in Attachment A is a "budget
27 item" as that term is used in SMC 5.08.020. Use of any amount of any appropriation restricted by one

1 or more of the provisos in C.F. 313295 for any other purpose than that stated, or for any purpose
2 expressly excluded, or in violation of any condition specified by proviso, whether by transfer
3 pursuant to SMC 5.08.020 or by any other means, is prohibited.

4 (d) In addition to each budget control level in Attachment A, any budget control level created
5 by a previous budget, for which appropriations remain that have not lapsed, is part of the 2014
6 budget and the un-lapsed appropriations for that budget control level are subject to the restrictions in
7 subsection 1(c) above. These un-lapsed appropriations continue to be subject to any provisos
8 previously placed on them that have yet to be removed or satisfied.

9
10 (e) The funds appropriated in each budget control level are available to first satisfy any
11 obligations incurred by contract, including but not limited to satisfaction of any bond obligation,
12 contractual indemnity provision or lease obligation.

13 (f) Unspent funds for the Executive Department Office of Housing's Low-Income Housing
14 Fund 16400 Budget Control Level appropriated by Subsection 1(b) shall carry forward to subsequent
15 fiscal years until they are exhausted or abandoned by ordinance.

16 (g) The revenue estimates for 2014 contained in the Mayor's 2014 Proposed Budget, filed in
17 C.F. 313293, as modified by the changes of the City Council in C.F. 313295, are adopted.

18
19 **Section 2.** The 2014-2019 Proposed Capital Improvement Program submitted by the Mayor,
20 filed in C.F. 313294, as modified by the changes of the City Council in C.F. 313295, is adopted as
21 the City's six-year Capital Improvement Program ("CIP").

22 **Section 3.** (a) The officer and employee position modifications in Attachment B, including
23 the creation of some positions exempt from civil service, are adopted effective January 1, 2014.

24 (b) The City by enacting Ordinance 124234 established a position list effective as of January
25 1, 2013. Subsection 3(a) of this ordinance modifies that list. It is anticipated that the Personnel
26 Department will submit a proposed list of the City's regular positions for each department or office as
27

1 of January 1, 2014, to the City Council for possible action in early 2014. The proposed list should
2 reflect (i) the modifications made in Subsection 3(a) of this ordinance that take effect on January 1,
3 2014; (ii) the reclassifications of regular positions made by the Personnel Director from January 1,
4 2013, through December 31, 2013; and (iii) the creation, modification, or abrogation of regular
5 positions, by ordinance, that took effect from January 1, 2013, through December 31, 2013.

6 **Section 4.** (a) Subject to the conditions in Section 1 above, the appropriation of money in the
7 budget adopted by this ordinance, for a budget control level that includes a program or project
8 assigned a project identification number in the 2014-2019 Adopted CIP, constitutes authority for the
9 designated City department, commission, or office (after compliance with the State Environmental
10 Policy Act) to acquire personal property; obtain options to acquire real property; negotiate to acquire
11 right-of-way and other real property interests; prepare plans and designs; demolish, construct, make
12 improvements; and obtain any ancillary services, including, without limitation, planning,
13 engineering, design, appraisal, escrow, title insurance, construction, inspection, environmental audits,
14 and remediation appraisals or other reviews; all in order to carry out the project or program
15 substantially as described in the 2014-2019 Adopted CIP. Each department may obtain the
16 authorized services or property using City staff or by contract as authorized in Section 4(j). If
17 projects or programs are identified in the 2014-2019 Adopted CIP to be carried out by other entities
18 wholly or in part with City funds, the appropriation constitutes authority to provide such funds to
19 such other entities for such purposes, subject to applicable laws and ordinances.

22 (b) None of the appropriations in the 2014 Adopted Budget may be spent on capital projects
23 or programs unless the projects or programs are specifically identified and assigned a project
24 identification number in the 2014-2019 Adopted CIP or are added to the 2014-2019 Adopted CIP by
25 a future amending ordinance.
26

1 (c) Without future Council authorization by ordinance, expenditures in 2014 on any project
2 or program identified and assigned a project identification number in the 2014-2019 Adopted CIP for
3 Seattle City Light, Seattle Public Utilities, or the Seattle Department of Transportation, other than
4 expenditures pursuant to unspent capital appropriations carried forward from 2013 into 2014 in
5 accordance with RCW 35.32A.080 and allocated to the same project or program, shall not exceed by
6 more than \$1,000,000 the amount shown as the Appropriations Total in the 2014 column for that
7 project or program in the Adopted CIP, as that amount may be amended by ordinance. The City
8 Budget Office shall certify to the Chair of the City Council Budget Committee a list of those unspent
9 capital appropriations not subject to the expenditure restriction imposed by this subsection by May 1,
10 2014, and shall also file the list with the City Clerk. The list shall include the project identification
11 number and the dollar amount by project or program not subject to the expenditure restriction, at
12 minimum.
13

14 (d) Moneys appropriated from funds, subfunds, accounts, and subaccounts in which are
15 deposited the proceeds derived from the issuance of bonded obligations shall be expended only in
16 accordance with the terms, conditions, and restrictions of ordinances authorizing such obligations
17 and establishing the respective funds.
18

19 (e) The 2014-2019 Adopted CIP is part of the 2014 Adopted Budget and identifies, among
20 other projects, those capital projects funded wholly or in part from the proceeds of the taxes
21 authorized in RCW 82.46.010 and/or RCW 82.46.035, and/or from the proceeds of bonds, for the
22 repayment of which tax revenues under RCW 82.46.010 have been pledged. Such taxes are intended
23 to be in addition to other funds that may be reasonably available for such capital projects.
24

25 (f) The portions of the 2014-2019 Adopted CIP pertaining to Seattle City Light and Seattle
26 Public Utilities, as those portions of the 2014-2019 Adopted CIP may be amended from time to time,
27

1 are adopted as systems or plans of additions to, and betterments and extensions of, the facilities,
2 physical plants, or systems of Seattle City Light and Seattle Public Utilities, respectively.

3 (g) The Director of Finance and Administrative Services and the City's Director of Finance
4 are authorized to draw and pay the necessary warrants or checks and to make any necessary transfers
5 among funds and accounts.

6 (h) Except as limited by this Section or by Section 1 above or by any other ordinance, the
7 funds appropriated in the 2014 Adopted Budget are subject to transfer for use with other projects as
8 provided in SMC Chapter 5.08.

9 (i) The Mayor or, at the Mayor's request, the head of the department that is designated to
10 carry out a project for and on behalf of The City of Seattle, is authorized to submit applications as
11 may be deemed appropriate to the United States of America, or any of its departments, and the State
12 of Washington, or any of its departments, for financial assistance in carrying out the authorized
13 projects included in the 2014-2019 Adopted CIP; to make for and on behalf of the City all
14 assurances, promises, representations, and consent to suit, and/or covenants to comply with any
15 applicable regulations of the United States relating to implementation of the projects; to act in
16 connection with the applications as the authorized representative of the City; to provide additional
17 information as may be required; and to prepare plans for implementation of terms and conditions as
18 may accompany financial assistance, provided that the submission of an application shall not result in
19 the making of a contract, in incurring of any indebtedness, or in the acceptance of moneys imposing
20 any duties or obligations upon the City except as is authorized by this or other ordinance.

21 (j) The Director of Transportation, the Superintendent of Parks and Recreation, the Director
22 of the Office of Arts and Cultural Affairs, the General Manager and Chief Executive Officer of City
23 Light, the Director of Seattle Public Utilities, the Director of the Department of Finance and
24 Administrative Services, the City Librarian, the Chief Technology Officer, and the Director of the
25

27

1 Seattle Center Department are authorized to negotiate for and enter into non-public works contracts,
2 within their appropriation authority, to obtain property and services authorized in Section 4 to carry
3 out those capital projects and programs included in the 2014-2019 Adopted CIP and assigned to their
4 respective departments or offices.

5 **Section 5.** The Mayor and the City Council find that the General Fund's 2014 contribution to
6 the Park and Recreation Fund exceeds the requirements established in Article XI, Section 3 of the
7 City Charter.

8 **Section 6.** Pursuant to the requirements of Ordinance 117216, Ordinance 118814,
9 Ordinance 122293, Ordinance 122859, Ordinance 123459, and Ordinance 124057, the City in
10 Section 1(b) and Attachment A to this ordinance appropriates to the Firefighters' Pension Fund (the
11 Fund) \$19,320,392, of which \$18,047,538 comes from General Fund resources. No beneficiary of
12 the Fund has a vested contractual right to the appropriation of the foregoing amount or any amount
13 appropriated by the City to the Fund.
14

15 The Mayor and the City Council, under the authority granted by RCW 41.16.060, find that
16 the General Fund's 2014 contribution to the Fund is equal to \$0.140858 per \$1,000 of assessed value
17 and provides, in accordance with the 2013 Actuarial Report on the condition of the Fund received
18 from a qualified actuary and dated September 16, 2013, together with other amounts appropriated by
19 the City for the Fund, an amount equal to or greater than the estimated demands on the Fund for 2014
20 and maintains the actuarial soundness of the Fund as it prevents recording a positive net pension
21 obligation for the Fund.
22

23 The Mayor and the City Council find that the amount appropriated by this ordinance is
24 appropriated for the purpose of keeping the Fund flexible, and maintaining its integrity and actuarial
25 soundness. The Mayor and City Council also find that such amount is reasonable for the purposes
26

1 established in the ordinances listed at the beginning of Section 6, and that such amount bears a
2 material relation to the successful operation of the Fund.

3 **Section 7.** The provisions of this ordinance are declared to be separate and severable. If one
4 or more of the provisions of this ordinance is declared by any court of competent jurisdiction to be
5 contrary to law, the provision shall be severed from the rest of the ordinance and all other provisions
6 shall remain valid.

7 **Section 8.** This ordinance shall take effect and be in force 30 days after its approval by the
8 Mayor, but if not approved and returned by the Mayor within ten days after presentation, it shall take
9 effect as provided by Seattle Municipal Code Section 1.04.020.
