

1 WHEREAS, City Light and the Department of Parks and Recreation have determined the fair
2 market value of the Morningside Property by real estate appraisal, which assumes there is
3 no Hazardous Substance (as defined in Section 5 below) in or on the Morningside
4 Property that would affect the value of the Morningside Property, and City Light has
5 agreed to credit the Department of Parks and Recreation for certain costs for
6 environmental testing; NOW, THEREFORE,

7 **BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:**

8 Section 1. Pursuant to the provisions of R.C.W. 35.94.040 and after public hearing, the
9 real property commonly known as the Morningside Substation Property (“Morningside
10 Property”), legally described below, is declared no longer needed for the City of Seattle’s utility
11 purposes and is surplus to the City’s utility needs:

12 *The east half of the south half of the east half of Block 4, Earl J. McLaughlin’s*
13 *Addition to Seattle, according to the Plat thereof recorded in Volume 15 of Plats,*
14 *page 48, in King County, Washington.*

15 *EXCEPT that portion for street.*

16 Section 2. Jurisdiction over the Morningside Property is hereby transferred from Seattle
17 City Light (“City Light”) to the Department of Parks and Recreation for open space, park, and
18 recreation purposes, upon payment of One Million Sixty Thousand Four Hundred Forty Dollars
19 (\$1,060,440) to the Light Fund (Fund 41000) from the 2008 Parks Levy Fund.

20 Section 3. In order to pay for necessary capital costs and expenses incurred, or to be
21 incurred, but for which insufficient appropriations were made due to causes that could not
22 reasonably have been foreseen at the time the 2013 budget was adopted, the appropriation for the
23 following in the 2013 Adopted Budget and the 2013-2018 Adopted Capital Improvement
24 Program is increased from the funds shown, as follows:



Section 4. Notwithstanding the transfer of jurisdiction, City Light shall remain responsible for all costs and expenses for response, removal, or other remedial action, including disposal, of any Hazardous Substance in or on the Morningside Property or improvements thereon caused by City Light's use, occupation, or operation of the Morningside Property.

Section 5. For purposes of this ordinance, the term Hazardous Substance means any substance or material defined or designated as a hazardous, dangerous, radioactive or toxic material, waste or substance, environmental pollutant or contaminant, including without limitation asbestos and petroleum products, or other similar term by any Environmental Laws, and the term Environmental Laws means any environmental or health and safety-related law, regulation, or rule, ordinance or directive at the federal, state or local level, whether existing as of the date of this Ordinance, previously enforced or subsequently enacted.


1 Section 6. This ordinance shall take effect and be in force 30 days from and after its
2 approval by the Mayor, but if not approved and returned by the Mayor within ten days after
3 presentation, it shall take effect as provided by Municipal Code Section 1.04.020.

Legislation Title: AN ORDINANCE relating to the 2008 Parks and Green Spaces Levy; transferring jurisdiction of the Morningside Substation Property from Seattle City Light to the Department of Parks and Recreation for open space, park, and recreation purposes; and increasing appropriations to the Department of Parks and Recreation in the 2013 Budget; all by a three-fourths vote of the City Council.

Summary and background of the Legislation:

On November 4, 2008, Seattle voters approved a six-year property tax levy, the 2008 Parks and Green Spaces Levy (Levy), for the purpose of improving and expanding the City's parks and green spaces. The proposed Council Bill transfers jurisdiction of the Morningside Substation Property (Property) from Seattle City Light (SCL) to the Department of Parks and Recreation (DPR) for open space, park, and recreation purposes and requests appropriation to cover the costs of the transfer. The transfer of jurisdiction of this 14,255 square-foot site, situated in the Wedgwood neighborhood of northeast Seattle, will provide a future new neighborhood park in an underserved area of the City and help satisfy DPR's goal of providing parks within walking distances for all residents of Seattle. This acquisition will fill an identified open space gap in the Wedgwood neighborhood. The property will remain vacant until development funding is available.

SCL acquired the Property for electrical utility purposes and the Property is no longer required for those purposes. In compliance with applicable law, DPR will deposit \$1,060,440, the negotiated fair market value of the Property (\$1,120,000) minus environmental testing costs incurred by DPR (\$59,560), using new appropriation, into the Light Fund for the transfer of jurisdiction.

Notes: The total project cost for this acquisition is \$1,200,000, for the purchase price and related costs and expenses associated with property acquisition, including, but not limited to title, survey, environmental assessment, project administration, public meetings, and other miscellaneous expenses. The City has been awarded \$500,000 in 2012 King County Conservation Futures to offset acquisition costs. These funds require a 50% match and are paid on a reimbursement basis. When the Conservation Futures grant is received, the 2008 Parks Levy Fund will be reimbursed by \$500,000.

Achievement of one of the goals of the Neighborhood Park Acquisitions category of the 2008 Parks Levy, which is acquiring real property and expanding open space networks, would be delayed. This delay and further staff cost to meet this goal with another effort would consume additional and unanticipated resources from the 2008 Parks Levy Fund.
- c) **Does this legislation affect any departments besides the originating department?**
Yes, Seattle City Light.
- d) **What are the possible alternatives to the legislation that could achieve the same or similar objectives?** DPR could try to find another opportunity like this in the same area, but to do this would require spending additional resources and would delay the goal for park acquisition in this underserved area as mentioned in the 2008 Parks Levy. City Council approval is required for transfer of jurisdiction.

I am transmitting the attached proposed Council Bill that transfers jurisdiction of the Morningside substation property, located at 8605 35th Avenue NE, from Seattle City Light (City Light) to the Department of Parks and Recreation (DPR) for open space, park, and recreation purposes. The Wedgwood Neighborhood was included in the 2008 Parks and Green Spaces Levy as a candidate for a neighborhood park acquisition to fill an open space gap identified in the Department's 2006 Gap analysis. The Morningside substation property, the subject of this legislation, is well-suited for development as a park.

The Wedgwood Community Council conducted significant public outreach in the search for an appropriate park site and concluded the Morningside substation property is the site best suited to the community's needs. City Light has determined that the Morningside substation property is surplus to its needs and is willing to transfer it to DPR.


