9 WHEREAS, the City Council adopted Statement of Legislative Intent 41-1-A-1 with the 2014
10 Adopted Budget, requesting to elevate the Office for Education within the Department of
11 Neighborhoods to a separate Department of Education and Early Learning; and

12 WHEREAS, the Mayor has developed a proposal that would transfer key early learning program
13 responsibilities of the Human Services Department as well as the Seattle Youth Violence
14 Prevention Initiative to this new department; and

15 WHEREAS, the Mayor recognizes the importance of integrating key education and early
16 learning programs to improve child outcomes by creating better programmatic alignment,
17 streamlining processes and leveraging multiple program investments; and

18 WHEREAS, Seattle is home to a number of world-renowned higher education institutions; and

19 WHEREAS, the City's engagement with the higher education community can further goals of
20 economic development and position Seattle as a national leader for academic, technology
21 and scientific research; and

22 WHEREAS, Race and Social Justice concerns are particularly critical in the education sphere,
23 where disparities in opportunity and access can have widespread and lifelong impacts;
24 and

25 WHEREAS, outreach, communication and building capacity with underserved communities will
26 create sustainable solutions for Race and Social Justice issues; NOW, THEREFORE,

27 **BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:**

28 Section 1. Subchapter V of Chapter 3.20, including sections 3.20.300 and 3.20.310, of
the Seattle Municipal Code is repealed and the Office for Education is abolished.

~~A. Families and Education Levy. The Office shall:~~

- ~~1. Perform the strategic planning necessary to establish a policy framework for the City's involvement in education and school-related initiatives, including the Families and Education Levy;~~

- ~~3. Negotiate a levy interlocal agreement between the City and the Seattle School District; and~~

12 Section 2. A new Chapter 3.36 is added to the Seattle Municipal Code as follows:

13 3.36 Department of Education and Early Learning

15 **3.36.010 Department created—purpose**

16 A Department of Education and Early Learning is created. The mission of the
17 Department is to ensure that all Seattle children have the greatest opportunity to succeed in
18 school and in life and to graduate from high school ready for college or a career.

19 This Department shall facilitate the City's support for the educational and developmental
20 needs of children birth to preschool, students in Seattle's public schools, students in post-
21 secondary programs, and their families. The Department is responsible for leadership, direction,
22 policy development, interdepartmental and interagency communication and coordination
23 regarding:

25 A. Early Learning Programs. The Department shall:
26

1 1. Administer, align and integrate policies and funding for Seattle's
2 education and early learning programs/initiatives for children from birth through age eight (3rd
3 grade) to improve learning outcomes for children; and

4 2. Provide coordination and collaboration with Early Learning systems,
5 Early Learning providers, the Washington State Department of Early Learning and public
6 schools to ensure high quality early learning services are available to families and to support a
7 seamless transition from early education systems into school.
8

9 B. Education Programs and Policies. The Department shall:

10 1. Act as the liaison between the City and public schools on all education issues
11 of joint concern, including, but not limited to, before and after school programs, Families and
12 Education Levy implementation, school safety, transportation and planning for growth;
13

14 2. Develop and facilitate City interdepartmental collaboration to assure City-
15 funded programs within public schools are operating efficiently and effectively;

16 3. Work cooperatively with public schools to develop new educational support
17 resources and ensure coordinated linkage, as appropriate, with community-based services; and
18

19 4. Act as a liaison with other education agencies in the region to promote a
20 coordinated response to education related issues.

21 C. Higher Education Liaison. The Department shall:

22 1. Act as a liaison to higher education institutions on all education issues of
23 joint concern and build partnerships for academic, economic and social advancement;

24 2. Facilitate collaboration between local higher education representatives and
25 the City to:

1 a. Align investments, initiatives and priorities to achieve shared
2 goals of increased student success and higher levels of educational attainment; and

3 b. Engage in planning and development of new policies and
4 partnership opportunities, including facilitating relationships between higher education
5 institutions and other City departments to advance and meet common goals; and

6 3. Support educational institutions in linking career education and workforce
7 development programs with City investments on employability and equity.
8

9 D. Access and Communication. The Department shall improve access to and
10 communication among key education leaders and decision-makers in the public, private,
11 nonprofit and philanthropic sectors.
12

13 E. Race and Social Justice. The Department shall:
14

15 1. Embed Race and Social Justice Initiative goals and principles into the day-
16 to-day approach to advancing the City's mission and objectives for education in Seattle; and

17 2. Strive to build necessary capacity for quality learning services in emerging
18 and/or underserved communities.
19

20 F. Families and Education Levy. The Department shall:

21 1. Perform the strategic planning necessary to establish a policy framework for the
22 City's involvement in education and school-related initiatives, including the Families and
23 Education Levy;

24 2. Provide staffing and logistical support to the Families and Education Levy
25 Oversight Committee and interdepartmental teams;

1 3. Administer a levy partnership agreement between the City and Seattle School
2 District No. 1; and

3 4. Develop and oversee interagency and interdepartmental collaborative planning,
4 implementation, and evaluation of Families and Education Levy funded programs.

5 **3.36.020 Director created, term, appointment and removal**

6 The Director of Education shall be the head of the Department of Education and Early
7 Learning. The Director shall be appointed by the Mayor, subject to confirmation by a majority
8 vote of all members of the City Council, subject to reappointment and reconfirmation every four
9 years. The Mayor may remove the Director at any time upon filing a statement of his or her
10 reasons with the City Council.
11

12 **3.36.030 Director's duties**

13 The Director shall be responsible for the administration of the department and shall:

14 A. Appoint, remove, supervise and control officers and employees in the Department of
15 Education and Early Learning in accordance with civil service rules and regulations;
16

17 B. Develop, manage, and evaluate programs providing the services for which the
18 Department of Education and Early Learning is responsible;
19

20 C. Manage the preparation of the proposed annual budget of the Department of Education
21 and Early Learning; authorize necessary expenditures and enter into contracts for professional
22 and expert services in accordance with the annual budget; develop and manage programs; and
23 supervise development and maintenance of adequate managerial and accounting systems and
24 procedures;
25

26 D. Execute, administer, modify and enforce agreements and instruments as he or she shall
27 deem appropriate for carrying out the responsibilities, functions, and activities of the
28

1 Department; apply for grants and donations for departmental programs; and solicit and use
2 volunteer services;

3 E. Promulgate rules and regulations to carry out departmental activities pursuant to the
4 Administrative Code, Chapter 3.02; and

5 F. Have such other and further powers and duties as shall be prescribed by ordinance.

8 Section 3. Section 3.35.010 of the Seattle Municipal Code, last amended by Ordinance
9 120773, is amended as follows:

10 **3.35.010 Department established—~~((P))~~purpose~~((r))~~**

11 There is established a Department of Neighborhoods to provide citizens and
12 neighborhoods with consolidated, accessible, and effective tools and resources:

13 A. To identify and address their diverse character and needs;

14 B. To assist their participation in the processes of City government;

15 C. To improve two ~~((2))~~ way communication between them and City departments;

16 D. To give them the capacity to build their communities;

17 E. To encourage their participation in finding solutions to their problems;

18 F. To encourage their communication and collaboration with other neighborhoods,
19
20 business organizations and community groups;

21
22 G. To implement the Neighborhood Planning and Assistance Program adopted by
23 Resolution 27709; and

24 H. To foster coordination and unity of purpose among neighborhoods~~((;))~~ and City
25 government ~~((and the schools through co-location with the City's Office for Education)).~~

1 Section 4. Section 3.35.030 of the Seattle Municipal Code, last amended by Ordinance
2 123361, is amended as follows:

3 **3.35.030 Director—~~((F))~~functions~~((r))~~**

4 The Director of the Department of Neighborhoods shall manage the department and shall:

5 A. Serve as liaison with citizens, neighborhoods and other community organizations;

6 B. Manage the City's system of neighborhood service centers; provide staff for the City
7 Neighborhood Council and district councils; and administer the Neighborhood Matching Fund
8 Program and the Neighborhood Matching Fund;

9 C. Conduct outreach programs to elicit citizen participation; present neighborhood
10 concerns to City departments and strengthen departmental responses to neighborhood problems;
11 assure coordinated departmental responses to neighborhood concerns; and mediate disputes
12 between City departments and affected communities;

13 D. Assist communities in understanding and responding to proposed projects and
14 activities affecting local land uses and the quality of the neighborhood environment; and
15 facilitate community meetings on City issues and actions having an impact on neighborhoods;

16 E. Assist communities in identifying problems and needs and help them develop,
17 coordinate and implement neighborhood plans and other actions to address such issues; and
18 report annually to the City Council regarding the status of neighborhood plans;

19 F. Provide technical assistance to neighborhoods undertaking general organizing efforts;

20 ~~((G. In collaboration with the Mayor, appoint the director of the Office for Education and
21 oversee that office's programs and functions;))~~

22 ~~((H.))~~ G. Oversee and direct the Neighborhood Action Team Seattle to foster a multi-
23 department and community engagement approach to solving complex public safety problems;

6 Section 5. It is the express intent of the City Council that, in the event a subsequent
7 ordinance refers to a position or office that was abolished by this ordinance, that reference shall
8 be deemed to be to the new position or office created by this ordinance, and shall not be
9 construed to resurrect the old position or office unless it expressly so provides by reference to
10 this ordinance.
11

12
13 Section 6. It is the express intent of the City Council that, in the event a subsequent
14 ordinance refers to or amends a section or subsection of the Seattle Municipal Code or a
15 previously enacted ordinance that is amended or recodified in this ordinance, but the later
16 ordinance fails to account for the change made by this ordinance, the two sets of amendments
17 should be given effect together if at all possible.
18

21 Section 7. A new Education Fund is created in the City Treasury effective January 1,
22 2015, to which revenues may be deposited, and from which associated expenditures may be paid
23 including, but not limited to, operating, maintenance, capital and City administration costs for
24 the purposes described in Section 8 below.

1 Section 8. The purpose of creating the Education Fund is to separately account for the
2 expenditures of the Department of Education and Early Learning.



4 Section 9. The new Education Fund shall receive revenues from the Families and
5 Education Levy, the General Fund, and other monies as authorized. The Fund shall receive
6 earnings on its positive balances and pay interest on its negative balances.

7
8 Section 10. The Director of the Department of Education and Early Learning shall have
9 responsibility for administering the Education Fund. The Director of Finance is authorized to
10 create other Subfunds, Accounts, or Subaccounts as may be needed to implement the Fund's
11 purpose and intent as established by this ordinance.

2 Section 11. This ordinance shall take effect and be in force 30 days after its approval by
3 the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it
4 shall take effect as provided by Seattle Municipal Code Section 1.04.020.

Legislation Title:

AN ORDINANCE relating to the City’s support for education; abolishing the Office for Education and creating a Department of Education and Early Learning; repealing subchapter V of Chapter 3.20 and redesignating the subchapter titles; adding new sections 3.36.010, 3.36.020, 3.36.030, and 3.36.040; amending sections 3.35.010 and 3.35.030 of the Seattle Municipal Code; and creating a fund for education purposes.

Summary of the Legislation:

This ordinance creates the Department of Education and Early Learning (DEEL). In doing so, it abolishes the Office for Education and deems DEEL as its successor institution, establishes an Education Fund to act as the operating fund for the new department, and defines the duties and purpose of DEEL.

The mission of DEEL is to ensure that all Seattle children have the greatest opportunity to succeed in school and in life and to graduate from school ready for college or a career. DEEL will facilitate the City’s support for educational and developmental needs of children from birth to preschool, students in Seattle’s public schools, students in post-secondary programs, and their families, including:

- Administering the City’s early learning services.
- Acting as the liaison and lead collaborator with Seattle Public Schools.
- Acting as the liaison with the City’s higher education institutions.
- Embedding the City’s Race and Social Justice Initiative into the City’s education objectives.
- Administering the Families and Education Levy.

Background:

Last fall, the Council demonstrated its commitment to the education by unanimously approving a budget action requesting the Executive to develop a proposal that would “elevate the Office for Education to a separate Department...” (SLI 41-1-A-1). The Council’s primary motivation was to demonstrate the City’s strong commitment to education by focusing on the following objectives:

- Focus the efforts of the ...department with a specific mission, which is growing/expanding to:
 - Align the various [City] education and early learning programs and initiatives to provide the best learning outcomes for children



- Prepare for implementation of a voluntary, high-quality, universal preschool program for the city's three- and four-year-olds and
- Collaborate more closely with the Seattle School District to boost the academic achievement of students
- Improve direct access to key decision-makers (e.g. Mayor, Council, Superintendent, School Board) (SLI 41-1-A-1).

The current administration has embraced these goals and identified additional objectives for the creation of a unified Department of Education and Early Learning, including:

- Work with the school district to better address issues of shared interest including school safety, transportation, and planning for growth
- Embed the goals and principles of the City's *Race and Social Justice Initiative* into the day-to-day approach to advancing its mission related to education
- Develop a plan for how to address existing disparities in academic outcomes
- Develop and execute strategies for Seattle to become a 21st century model for excellence in public education, beginning with facilitation of an education summit to support an ongoing city-wide discussion of the state of education in our city.
- Enhance strategic partnerships with colleges and universities
- Streamline process for data-driven decision-making and program development

The creation of DEEL will allow for programmatic alignment, streamlined contracting, consistency of expectations and metrics used to evaluate provider performance, and the leveraging of programmatic investments for improved outcomes.

Currently the Office for Education administers the following programs that will be moved to DEEL:

- Early Learning (Preschool for 3- and 4-year-olds and Professional Development and Assessment)
- Elementary, Middle School, and High School programs that provide academic support, help with social/emotional development, extended learning opportunities including summer learning, college and career planning, sports, and transportation
- Health (School-Based Health Centers, Health Support Services (School Nursing), Mental Health Enhancement, Elementary Health, Oral Health)
- Seattle Youth Violence Prevention Initiative
- Read and Rise (funded for 2015 only)

To achieve full integration of the City's education efforts, the following additional programs will be moved from HSD to the new Department of Education and Early Learning:

- Early Childhood Education and Assistance Program
- Comprehensive Child Care Program
- Child Care Assistance Program
- Nurse Family Partnership
- All Families and Education Levy Programs
 - Step Ahead

- Child Care Health Services
- Parent-Child Home Program

DEEL will be the City's one-stop-shop for all matters related to education, birth through college. This will provide greater clarity for community partners and more transparency for city taxpayers who want to know how city resources are being used to help children and families.

The overarching purpose of these changes will be to eradicate educational disparities and ensure that all Seattle children have equitable opportunities for success.
