8 **BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:**


9 Section 1. Payment of the sum of \$11,648,559.67 on Summit mechanical warrants
10 numbered 4002554067 – 4002556827 plus manual or cancellation issues for claims, E-Payables
11 of \$88,027.41 on Summit 9000021734 – 9000021790 and Electronic Financial Transactions
12 (EFT) in the amount of \$14,498,470.21 are presented for ratification by the City Council per
13 Chapter RCW 42.24.180.

14 Section 2. Payment of the sum of \$40,441,964.03 on City General Salary Fund
15 mechanical warrants numbered 51238072– 51238877 plus manual warrants, agencies warrants,
16 and direct deposits numbered 380001 – 392010 representing Gross Payrolls for payroll ending
17 date Sept 8, 2015 as detailed in the Payroll Summary Report for claims against the City which
18 were audited by the Auditing Committee and reported by said committee to the City Council
19 Sept. 17, 2015 consistent with appropriations heretofore made for such purpose from the
20 appropriate Funds, is hereby approved.

21 Section 3. That any act consistent with the authority and prior to the effective date of this
22 ordinance is hereby ratified and confirmed.

1 Section 4. This ordinance shall take effect and be in force 30 days after its approval by
2 the Mayor, but if not approved and returned by the Mayor within ten days after presentation, it
3 shall take effect as provided by Seattle Municipal Code Section 1.04.020.

AN ORDINANCE relating to the Special Events Committee, special events permitting, and special events fees; amending Sections 15.52.005, 15.52.010, 15.52.020, 15.52.030, 15.52.040, 15.52.050, 15.52.060, 15.52.080, and 15.52.090 of the Seattle Municipal Code; and repealing and replacing Section 15.52.070 of the Seattle Municipal Code.

Ordinance 124861

AN ORDINANCE requiring owners of certain low-income housing to notify the Office of Housing and the Seattle Housing Authority of the owner's proposed sale of that housing; establishing penalties; and adding a new Chapter 22.907 to the Seattle Municipal Code.

Ordinance 124862

AN ORDINANCE related to rental housing; and amending Seattle Municipal Code subsection 22.206.160.C to require the owners of rental housing units to provide additional advance written notice to tenants prior to eviction.

Ordinance 124863

AN ORDINANCE relating to City employment commonly referred to as the Second Quarter 2015 Employment Ordinance; establishing new titles and/or salaries; designating positions as exempt from Civil Service status; amending Seattle Municipal Code Section 4.13.010; amending Seattle Municipal Code Section 4.12.080; and

ratifying and confirming certain prior acts; all by a 2/3 vote of the City Council.
