ORDINANCE NO. 10362

AN ORDINANCE providing for the laying off, opening, widening, extending and establishing of First Avenue Scuth, in the City of Seattle, from the north line of Lot Six (6), Section Seventeen (17) and Lot One, (1), Section Eighteen, Township Twenty-four (24) North, Range Four (4), East, W.M., to the north line of Junction Street, as a public street and highway, over and across certain lots, blocks, tracts and parcels of land, and establishing the grade for the overhead bridge of First Avenue South, as provided for in this Ordinance, from a point Seven nundred (700) feet south of Spokane Avenue to the north line of Junction Street, and providing for the taking and damaging of all lands and other property necessary for the laying off, widening, extending and establishing of said First Avenue South, and nece sary for the grading of First Avenue South and the construction of said overhead Bridge and of the approaches thereto, in conformity with such established grades, and for the construction of the nece sary slopes and retaining walls for cuts and fills upon the property abutting upon said street and approaches thereto, and providing for the ascertainment and payment of the just compensation to be made for the property and property rights taken or damaged for said purposes, and for an assessment upon the property benefited for the purpose of makingsuch compensation.

WHEREAS: Public necessity and convenience demand that First Avenue South, in the City of Seattle, be produced South, from the north line of Lot Six (6), Section Seventeen (17), and Lot One (1), Section Highteen (18), Township Twenty-four (24) North, Range Four (4) Hast, W. M., to the north line of Junction Street, as a public street and highway, and

WHIREAS: it is necessary to establish the grade of said First Avenue South for the erection of an overhead bridge thereon, and

WHEREAS: the same will be of special benefit to certain lands and other property situated in the vicinity of the proposed street,

NOW, THEREFORE:

That portion of Block "S", Ladd's Factory Sites, An Addition to

South Seattle, described as follows, to-wit: -Beginning at the south-east corner of said Block "S", and running thence northerly along the east line of said plock "S", a distance of Seventy and ninety-five One-hundredths (70.95) feet; thence south a distance of Fifty-three and Thirteen one-hundredths (53.13) feet to the south line of said Block "S"; thence easterly along said south line a distance of Forty-six and Fifty-seven One-hundredths (46.57) feet to the point of beginning, and containing One Thousand Two Hundred Thirty-seven (1,237) square feet, more or less.

Section 2. That the overhead bridge grades on First Avenue South, from a point Seven Hundred (700) feet south of Spokane Avenue to the north line of Junction Street, be and the same are hereby established at the followingrespective elevations above gity patum, to-wit: --

At a point Seven Hundred (700) feet south of Spokane Avenue, Elevation 9.00 Feet.

Thence on an incline to the north margin of Duwamish Avenue, to an elevation of 35.00 feet. Thence on a level grade, to the south margin of Henrietta Street,

to an elevation of 35.00 feet. Thence on an incline to the north margin of Whatcom Avenue, to

an elevation of 11.00 feet.

Thence to the north margin of Junction Street, to an elevation of 10.00 feet.

Section 3. That all the lands, rights and privileges and other property lying within the limits of the lots, blocks, tracts and parcels of land bounded and described in Section One (1) herein, be and the same are hereby condemned and appropriated to the public use for the purpose of a public street and highway forever, and that all the lands, rights, privileges and other property necessary to be taken, used or damaged by the establishment of the grades of said First Avenue South, as provided for herein, and the grading and regrading of said First Avenue South and First Avenue South produced, and approaches thereto, in conformity with such established grade, and in the construction of overhead bridges and slopes and retaining walls for cuts and fills upon the property abutting upon said street and approaches thereto, are hereby condemned and appropriated to the public use for the purpose of the establishment of such grades and for the construction of the necessary overhead bridges and slopes and retaining walls in the grading of said street and approaches; said lands, rights, privileges and other property to be taken and appropriated only after the just compensation

has been made or paid into court for the owner in the manner provided by law.

Section 4. That the Corporation Counsel be, and he is hereby authorized and directed to file in the Superior Court of the State of Washington, for the county of King, in the name of the City of Seattle, a petition complying with the requirements of the laws of the State of Washington, and praying that the just compensation to be made for the private property to be taken or damaged for the purpose of laying off, opening, widening, extending and establishing First Avenue South, as provided in Section One (1) hereof, and for the property or property rights to be taken or damaged by reason of the fixing of the grades on said street and the grading and regrading of the same, in conformity herewith, and by the construction of overhead bridges and slopes and retaining walls for cuts and fills upon abutting property, as provided in Section Two (2) and Section Three (3) herein, be ascertained by a jury, or by the Court in case a jury be waived.

Section 5. An assessmnt shall be made in the manner provided by the laws of the State of Washington for the purpose of raising the amount necessary to pay the compensation and damages which shall be awarded for the property taken as aforesaid, and for the costs of the proceedings, including the costof making and collecting such assessment, and such assessment shall be made subject to the provisions of said laws upon all property specially benefited.

Any part of the compensation, damages or costs that is not finally assessed against said property benefited shall be paid from the General Fund of the City of Seattle.

For the purpose of said special assessment, a supplementary petit on shall be filed in said Court, and all other acts and proceedings necessary for the making, completion and collection of said Assessment, shall be taken and done asprovided by the laws of the State of washington.

Section 6. This ordinance shall take effect and be in force from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the City Charter.
