ORDINANCE NO. 16363

An Ordinance changing the names of certain streets, avenues, ways and places in that certain portion of the City of Seattle, heretofore lying within the limits of the City of Ballard.

Be it Ordained by the City of Seattle as follows:

Section 1. That the names of certain streets, avenues, ways, and places hereinafter mentioned, now platted or existing in that certain portion of the City of Seattle, heretofore lying within the limits of the City of Ballard, be, and the same are hereby altered, defined and established as follows, to-wit:
