ORDINANCE NO. 16905

AN ORDINANCE granting permission to the Interlaken Land Company to improve Twenty-fifth Avenue North, Twenty-sixth Avenue North and Boyer Avenue, at its own cost and expense.

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the Interlaken Land Company be and it is hereby granted permission to improve Twenty-fifth Avenue North, Twenty-sixth Avenue North and Boyer Avenue, lying and being within the limits of Interlaken, An Addition to the City of Seattle, by grading, curbing and the construction of cement walks and by the construction of water and sewer mains, at its own cost and expense.

Section 2. That all of said work shall be done at the sole cost and expense of said Interlaken Land Co. and shall be under the direction and supervision of the City Engineer and all plans for said work shall be approved by the Board of Public Works. The cost of engineering, supervision and inspection shall be paid into the City Treasury by said Interlaken Land Co. and the said Interlaken Land Co. shall furnish a good and sufficient bond to save and protect the City of Seattle from any costs or damage that may arise by reason of said work.

Section 3. This ordinance shall take effect and be in force from and after its passage and approval, if approved by the Mayor; otherwise it shall take effect at the time it shall become a law under the provisions of the City Charter.
